They are the source of details about the purpose, membership, duties, and other requirements of the body. Included are contact numbers as well as the date, time, and place of regular meetings. Also included is the member's party affiliation when a balance between parties is required by law. In addition, the year in which the member's term ends is also included. The final column indicates the appointing authority or incumbent.

The 2014 edition includes zip codes and population numbers for all ten towns; frequently called numbers that are often hard to find in the phone book; a list of public and non-profit organizations that receive local public funds; city and county district maps; and elections information.
