MINUTES & MEMORANDUM for January 6, 2015

The January 6, 2015, Montgomery County Council meeting was held at 8:00 a.m. in the first floor Council Room of the Courthouse. Councilman Aaron Morgan, Tom Utley, Michael Plant, Richard Chastain, Mark Smith, Don Mills and Mark Davidson were present. Attorney Dan Taylor, Jennifer Andel, Auditor and Commissioners Phil Bane and Terry Hockersmith were also present.

The Call to Order:

Council President Morgan called the meeting to order. This was followed by prayer by Alan Goff, then the Pledge of Allegiance and a welcome to the new council members, Mark Smith, Don Mills and Mark Davidson.

Approval of Minutes:

A motion to approve the December 9, 2014 minutes was made by Councilman Utley and seconded by Councilman Plant. Motion carried 7-0.

Money Matters:

A. Transfers - User Fees

- 1. Sheriff requested \$100 be transferred from OT 1000.0005.410.411.0.0028 to Sheriff Clerk Salary 1000.0005.410.411.0.0014 (for longevity).
- 2. Sheriff requested \$5000 from Drug Investigation Fund 1000.0005.430.415.0.0060 to Sheriff Legal Fees 1000.0005.430.431.0.0010 noting that the \$5000 will not be enough to cover the anticipated expenses. Councilman Plant questioned if this was for the 2015 budget, which it was, then Councilman Utley motioned that it be allowed seconded by Councilman Plant. Motion carried 7-0.
- 3. Sheriff Casteel then requested that he be allowed to spend up to \$5000 from Commissary after the transferred amount was used. Councilman Utley motioned it be allowed, seconded by Councilman Davidson. Motion carried 7-0.
- 4. Sheriff Casteel also requested that he be able to spend up to \$17,000 out of Commissary for INTERACT. Councilman Utley motioned that this be accepted, Councilman Davidson seconded. Motion carried 7-0.
