Ordinance 2018 - 8

An Ordinance Imposing a Temporary Vehicle Weight Limit on Certain County Roads

WHEREAS, the Montgomery County Board of Commissioners is authorized to impose various regulations on the roadways within the county, including limitations on the weight of vehicles travelling upon certain roadways, under both Indiana Code 9-21-1 et seq. and Section 70 of the Montgomery County Code;

AND WHEREAS, the Indiana Department of Transportation has informed the County that certain temporary closures of Interstate 74 in Montgomery County will result in the detour of traffic onto state highways within the County;

AND WHEREAS, the County Highway Director has recommended imposing temporary weight restrictions on the county roads, which are near the areas of the detours, during the interstate closures in order to prevent damage to the County's roadways caused by vehicles seeking alternative routes other than the detour;

AND WHEREAS, for these reasons temporary weight restrictions should be imposed on the county roads identified in the attached Exhibit A, in the vicinities specified, with the exception of deliveries and agricultural vehicles and machinery servicing the farms on these segments of the roads, and these temporary weight restrictions should remain in place from April 1, 2018 to and until August 31, 2018.

NOW, THEREFORE, IT IS ORDAINED by the Montgomery County Board of Commissioners that from April 1, 2018 to and until August 31, 2018 no vehicles weighing more than six (6) tons shall travel upon the County Roads identified on

the attached Exhibit A, with local deliveries and agricultural vehicles and machinery servicing the farms on these segments of the County Road excepted, and the County Highway Director shall cause signs to be placed at appropriate locations to inform the public of this restriction.

IT IS FURTHER ORDAINED that in violations of this Ordinance shall be subject to monetary fines imposed by Section 70(C)(1) of the Montgomery County Code which are in the following amounts:

First violation:	\$100;
Second violation within 12 months:	\$250;
Each subsequent violation within a 12-month period:	\$500.
