# Montgomery County Health Department COVID-19 Vaccination Information

Updated: 3/15/2021

Montgomery County is fortunate to have multiple locations offering COVID-19 vaccination to our citizens. Vaccination availability for COVID-19 is rapidly changing. We want to provide our citizens with the most up to date information on how the vaccine program works as well as how to sign up to be vaccinated when a person becomes eligible. MCHD will update this document as information changes.

COVID-19 vaccine is distributed in one of two ways: (1) from the federal government to state health departments where it is pushed out to county health departments and hospitals, and (2) from the federal government directly to pharmacies. State health departments are charged with determining the eligibility criteria for their citizens. **These criteria apply whether the vaccination is administered by a county health department vaccine clinic, a hospital, or a pharmacy**. We do not want any vaccine to go to waste. All vaccination locations are asked to have "waste lists" containing people who can be called at the end of the location's vaccination day to come in to receive any extra doses for people who did not show up for their appointment. These lists are to be prioritized, in order, based on vaccine <u>eligibility groups</u>:

If you have scheduled an appointment to be vaccinated and then sign up for a different time or location, please cancel your original appointment to open that spot up for someone else.

If you receive a 2-dose vaccine (Pfizer or Moderna), you should receive your second dose at the same location where you received your first dose. Only Indiana residents may receive vaccination at an Indiana vaccination site.

# COVID-19 Vaccination Options in Montgomery County

Montgomery County Health Department Vaccination Site

- Location: 451 East South Boulevard (previous County Market/Save A Lot grocery building). Please note this is NOT the location of the Montgomery County Health Department at 308 W. Market St.
- Appointment required by registering online <u>here</u> (preferred) or by calling 2-1-1. You can choose available vaccination sites using the county list on the right side of the window and clicking on the county name. This site is listed as "Montgomery County HD COVID VAX." The online scheduler works best when using either the Google Chrome or Firefox web browsers. If you call 2-1-1 be sure and tell the scheduler you are being scheduled for a COVID-19 VACCINE at 451 East South Boulevard and NOT for a COVID-19 TEST at 308 W. Market St.

- Location: 1660 Crawfordsville Square Drive.
- Appointments available by registering <u>here</u>.

### Walmart Pharmacy

- Location: 1835 U.S. 231 South
- Appointments are available by scheduling through the <u>Indiana Department of Health</u> <u>scheduling site</u>.

### Walgreens Pharmacy

- Location: 110 W. Market St.
- Walgreens has begun offering vaccine with <u>scheduling via their web site</u>.

### CVS Pharmacy

• CVS is not currently offering vaccine in Crawfordsville. They will likely do scheduling through their <u>corporate website</u>.

### K-12 Teachers and Support Staff

• Will have the option of receiving vaccine administered in their school system by paramedics as part of a joint effort of the Crawfordsville Community Paramedicine program and the Montgomery County Department of Health.
