New Business

Salary Adjustment Request from Clerk's Office

I have recently hired an election coordinator. Based on the salary for this position the comparable hourly rate is about \$18/hr. I would like to start her pay at \$20/hr. If the new pay schedule is adopted, this position is marked to make \$43K+ annually (roughly \$22/hr). The current Election Coordinator Budget has \$5,877.75 remaining. At \$20/hr compensation through end of the year, we would be paying out \$4650, leaving approximately \$1200 still in the fund for this position.

(On a side note, we have 2 other positions, that together, will have around \$40K left in the budget for salaries.)

Resolution 2024-9 Transfer and Reduction of Appropriations

Each year, the Auditor is faced with the need for certain transfers and budget reductions to occur after the December Council meeting and before the end of the calendar year.

Resolution 2024-10 Transferring Cash from County General to Correct Negative Balance Funds

The 2023 Federal Audit identified obsolete grant funds with immaterial negative balances. We are requesting approval to make cash transfers to bring those funds to zero.
