

**ORDINANCE NO. 2016-16**

**AN ORDINANCE OF THE MONTGOMERY COUNTY BOARD OF  
COMMISSIONERS ESTABLISHING THE  
INDIANA DEPARTMENT OF CORRECTIONS COUNTY COMMUNITY  
CORRECTIONS FUND**

WHEREAS, as a result of House Enrolled Act 1006 (2014), the State of Indiana reduced the number of individuals who are in custody or a ward of the Indiana Department of Corrections (IDOC);

AND WHEREAS, Indiana Code §11-12-2-1 provides that IDOC must certify the estimated amount of operational cost savings caused by this reduction, and IDOC may make grants to counties for the establishment and operations of community corrections programs and may transfer funds to the Judicial Conference of Indiana to be used to provide additional financial aid for the court probation services under the program established under Indiana Code §11-13-2;

AND WHEREAS, Montgomery County has received notice that it will receive an allocation from a regional grant to be received by Fountain County from IDOC, and it is necessary to establish a new fund for this allocation;

AND WHEREAS, the Montgomery County Board of Commissioners now finds that a new fund should be established in order to allow the appropriation and use of this allocation.

IT IS, THEREFORE, ORDAINED that a new section should be added to the

Montgomery County Code in order to establish the Indiana Department of Corrections County Community Corrections Fund, and this new section will read as follows:

"Section 35.44 INDIANA DEPARTMENT OF CORRECTIONS COUNTY COMMUNITY CORRECTIONS FUND

(A) *Source of Funds.* There is hereby created a new fund, the Indiana Department of Corrections County Community Corrections Fund. The source of monies in this fund is grants made from the Indiana Department of Corrections to counties for the establishment and operations of community corrections programs and transfers to the Indiana Judicial Conference to be used to provide financial aid for the support of court probation services under the program established under Indiana Code §11-13-2.

(B) *Use of Funds.* Monies deposited into this fund may be used to pay for the salaries, benefits, office supplies, contract services, capital expenses and other operational expenses of the community corrections program and court probations services under the program established under Indiana §11-13-2.


(C) *Non-Reverting Fund.* This is a non-reverting fund. Any money remaining in the fund at the end of the year does not revert to any other fund, but continues in the fund."

IT IS FURTHER ORDAINED that all provisions of Chapter 35 of the Montgomery County Code which are not expressly amended by this ordinance remain in full force and effect.


IT IS FURTHER ORDERED that this Ordinance shall be effective upon its adoption.
