The Montgomery County Commissioners met in regular session on Tuesday, November 12, 2024 at 8:00 am at the Montgomery County Government Center, 1580 Constitution Row – Room E109, Crawfordsville, Indiana.

#### **CALL TO ORDER**

On call of the roll, the members of the Board were shown to be present as follows: Board President John E. Frey; Board Vice President Commissioner Jim Fulwider; and Commissioner Dan Guard.

Also present: County Attorney Dan Taylor; County Administrator Tom Klein; Auditor Mindy Byers; Sheriff Ryan Needham; Building Administrator Marc Bonwell; Highway Director Jake Lough; Central Communications Director Sherri Hill; VA Officer Joe Ellis; Mapping Director Mike Davis; Chief Probation Officer Andria Geigle; EMA Director Jessica Burget; Assistant County Attorney Tyler Nichols and Commissioners Executive Assistant Lori Dossett.

#### **NEW BUSINESS**

#### Thrive West Central MOU for Grant Technical Assistance - \$45,000

The County has been awarded a \$450,000 grant from the Indiana Office of Community and Rural Affairs (OCRA) to establish and implement an Owner-Occupied Rehabilitation Program. MOU will authorize Thrive to assume a critical

role in overseeing every aspect of the program to ensure compliance with OCRA requirements. The County has contracted with Thrive for administration and program implementation.

Commissioner Fulwider moved to approve the Thrive West Central MOU. Seconded by Commissioner Guard. Motion carried 3-0 votes in favor.

#### Award Bid - Thomas K. Milligan Justice Center

Building Administrator Marc Bonwell stated Montgomery County moved the Probation Department to the current location in 2009 after the State Child services vacated the building at 307 Binford Street. Prior to the move the Probation Department—was housed on the third floor of the Courthouse. At the time of the relocation more space was needed for the employees of the Department. At the time of the relocation the interior was remodeled for the Department but the exterior was left existing. The current attributes of the sidewalks and steps needed to be upgraded. The County Commissioners issued a notice to bid for the ADA access improvements of the Thomas K Milligan Justice Center due back on October 28, 2024. One bid was received form JR Kelly Company, 3450 Concord Road, Lafayette, IN 47909. Base bid - \$275,400.00 with Alternate#1 for removal and replacement of Southeast Canopy – \$17,800. Total bid package of \$293,200.00

The engineer estimate for the project was \$216,000.00

After review it is the opinion of the Building Administrator that the bid is comprehensive and the Commissioners should accept the bid including Alternate #1 for the ADA Access improvements for the Thomas K Milligan Justice Center. Commissioner Fulwider questioned who the bid was higher than the engineers estimate. Building Administrator Bonwell stated that since the work area around the Thomas K. Milligan Justice Center is so small, the increased costs are for mobilization. Commissioner Fulwider also questioned when the project would begin. Building Administrator Bonwell stated that the after the contract is approved, the project will start as soon as possible.

Commissioner Guard moved to accept the JR Kelley bid. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.

#### **Open Bids for County Farm Cash Rent**

The County has approximately 24.6 tillable acreage of real estate on the former County Farm. Bid proposals shall be for a stipulated gross rent of not less than \$233.00 per tillable acre. The term of the lease will be for a three-year period beginning March 1, 2025 and ending on February 28, 2028. The lease will be for the 2025, 2026, 2027, crop years. Cash rent will be due and payable under the

terms and conditions of the lease in equal installments on April 15<sup>th</sup> and November 15<sup>th</sup> each year during the term of the lease, except that the first installment will be due at the time of execution of the lease. After preliminary bids are opened, bidders may raise their bids, a raise takes effect after the board has given written notice of that raise to the other bidders. Final bids will be opened by the Board on November 25, 2024 at 8:00 a.m. Attorney Dan Taylor opened one bid received from Wade Bennett for \$235 per/acre. *Commissioner Guard moved to take the bid under advisement. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.* 

#### State of Indiana Deferred Compensation Matching Plan Adoption Agreement

The Commissioners have adopted a Resolution to add a Deferred Compensation Matching Plan to the 401 A plan through Hoosier Start that is administered by Nationwide Retirement Solutions. The Deferred Compensation Adoption Agreement outlines the plan details for the Deferred Compensation Matching Plan. The agreement states that the employer will provide non matching contributions during each payroll for eligible employees. The nonmatching contribution will be 11.2% of the employee's compensation. There will not be a waiting period for eligibility. The only eligible employees for this plan are elected officials not covered by the INPRS defined benefit plan. The plan allows for contributions to account for prior years of service and the plan states that these contributions will consist of equal payments, for the person(s) who need to have it spread over more than one year. The effective date of the plan will be December 1, 2024. *Commissioner Fulwider moved to approve the State of Indiana Deferred Compensation Matching Plan Adoption Agreement. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.* 

#### Affirm the End of the Burn Ban effective November 4, 2024

Commissioners ordered an end of the burn ban effective Monday, November 4, 2024. *Commissioner Guard moved to affirm the end of the Countywide Burn Ban effective November 4, 2024. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.*

#### Assessor: Updated Eagleview & Termination of Contract Eagleview Master Services Agreement

The new contract includes county wide 3" (our old contract was 3" in the city and towns and 6" in rural areas) as well as change finder. Change finder compares our most recent aerial images to the new aerial images and provides me with a list of structures that do not match.

There is an additional cost for these items. I feel that these are mostly beneficial to my office. As such, I am willing to pay the additional \$14,107.94 per year out of my Reassessment budget. The departments that currently pay a portion of the annual bill will pay the same amount as they have been.

Commissioner Guard moved to approve both of the requests for Eagleview. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.





**WHEREAS**, the Montgomery County Board of Commissioners has received a grant from the Indiana Department of Corrections (DOC) for the fiscal year 2025 in the amount of \$164,890.00 to support the operations of the Montgomery County Probation Office: and

**WHEREAS**, the Montgomery County Commissioners desire to create a dedicated fund to receive, allocate, and appropriately manage these grant funds for the period from **January 1**, **2025**, **to December 31**, **2025**; and

**WHEREAS**, the Montgomery County Commissioners intend to establish a dedicated fund to receive and manage the 2025 DOC Probation Grant Fund and allocate these funds for specific purposes as outlined in the grant agreement;

**THEREFORE, BE IT ORDAINED** by the Montgomery County Board of Commissioners that a new section, Section 35 \_\_\_ of the Montgomery County Code, is hereby added to the County Code and that this new section shall read as follows:

#### 35.\_\_\_ 2025 DOC Probation Grant Fund

- (A) Source of Funds. The Montgomery County Board of Commissioners hereby establishes the 2025 DOC Probation Grant Fund. The fund is hereby created to receive, allocate, and manage the 164,890.00 grant funds.
- (B) Use of Funds.
  - 1. Salary for Brock Young: \$69,321.00
    - o This amount shall be used to cover the salary of Brock Young, an employee of the Montgomery County Probation Office.
  - 2. Salary for Patrick Gilliland: \$63,473.00
    - This amount shall be used to cover the salary of Patrick Gilliland, an employee of the Montgomery County Probation Office.
  - 3. FICA (Federal Insurance Contributions Act): \$10,158.00
    - o This amount shall be allocated for FICA payments for the employees:
      - \$5,303.00 for Brock Young
      - \$4.855.00 for Patrick Gilliland

- 4. INPRS (Indiana Public Retirement System): \$14,871.00
  - This amount shall be allocated to INPRS for contributions to the Indiana Public Retirement System:
    - \$7,763.00 for Brock Young
    - \$7,108.00 for Patrick Gilliland
- 5. Group Insurance: \$867.00
  - o This amount shall be used for Group Insurance premiums:
    - \$434.00 for Brock Young
    - \$433.00 for Patrick Gilliland
- 6. Gas/Fuel: \$1,500.00
  - o This amount shall be used to cover gas and fuel expenses for the Probation Office vehicles used in field supervision and travel.
- 7. Travel and Training: \$3,500.00
  - This amount shall be allocated for travel and training expenses, including conferences, workshops, and seminars for Probation Office staff.
- 8. Cell Phone Reimbursement: \$1,200.00
  - This amount shall be used for the reimbursement of cell phone expenses for Probation Office staff, as needed for work-related communication.
- (C) Non-Reverting Fund This is a Non-Reverting Fund.
