The Montgomery County Commissioners met in regular session on Monday, March 10, 2025 at 8:00 am at the Montgomery County Government Center, 1580 Constitution Row – Room E109, Crawfordsville, Indiana.

CALL TO ORDER

Acknowledge Receipt of 2024 Annual Financial Report –

Every municipality and local government is required to provide electronically and in a manner prescribed by the state examiner, financial reports for the fiscal year not later than sixty days after the close of the fiscal year. The Annual Financial Report (AFR) is prepared by the County Auditor.

Commissioner Bohlander moved to approve the Consent Agenda. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.

NEW BUSINESS

Request for Lane Closure on Nucor Road for Watermain Project –

Commissioner Bohlander moved to approve the Request for Lane Closure on Nucor Road for Watermain Project. Seconded by Commissioner Fulwider.

Scott Minnick from Nucor Steel stated that they have had a lot of issues with Gradex and he is concerned and has questions on where the road closure will be and for how long.

Dustin Baldwin from Gradex stated they are proposing for the lane closure to be north of the main gate for 1.4 miles for approximately one month. The lane closure will end at CR300. The automated signals have a camera and sensors and will adjust with the changes in traffic flow throughout the days and nights.

Commissioner Fulwider questioned if there is a point of contact for both Nucor and Gradex. Scott Minnick will be Nucor's point of contact and Gradex will supply contact information for their Traffic manager as well.

Ryan Pattenau from Lochmueller stated that he did some research on the DATS proposed automated signals and found that the system is very reliable and will adjust with the traffic flow.

Jake Lough from Montgomery County Highway Department stated that the automated signals take the possibility of human error out of the equation. He stated a concern of the impact on the roads with loaded trucks sitting for longer periods of times and what kind of long term damage it could cause.

Commissioner Fulwider questioned if the automated signals detect if an emergency vehicle is coming through. They did not know the answer but will check.

Scott Minnick from Nucor stated that he can supply a Nucor radio to Gradex which will alert them of any incidents going on at the plant.

Hearing no further discussion, motion carried 3-0 votes in favor.

2nd Reading Ordinance 2025-6 Creating the 2025 OCRA Owner-Occupied Rehabilitation Program Fund - \$450,000

Montgomery County has been approved by the Indiana Office of Community and Rural Affairs (OCRA), to receive a Community Development Block Grant (CDBG) Funds in the amount of \$450,000 to establish and implement a County-wide Owner-Occupied Rehabilitation Program. The fund is created in order to receive the funds from the Office of Community and Rural Affairs (OCRA) and to provide a mechanism for appropriation and accounting for the funds used.

Commissioner Fulwider moved to approve Ordinance 2025-6. Seconded by Commissioner Bohlander. Motion carried 3-0 votes in favor.



**Agreement between the Montgomery County Free Clinic and the
Montgomery County Department of Health Regarding Support of Women's Health Clinic**

This Agreement is between the Montgomery County Free Clinic ("MCFC") and the Montgomery County Health Department ("MCHD").

Background and Purpose

- The Montgomery County Health Department and Montgomery County Free Clinic have a shared mission to improve the health of underserved residents of Montgomery County.
- Montgomery County Free Clinic provides primary care services to uninsured residents.
- The Montgomery County Health Department may use Health First Indiana funds to help support community partners working to address public health gaps and opportunities for improvement.
- Montgomery County has limited access to contraceptive and prenatal care.
- Montgomery County has a high teen birth rate of 18.3 compared to the state average of 16.9.
- Montgomery County has a high rate of smoking. 20% of adults smoke compared to Indiana at 18% and the United States at 15%.
- The smoking rate during pregnancy for Montgomery County is 15.7% compared to Indiana's average of 6.6% placing Montgomery County at 68th of the 92 Indiana counties. This may contribute in part to 12.9% of births being preterm and 9.8 % of births being low birth weight; both measures above state averages.
- Montgomery County has a high rate of obesity, 48.7%, which ranks us 83rd among Indiana counties.
- Montgomery County has limited access for uninsured women to receive recommended health screenings, including STI screening.
- The purpose of this Agreement is to establish a partnership and understanding between the Montgomery County Free Clinic and the Montgomery County Department of Health for the provision of a Women's Health Clinic to improve access to care for underserved women, including improved access to contraception, immunization, smoking cessation, nutrition and diet education, STI screens and other health-related screening.

The parties now, therefore, acknowledge their understanding of the following terms and conditions:

1. **Term; Cancellation.** The term of this Agreement shall be one year from the date of execution. This Agreement may be terminated with or without cause by either party giving the other party 10 days prior written notice of termination. MCHD will pay MCFC for all one-half days up to termination.
2. **Hours and Dates.** MCFC will establish a weekly one-half day Women's Health Clinic at a mutually agreed upon recurrent day and time at 816 Mill Street, Crawfordsville, Indiana, 47933.


3. **Duties.** MCFC will be responsible for scheduling and providing women's primary care services. MCHD will provide a nurse to assist the clinic with the following:
 - a. Rooming;
 - b. Provision and administration of immunizations;
 - c. Performance of rapid point-of-care screening for HIV Hepatitis C, and Syphilis for eligible patients;
 - d. Submission for GC and Chlamydia screening specimens to the Indiana Department of Health for eligible patients;
 - e. Provision of smoking cessation information and counseling;
 - f. Provision for diet and nutrition information and counseling.
4. **Personnel.** MCFC will provide a licensed provider (physician, physician assistant, or nurse practitioner). MCHD will provide a licensed registered nurse or certified medical assistant. Parties agree MCFC's licensed provider is not an employee of MCHD and has no right to any benefit or claim as an employee of MCHD. And likewise, that MCHD's licensed provider is not an employee of MCFC, but will work under the supervision of MCFC's licensed provider.
5. **Financial Support.** MCHD will grant MCFC \$525.00 for each one-half day clinic up to a maximum of \$25,000.00 for 2025. MCFC will provide an invoice statement quarterly to MCHD, which will be paid by MCHD within a reasonable time, subject to appropriated funding.
6. **Indemnification.** MCFC promises to indemnify and defend MCHD for any loss, injury, or damage resulting from MCFC's provision of services, including MCHD's reasonable attorney's fees.
7. **Breach:** In any dispute regarding the terms of this Agreement, the non-prevailing party will pay the prevailing party's costs and reasonable attorney's fees.
8. **Notices:** Any notice to be given in writing shall be deemed given or made when delivered by hand or by regular U.S. mail as follows:

All proposals will then be publicly opened and read aloud during the County Commissioner's meeting, which begins on March 24th at 8:00 A.M. (local time). Any proposals received after the above-designated time will be returned unopened.

The proposed construction will include type 3p single chip seal and microsurface for cape seal, and all incidental work required, as more fully specified in the Contract Documents and Plans.

All proposals must be submitted on State Board of Accounts Form No. 96 together with the proper forms included in the Contract Documents, the entire set of which shall be filed intact as a bid. The bid envelope must be sealed and have the words "**MONTGOMERY COUNTY 2025-1 CCMG Project**" legibly written on the front. **Bidders must be INDOT pre-qualified per Indiana Code (IC) 5-16-13-10.**

**AN ORDINANCE CREATING THE
2024-2025 MONTGOMERY COUNTY HEALTH DEPARTMENT
IMMUNIZATION GRANT FUND**

Whereas, the Montgomery County Health Department has received a grant from the Indiana Department of Health to receive an Immunization Grant in the amount of \$27,014.78 to implement a Local Health Department Immunization Program; and

Whereas, the use of funds from the grant award may be used by the Montgomery County Health Department consistent with the terms and conditions of the Indiana Department of Health – Immunization Division Grant; and

Whereas, the Montgomery County Board of Commissioners finds that a new fund, the 2024-2025 Montgomery County Health Department Immunization Grant Fund should be created in order to receive the funds from the Indiana Department of Health and to provide a mechanism for appropriation and accounting for the funds used.

Therefore, it is ordained that a new section, Section 35.____ of the Montgomery County Code, is hereby added to the County Code and that this new section shall read as follows:

**"§ 35.____ 2024-2025 MONTGOMERY COUNTY HEALTH DEPARTMENT
IMMUNIZATION GRANT FUND**

(A) *Source of Funds.* The Montgomery County Board of Commissioners hereby establishes the 2024-2025 Montgomery County Health Department Immunization Grant Fund. The fund shall consist of monies received by the Indiana Department of Health for expenses related to the implementation of a Local Health Department Immunization Program.

(B) *Use of Funds.* All money of the will be used consistent with the grant award to provide specifically for expenses related to the Immunization Program: \$1,000-travel; \$2,471.62-supplies; \$23,543.16-equipment in a form and manner consistent with the grant award.

(C) *Non-Reverting Fund.* This is a Non-Reverting Fund."

It is further ordained that this ordinance shall be effective upon adoption.

It is further ordained that all other provisions of the Montgomery County Code of Ordinances which are not specifically amended by this ordinance shall remain in full force and effect.

Whereas, the Montgomery County Health Department has received a grant from the Indiana Department of Environmental Management to receive a Waste Tire Grant in the amount of \$10,000 for one or more Waste Tire Amnesty Events to reduce the amount of waste tires in Montgomery County; and

Whereas, the use of funds from the grant award may be used by the Montgomery County Health Department consistent with the terms and conditions of the Indiana Department of Environmental Management; and

Whereas, the Montgomery County Board of Commissioners finds that a new fund, the 2025 Montgomery County Health Department Waste Tire Grant Fund should be created in order to receive the funds from the Indiana Department of Environmental Management and to provide a mechanism for appropriation and accounting for the funds used.

Therefore, it is ordained that a new section, Section 35.____ of the Montgomery County Code, is hereby added to the County Code and that this new section shall read as follows:

"§ 35. ____ 2025 MONTGOMERY COUNTY HEALTH DEPARTMENT WASTE TIRE

GRANT FUND

(A) Source of Funds. The Montgomery County Board of Commissioners hereby establishes the 2025 Montgomery County Health Department Waste Tire Grant Fund. The fund shall consist of monies received by the Indiana Department of Environmental Management for expenses related towards one or more waste tire events.

(B) Use of Funds. All money of the will be used consistent with the grant award to provide specifically for expenses related to the Immunization Program: \$10,000 for clean-up events including an advertisement budget of no more than \$500 in a form and manner consistent with the grant award.

(C) Non-Reverting Fund. This is a Non-Reverting Fund."

It is further ordained that this ordinance shall be effective upon adoption.

It is further ordained that all other provisions of the Montgomery County Code of Ordinances which are not specifically amended by this ordinance shall remain in full force and effect.
