Approving 2nd Assistant Chief Deputy for Probation Department

Mark Bickel's last day as Assistant Chief (AC) will be October 3, followed by his payout of PTO. They are seeking authorization to have a second AC (in training), Lindsey Villalpando, until Mark's retirement. While in training, Lindsey has been given additional tasks so they are requesting to pay her more. The Judges approved this request. It doesn't meet the requirements for a new classification of position and therefore doesn't need to go to the compensation consultant. Historically, the new pay doesn't start until they officially take the position.
