Cargill's investment at our Linden facility will be a multi-phased project to create a regional office hub, new receiving pit and staging area, and new covered conveyors at the facility. The \$17.5M investment will support an increase in our capacity by 10M bushels per year. This growth will drive local market demand and improve overall productivity at the facility. Investments: Phase 1 \$2.3M Real Property (RP), Phase 2 \$9.05M RP & \$4.7M Personal Property (PP), Phase 3 \$250K RP & \$1.2M PP.
