#### **ORDINANCE 2013-3**

## AN ORDINANCE AMENDING THE WEIGHT LIMIT ON COUNTY ROADS

WHEREAS, in order to prevent the deterioration of the roads caused by trucks carrying loads in excess of the road design, Schedule I of Chapter 70 prohibits vehicles with a gross weight of over eight tons on all county roads except those specifically identified;

AND WHEREAS, the Board of Commissioners of Montgomery County has investigated and determined that vehicles exceeding eight tons should be permitted on County Road 400 South from its intersection with Nucor Road extending a distance of one-half mile to the east;

AND WHEREAS, the Board of Commissioners of Montgomery County wishes to amend Schedule I to provide for such changed weight limit.

NOW, THEREFORE, BE IT ORDAINED, by the Montgomery County Board of Commissioners that the schedule of roads on which vehicles over eight tons are permitted be amended to include County Road 400 South as described herein, as set forth in the following table:

Weight Limits Over Eight Tons
Ladoga – Crawfordsville Road
Old State Highway 55 from Crawfordsville to Wingate
1100 North, from New Richmond to Indiana Highway 25
Russellville Road from Russellville to Indiana Highway 47
Nucor Road from 500 South to State Road 32
1000 North from Linden to New Richmond
600 South from State Road 47 to U.S. 231
Ladoga – Roachdale Road (550E)
400 South from Nucor Road to ½ mile east of Nucor Road

BE IT FURTHER ORDAINED that Schedule I of Chapter 70 of the Montgomery County Code of Ordinances be repealed and replaced in its entirety by a new Schedule I in the form attached to this Ordinance as Exhibit A, which incorporates the foregoing change.

BE IT FURTHER ORDAINED that the County Highway Department is directed to post signage compliant with the Indiana Manual on Uniform Traffic Devices providing notice of the weight restrictions and shall notify the Sheriff's Department of the this change.

## Title VII: Traffic Code

# **CHAPTER 70: TRAFFIC SCHEDULE**

## SCHEDULE I. WEIGHT LIMITS.

- (A) This schedule is authorized pursuant to the provisions of <u>I.C. 9-21-1-3</u> and <u>I.C. 9-20-1-3</u> and for the reason that the highways under control of the Board of Commissioners, by reason of deterioration, rain, snow or other climatic conditions, will be seriously damaged or destroyed unless the use of vehicles is prohibited or permissible weight of vehicle is reduced.
- (B) No vehicle with a gross weight of over eight tons shall be allowed on any road contained in the county highway system, excepting the following.

Weight Limits Over Eight Tons
Ladoga – Crawfordsville Road
Old State Highway 55 from Crawfordsville to Wingate
1100 North, from New Richmond to Indiana Highway 25
Russellville Road from Russellville to Indiana Highway 47
Nucor Road from 500 South to State Road 32
1000 North from Linden to New Richmond
600 South from State Road 47 to U.S. 231
Ladoga – Roachdale Road (550E)
400 South from Nucor Road to ½ mile east of Nucor Road
