

ORDINANCE NO. 2013-7

**AN ORDINANCE OF THE MONTGOMERY COUNTY BOARD OF COMMISSIONERS
AMENDING THE STOP AND SPEED ORDINANCE FOR COUNTY ROADS**

WHEREAS, Schedule III and Schedule IV of Chapter 70 of the Montgomery County Code of Ordinances, respectively, sets forth the speed limits on and the locations of the stop intersections on county roads; and

WHEREAS, The County Highway Superintendent has recommended that, because of traffic problems at this intersection, the traffic on County Road 150 South and County Road 200 West both stop at this intersection which would become a 4-way stop; and

WHEREAS, the Montgomery County Board of Commissioners finds that it is in the best interests of the public safety and welfare that a 4-way stop be designated at the intersection of County Road 150 South and County Road 200 West; and

WHEREAS, the County Highway Superintendent should take all steps to place the appropriate stop signs and markings at this intersection in order to carry out the intent of this ordinance; and,

IT IS THEREFORE ORDAINED that the County Stop and Speed Ordinance is hereby amended in order to provide that the traffic traveling from the east and west on County Road 150 South and from the north and south on County Road 200 West will stop at the intersection of these two County Roads and that Schedule III of Chapter 70 of the Montgomery County Code of Ordinances is hereby amended in order to reflect this amended traffic control, as follows:

County Road 150 South	East	County Road 200 West

County Road 200 West	North	County Road 150 South
County Road 200 West	South	County Road 150 South

BE IT FURTHER ORDAINED that Schedule III of Chapter 70 of the Montgomery County Code of Ordinances be amended in order to reflect the changes made by this Ordinance.

IT IS FURTHER ORDAINED that the County Highway Department is directed to post signs in compliance with the Indiana Manual on Uniform Traffic Devices for the new stop at the intersection of County Road 150 South and Country Road 200 West.

IT IS FURTHER ORDAINED that the Sheriff's Department shall be notified by the County Highway Director of this change in the stop ordinance and of the installation of related regulatory signs.

IT IS FURTHER ORDAINED that all provisions of Chapter 70 of the Montgomery County Code which are not expressly amended by this ordinance, including but not limited to all other stop intersections listed in Schedule III shall remain in full force and effect.


IT IS FURTHER ORDAINED that this Ordinance shall be effective on October 1, 2013.


