Ordinance 2018-29

An Ordinance Establishing the 2018 Health Department MCCF Drug Free Montgomery County Grant Fund

Whereas, the Montgomery County Health Department applied for a grant from the Montgomery County Community Foundation to assist in the creation of a website for Drug Free Montgomery County; and

Whereas, on August 21, 2018, the Montgomery County Community Foundation notified the Montgomery County Health Department that the Foundation had awarded a grant in the amount of \$6,610.00 as requested; and

Whereas, there is a need to create a fund for the deposit of these grant funds, and the Commissioners find that a new fund, the 2018 Health Department MCCF Drug Free Montgomery County Grant Fund, should be created in order to receive these grant funds; and

Whereas, the grant is conditioned upon the County's fulfillment of the duties, obligations, and requirements detailed in the Grant Agreement. This Agreement is attached as Exhibit A; and

Whereas, the Board of Commissioners has reviewed these terms and believes it is in the best interest of Montgomery County and its citizens to perform these duties and participate in this grant; and

Therefore, it is ordained that a new section, Section 35.121, is hereby added to the Montgomery County Code of Ordinances establishing the 2018 Health Department MCCF Drug Free Montgomery County Grant Fund, and this section shall read as follows:

“§ 35.121 2018 HEALTH DEPARTMENT MCCF DRUG FREE MONTGOMERY COUNTY GRANT FUND

- (A) *Source of Funds.* The Montgomery County Board of Commissioners hereby establishes the 2018 Health Department MCCF Drug Free Montgomery County Grant Fund. The fund shall consist of grant monies received by the Montgomery County Health Department from the Montgomery County Community Foundation pursuant to a grant award letter, dated August 21, 2018, and agreement.
- (B) *Use of Funds.* All money of the 2018 Health Department MCCF Drug Free Montgomery County Grant Fund will be used, without appropriation, solely to implement the “Project” and/or to provide the services in conformance with the “Grant Agreement” entered into by and between the Montgomery County Community Foundation and the Montgomery County Health Department. Specifically, the funds will be used to provide a website for Drug Free Montgomery County. Any unexpended funds must be returned to the Montgomery County Community Foundation.
- (C) *Non-Reverting Fund.* This is a Non-Reverting Fund.”


It is further ordained that this ordinance shall be effective upon adoption.

It is further ordained that all other provisions of the Montgomery County Code of Ordinances which are not specifically amended by this ordinance shall remain in full force and effect.


It is further ordained that the Montgomery County Health Department shall have the authority to implement the duties and obligations detailed in the Grant Agreement.
