Ordinance 2018-28

An Ordinance Establishing the 2018 Emergency Management Performance Grant Fund

Whereas, the Montgomery County Emergency Management Department applied for an Emergency Management Performance Grant from the Indiana Department of Homeland Security to assist the operation of the Coroner; and

Whereas, on October 1, 2018, the Indiana Department of Homeland Security notified the Montgomery County Emergency Management Department that it was awarded the grant in the amount of \$9,369.10; and

Whereas, the funds from this grant will be used to purchase and provide cadaver racks, a hydraulic scissor lift, a 17.5 KW generator, a flammable storage cabinet, shipping costs for these items and other equipment for the Montgomery County Coroner; and

Whereas, any unexpended funds from this grant as of November 14, 2019 will be returned to the Indiana Department of Homeland Security; and

Whereas, there is a need to create a fund for the deposit of these grant funds, and the Commissioners find that a new fund, the 2018 Emergency

Management Performance Grant Fund, should be created in order to receive these grant funds; and

Whereas, the grant is conditioned upon the County's fulfillment of the duties, obligations, and requirements detailed in the Grant Agreement. This Agreement is attached as Exhibit A; and

Whereas, the Board of Commissioners have reviewed these terms and believe it is in the best interest of Montgomery County and its citizens to perform these duties and participate in this grant; and

Therefore, it is ordained that a new section, Section 35.120, is hereby added to the Montgomery County Code of Ordinances establishing the 2018 Emergency Management Performance Grant Fund, and this section shall read as follows:

"§ 35.120 2018 EMERGENCY MANAGEMENT PERFORMANCE GRANT FUND

- (A) *Source of Funds.* The Montgomery County Board of Commissioners hereby establishes the 2018 Emergency Management Performance Grant Fund. The funds shall consist of grant monies received by the Montgomery County Emergency Management Department from the Indiana Department of Homeland Security pursuant to a grant award letter, dated October 1, 2018, and agreement.
- (B) *Use of Funds.* All money of the 2018 Emergency Management Performance Grant Fund will be used, without appropriation, solely to implement the "Project" and/or to provide the services in conformance with the "Grant Agreement" entered into by and between the Indiana Department of Homeland Security and the Montgomery County Emergency Management Department. Specifically, the funds will be used to provide equipment for the Montgomery County Coroner in a manner consistent with the grant award. Any unexpended funds as of November 14, 2019 must be returned to the Indiana Department of Homeland Security.

(C) *Non-Reverting Fund*. This is a Non-Reverting Fund.”


It is further ordained that this ordinance shall be effective upon adoption.


It is further ordained that all other provisions of the Montgomery County Code of Ordinances which are not specifically amended by this ordinance shall remain in full force and effect.

It is further ordained that the Montgomery County Emergency Management Department shall have the authority to implement the duties and obligations detailed in the Grant Agreement.
