Commissioner Frey moved to approve the change order as requested. Seconded by Commissioner Guard. Motion passed 3-0.

County Engineer James Peck requested a change order for CR100W from CR400N south to .6 miles to the beginning of the Bridge #79 replacement in an amount not to exceed \$75,953.50.

Commissioner Frey moved to suspend the rules to add change a change order for CR100W from CR400N south to .6 miles to the beginning of the Bridge #79 replacement. Seconded by Commissioner Guard. Motion passed 3-0. After discussion, Commissioner Fulwider moved to approve the request. Seconded by Commissioner Guard. 2 votes in favor (Fulwider & Guard). 1 vote against (Frey).

VII. Adjourment:

There being no further business before the Board, Commissioner Frey moved to adjourn. Commissioner Fulwider seconded. Motion passed 3-0.
