#### FINAL READING

Ordinance 2020-32 – Approving Text Amendments to Chapter 152 Subdivisions

Approved. Ordinance makes changes to the Subdivision Control Ordinance that were necessary as a result of the adoption of the Zoning Ordinance.

Ordinance 2020-33 – Rezoning Land from Agricultural to Residential (Case 2020-3) Petitioner Ratcliff, Inc.

Rejected.

Ordinance 2020-30 – CR400S Speed Limit Ordinance

Approved. Reduces speed limit to 40 mph on CR 400 S between 47 and 231.

Ordinance 2020-31 - Creation of Solid Waste District

Approved. Ordinance designates Montgomery County as a Solid Waste Management District, effective January 1, 2021 and creates a Board of Directors and other provisions for the operation of the District.

Ordinance 2020-34 - Creating Community Testing Grant - \$100,000

Introduced. Ordinance establishes a new fund to receive grant funds for community testing related to the 2019 COVID pandemic.

Ordinance 2020-35 - Creating CARES Act Public Health IT Funding - \$107,445.77

Introduced. Ordinance establishes a new fund to receive grant funds for public health information technology needs related to the 2019 COVID pandemic.
