#### **NEW BUSINESS**

## **Holladay Properties Agreement**

Commissioner Frey stated that the Commissioners and the Redevelopment Commission have worked to develop a marketing and development agreement with Holladay Properties to attract new businesses to Montgomery County. The Commissioners approved the marketing portion of the agreement at a previous meeting. If the Commissioners approve the development agreement it will be forwarded to the Redevelopment Commissioner for final approval. Commissioner Fulwider moved to approve the Holladay Properties Agreement. Seconded by Commissioner Guard. Motion passed 3-0.

## **Envoy County Annex Project Demolition Amendment**

County Administrator Tom Klein stated that Envoy is requesting approval of an amendment to their agreement for the new Courthouse Annex to allow the demolition of certain structures to proceed. The estimated cost is \$63,000 and they are requesting an amendment in the amount of \$100,000 to allow for other trades that may commence work prior to the final agreement for the project and the agreement also incorporates the fee paid to the Bond Council for work related to the BOT. Commissioner Fulwider moved to approve the County Annex Project Demolition Amendment. Seconded by Commissioner Guard. Motion passed 3-0.

Final Reading: Ordinance 2021-12: Amending the County's Policies to Require Criminal Background Checks Commissioner Guard moved to approve Ordinance 2021-12 as presented. Seconded by Commissioner Fulwider. Motion passed 3-0.

Final Reading: Ordinance 2021-13: Amending the County's Policies to Include HIPAA Policy, Amending Section 4.09 of the Employee Handbook and Approving HIPAA Plan

Commissioner Fulwider moved to approve Ordinance 2021-13 as presented. Seconded by Commissioner Guard. Motion passed 3-0.

Introduction: Ordinance 2021-14: Amending the County's Right-of-Way Policies

Ordinance establishes a permit requirement and policies for construction work in the County's right-of-way.

## SPECIAL PRESENTATION

## Wayfinding & Gateway Signage - Crawfordsville Main Street - Sue Lucas

Sue Lucas described the Wayfinding & Gateway Signage project as a tool to assist visitors to Montgomery County as well as local residents to help discover new places of interest to visit in Montgomery County. The estimated total cost of the project is \$300,000. Main Street is applying for a grant from the Montgomery County Community Foundation and are requesting the County to contribute \$41,500 to the project. The City has pledged \$92,000 to the project and Main Street has a pending \$10,000 grant application pending. Commissioner Guard moved to show support for the \$41,500 contribution request and will carry that request to the County Council to request an additional appropriation. Seconded by Commissioner Fulwider. Motion passed 3-0.

#### **OTHER BUSINESS**

County Administrator Tom Klein stated in March three County employees are celebrating milestones: Vanessa Bowling – 5 years; Lena Custer – 10 years; Seth Steelsmith – 15 years.

Commissioner Frey requested official support from the Commissioners to submit an application for membership to West Central Regional Economic Development District. *Commissioner Frey moved to submit an application for membership to the West Central Regional Economic Development District. Seconded by Commissioner Guard. Motion passed 3-0.*

There being no further business before the Board, Commissioner Fulwider moved to adjourn. Commissioner Guard seconded. Motion passed 3-0.
