MONTGOMERY COUNTY TAX SALE

DELINQUENT PROPERTY TAX SALE NETS \$491,291 FROM 113 PROPERTIES PAID PRIOR TO THE SALE AND SOLD AT THE SALE

CRAWFORDSVILLE, INDIANA - 9/29/2021

Montgomery County Officials held their annual delinquent property tax sale on September 29, 2021. The sale was conducted by County Auditor Jennifer Andel and County Treasurer Heather R. Laffoon. A property tax sale is required to be held in each Indiana county for those properties where an owner of real estate fails to pay the property taxes from the prior year's first property tax bill installment. A tax lien on the property may be sold to satisfy the tax obligation to the highest bidder. The owners of the properties sold at the tax sale have one year to pay the delinquent property taxes, costs and penalties to keep the property. The sale, conducted by Indianapolis-based SRI Incorporated on behalf of Montgomery County, offered 18 parcels to 17 bidders. SRI conducts tax sales in over 100 counties in Indiana, Michigan, Colorado, Louisiana and Iowa.

This year's tax sale resulted in the collection of \$491,290.72 from owners and buyers. 113 parcels had all taxes, penalties, and costs paid in full. Treasurer Heather R. Laffoon said, "Tax sales are a necessary function of county government. It is only fair to the people who pay their property taxes every year to pursue those that do not pay."

For the 4 properties that did not sell, the county commissioners acquire a tax lien. The county commissioners may offer those properties to the public at a sale at a later date. County Auditor Jennifer Andel commented, "It is our ultimate goal to return these properties to the tax rolls as quickly and efficiently as possible. Property owned by people that pay their property taxes ensure our local government services are fully funded."
