

Montgomery County 2021 Annual Report



December 21, 2021 was the County's 199th Birthday. We celebrated it by ringing the Liberty Bell at the Courthouse.



Tempur Sealy will build its largest manufacturing facility in the world in Montgomery County. The County provided funding to extend water and sewer lines to the site and to improve roads.



Through an agreement with the County, Indiana American Water Company extended water lines to Nucor Road.



The County Commissioners adopted an action plan for funds from the American Rescue Plan Act.

Mary Herr was the first resident to receive a Covid-19 vaccination shot. The Health Department gave 21,716 vaccination shots.



The Highway Department replaced the 30 year old paving machine.



The Highway Department built a new salt barn that increased material storage capacity for snow fights.



The Engineering Department built a new bridge on 100 West and reconstructed two other bridges.



The Montgomery County Solid Waste District held its first tox away day at North Montgomery High School. 33 tons of material were collected.



The Sheriff's Office responded to 15,960 calls for service.




The Central Communications Center
answered 71,812 calls and 1,872 texts.
17,899 of them were 911 calls.



The Emergency Management Agency obtained \$496,000 in grants including \$334,000 for an armored vehicle for the SWAT team.



Joe Ellis, the Veteran Services Officer, answered 495 calls and had 188 office visits.



Jim Wolf, the Weights and Measures Inspector, inspected 1,061 weight scales and gas pumps.



Progress was made on construction of the new County Government Center at 1580 Constitution Row.



Employee lunches were held at the Courthouse Plaza. We have 218 full time employees.


Auditor's Office

- ▶ Accounts Payable distributed over \$101million via 3,432 checks and 1,040 direct deposit - a 49% increase in the number of payments made via Direct Deposit, saving the county thousands of dollars on materials and postage.
- ▶ Payroll paid \$10,175,791 to 302 different employees. Our deputy also processed the intake documents and verifications for 53 new employees as well as 50 terminations. She maintained the retirement funding as well as Health, Dental, Vision and supplemental insurance data for 264 different employees over the course of the year.
- ▶ Our Property Deputies processed 5,215 parcel transfers, splits and combines to maintain the county plat records, they also maintained 5,440 property tax deductions - adding, correcting or removing them as needed. There are 26,000 parcels in the county, so action was taken on over 20% of them.
- ▶ Accounts Receivable processed over 3,800 quietuses for over \$155million in inter- and intra- fund receipts.

Auditor's Office

- ▶ We sold all but 4 of the properties eligible for tax sale - a new county record.
- ▶ We calculated over \$54 million in Real Estate and Personal Property Abatements approved by City and County Councils.
- ▶ We distributed over \$45 million in property and excise taxes and special assessments to our local schools, city and towns, townships and libraries.
- ▶ We processed 1,010 budget adjustments as requested by Departments and approved by Council.
- ▶ We worked with the Assessor and Recorder teams to add the electronic deed and document processing option for customers.
- ▶ We enhanced our absence tracking capabilities in LOW software for better reporting.
- ▶ We integrated Controller activities, maintained State compliance and completed annual financial reports for two additional units: Montgomery County Redevelopment Authority and Montgomery County Solid Waste Management District.

Assessor's Office

- ▶ The Montgomery County Assessor's Office is finalizing the 2021 Reassessment cycle and beginning the next four-year cycle. In addition, we are now accepting 2022 Business Personal Property forms, which are due by, May 16, 2022.
- ▶ Our office has also begun finalizing assessed values for 2022 pay 2023. Each taxpayer will receive a Form 11, Notice of Assessment of Land and Structures/Improvements, later this spring. This Notice commences the time frame to appeal that proposed value. Please note that the deadline to file an appeal is June 15, 2022.

Building Department

- ▶ 67 housing starts with 45 completed
- ▶ 724 inspections
- ▶ 14,104 miles traveled to conduct inspections

Central Communications Center

- ▶ Completed Operations Study for Agency Structure & Governance, Personnel & Employee Retention, Operations Assessment, Quality Assurance, Technical Assessment and Facility Assessment.
- ▶ Upgraded the classification of employees to Public Safety.
- ▶ Installed a new UPS System received a new CAD Upgrade.
- ▶ Worked closely with the Mapping Director to insure that the 911 addresses/MSAG are up to date.
- ▶ Staffing remained consistent with 95% retention up until August. Between late July and the end of August, the Center lost 5 employees to various career decisions by those past employees.
- ▶ Received 71,812 phone calls for services with 17,899 of those being 911 calls. Received 1,872 text messages for assistance.

Child Support Enforcement Program (Prosecutor's Office IV-D)

- ▶ We have held the Honor Roll and received several Certificate of Continuous Excellence since the fiscal year of 2012 to current. Meeting or Exceeding State and Federal Average Performance measures in four areas:
 - ▶ Paternity Establishment
 - ▶ Support Order Establishment
 - ▶ Enforcement of Support Orders
 - ▶ Enforcement of Arrears
- ▶ For 2021, we enforced 1,341 cases in the four required areas. That number is usually much larger but in the last year we have managed to collect and close a lot of old child support arrears cases via several of our enforcement tools. We gain new cases weekly.

Child Support Enforcement Program (Prosecutor's Office IV-D)

- ▶ We send out income withholding orders to new employers and collect lump sum payments via several involuntary payment tools. Most child support payments are directed through the State with a very small percentage paid through the local clerk's office.
- ▶ Our office staff has been attending and completing roughly two years of training and certifications for a new child support program called Invest. Our State child support program has been operating on an old system for several decades and the State has invested a lot of time and planning for an updated system that our county will start using towards the end of 2022. It is being used in a few pilot counties at this time.




- ▶ We recorded over 9,100 documents last year which was up 1,500 from 2020.
- ▶ All of our records are scanned into our system but are not searchable by name. We are indexing old documents so they will be searchable.
- ▶ We indexed 8500 old documents, currently we are back to mid-1942 on deeds. With old and new documents, we indexed over 17,600 documents.
- ▶ Our vender Doxpop has a property watch program that you can sign up for and anytime something is recorded with their name or property they will get an alert.
