THRIVE West Central MOU - Grant Technical Assistance Nucor Road & US Highway 136 - \$5,000

Agreement to provide technical assistance and grant application preparation for the Nucor Road and U.S. Highway 136 Intersection Improvement Project due May 23. THRIVE agrees to write the narrative, create the application, and submit the application to USDOT on or before the deadline.

Public Hearing - Cecil Gill Petition to Vacate Portion of Lee Street in Linnsburg, Indiana - 8:00 am

Petition filed by Cecil Gill requests that the Commissioners vacate the west 178 feet of Lee Street in Linnsburg, Indiana. The Notice of Hearing has been published and the adjoining landowners notified via certified mail.

New Business

Notice to Proceed & Contract Bridge 29, 205 & 207 Deck Replacement -

At the July 25 meeting of the Board of Commissioners, the Commissioners opened bids for the Deck Replacement Project for Bridges 29, 205, 207. Two bids were submitted from Milestone - \$1,051,165 and H.I.S.'s - \$880,800. The Commissioners awarded the bid to H.I.S. in the amount of \$880,800.

Notice to Proceed & Contract for Landfill Project - J.S. McCullough -

Upon the recommendation of BFS the Commissioners awarded the bid for the Landfill Cap Stabilization Project to JS McCullough Excavating, LLC in the amount of \$437,064.60.

Change Order #3 - Comfort Drive - Remove existing CR200S -

The existing Comfort Drive (CR 200N) was originally planned to be removed, during construction it was determined that an Emergency Work Directive was required to maintain

the existing roadway. As part of the Emergency Work Directive (Construction Change 1) as a cost savings effort it was decided to eliminate the existing roadway removal from the contract and leave part of the existing cement stabilized roadway in as a "trail". Since that time there have been discussions with property owners along the existing roadway, who would like the entire existing roadway removed. As well as research into how the county can fund the maintenance of a gravel "trail". Based on the findings it is recommended that we remove the existing roadway completely and reclaim the stone for the County Highway's use. Discussions with Jake Laugh indicate that the county highway department would value the milled out existing roadway at \$25/Ton while the removal and delivering of material to the County Highways yard would cost \$6.60/Ton. This would allow the County Highway Department to get material at a significantly discounted price and remove the exiting roadway which would be very difficult to fund to maintain and please the residents that currently live on the roadway.

The project has also had several coordination issues during construction with Tempur Sealy and Indiana American Water's contractors as well as the unforeseen site conditions with the Sanitary Sewer Line that has limited the contractor from being able to use the entire site as planned to procure/spoil onsite materials for the earthworks to construct the roadway. F&K has agreed to haul the excess spoil material to the closed County Landfill for the County to use to in the Landfill Repair Project at a cost of \$11.10/CYD. Discussions with Jake Lough indicate that if the County were to purchase solid from a landfill for this project it would cost approximately \$20/CYD. This would allow the County Highway Department to get material at a significantly discounted price.

MEMORANDUM OF UNDERSTANDING FOR COLLABORATION WITH GRANT TECHNICAL ASSISTANCE

This Memorandum of Understanding for Nucor Road and U.S. Highway 136 Intersection Improvement Project (this "MOU") is formed between WEST CENTRAL INDIANA ECONOMIC DEVELOPMENT DISTRICT, INC. 3. The COUNTY agrees to notify THRIVE WEST CENTRAL of any changes or information that may impact the application/project.
4. The COUNTY agrees to secure signatures and final support letters to be submitted with the application.
5. The COUNTY agrees to communicate frequently and provide multiple points for feedback when requested.

III. Term & Termination

This MOU shall commence on the Effective Date and continue through July 1, 2022, at which time this MOU will terminate. To renew for additional period, a meeting is required to discuss experiences, outcomes, and any modifications. A new agreement will be issued. Either Party may terminate this MOU at any time and for any reason by providing at least thirty (15) days' advanced written notice to the other Party. 

The existing Comfort Drive (CR 200N) was originally planned to be removed. During construction it was determined that an Emergency Work Directive was required to maintain the existing roadway during construction. As part of the cost savings as part of that Emergency Work Directive (Construction Change 1) it was decided to eliminate the existing roadway removal from the contract and leave part of the existing cement stabilized roadway in as a "trail". Since that time there have been discussions with property owners along the existing roadway, and research into how the county can maintain a gravel "trail". Based on the findings it is recommended that we remove the existing roadway completely and reclaim the stone for the County Highway's use.

The project has also had several coordination issues during construction with Tempur Sealy and Indiana American Water's contractors as well as the unforeseen site conditions with the Sanitary Sewer Line that has limited the contractor from being able to use the entire site as planned to procure onsite materials for the earthworks to construct the roadway installation. F&K has agreed to haul the excess spoil material to the closed County Landfill for the County to use to in the Landfill Repair Project.

according to the plans and specification on file in the office of the Montgomery County Auditor and any supplemental or special provisions set or referred to in the CONTRACTOR's attached bid, and hereby agrees to pay the CONTRACTOR for the actual amount of such work done and materials in place, as measured by the Owner or their duly authorized representative at the Unit Prices stated in the CONTRACTOR's attached itemized proposal dated July 22, 2022, which sums the CONTRACTOR agrees to accept in full payment for such work, and


IT IS FURTHER MUTUALLY AGREED:

That the accompanying Proposal and Bond of the CONTRACTOR, together with the plans and specification, herein designated and referred to, are hereby made a part of the contract, the same as if herein fully set forth:

That the contract amounts may be paid to the CONTRACTOR upon progress estimated of completed work prepared by the Owner, but progress payments shall not exceed ninety percent (90%) of any such estimates less than the total amount of properly prepared and certified statements of indebtedness which shall have been filed against the CONTRACTOR for labor performed and materials furnished, or other services rendered in the carrying forward, performing and completing of this contract, and which estimate shall also be subject to the provisions of the standard specifications on file in the offices of the said County Auditor and made a part thereof;

That before any final estimate is paid to the CONTRACTOR, he shall furnish receipts for all debts incurred in the prosecution of such work or satisfactory evidence and assurance that the same have been paid; or shall consent to the withholding by the Owner from this final estimate of sums sufficient to cover any such indebtedness, which sums may be held until such indebtedness, is settled; and that no monies due on this final estimate shall be paid until the work is fully completed and accepted as provided in the specifications.
