
## Montgomery County 2022 Annual Report

Jail Corporal Cheyenne Warren won a Life Saving Award from the Indiana Sheriff's Association.






The County collaborated with the City to place more than 25,000 cubic yards of dirt at the closed landfill as part of the landfill cap stabilization project.

Jim Wolf, our Weights and Measures Inspector, completed 1,304 inspections of weight scales and gas pumps.



#### Assessor's Office

- In 2022, the Montgomery County Assessor's Office assessed and valued 23,139 real estate parcels for a gross assessed value of \$3,374,592,600.00. This was an increase in gross assessed value from the previous year of \$450,302,210.00.
- In 2022, the Montgomery County Assessor's Office received, audited and processed 1,956 Business Personal Property returns with a gross assessed value of \$553,620,380.00.

#### Assessor's Office

- Each year the County Assessor is required to send a Notice of Assessment of Land and Structures/Improvements to each property owner. This Notice lists the prior year's assessed value and the proposed assessed value for the upcoming tax year. From this Notice, taxpayers are allowed to appeal the proposed assessed value. Historically, Montgomery County has around .5% of appeals from our total parcel count.
- The 2022 pay 2023 assessed values increased significantly due to the strong real estate market. With the corresponding increase in assessed values, our office saw an increase in appeals from 159 (.5% of total parcel count) to 362 (1.5% total parcel count).
- The County Assessor is required to reassess ¼ of all parcels annually as a part of our cyclical reassessment. Our staff visited and reassessed 3,656 residential parcels, 1,389 agricultural parcels and 742 commercial/industrial parcels. 2022 was the first year of the 2026 Reassessment Cycle.

#### **Central Communications Center**

The Montgomery County Central Communications Center started off 2022 short-staffed.
We were able to fill all 4 open positions by the end of January. Unfortunately, by the middle of March, 3 of the 4 persons that were hired had resigned, all stating the position was too stressful and too much responsibility. We filled 2 of those later as the year progressed, but alas the position was not for them either. We are still in search of 4 qualified candidates to fill our openings. Staffing has been our biggest issue/concern of 2022.

▶ We retained Ritter Strategic Services for 2022 to continue moving forward with our Radio Replacement Project, as the current radio is at end of life. While working on this project, the County hired Ritter Strategic to assist in the project of Countywide EMS. Ritter Strategic was also to assist the Center's Director and Asst. Director in the re-writing of Standard Operating Procedures as well as the Center's Rules & Regulations. The Center and Ritter Strategic have completed approximately 75% our SOP's and Rules & Regulations. The plan is to have this completed by the end of March, 2023. As the year was coming to an end, the Center worked closely with Mike Davis, Director of Mapping and WTH, our mapping software company, to implement Countywide EMS as of January 1, 2023.

### **Central Communications Center**

- The Center is a centralized dispatch center for all of Montgomery County, including the City of Crawfordsville and all of our small communities as well.
- In 2022, the Center received 68,277 telephone calls from citizens for assistance, with 15,853 of those being 911 calls. From the 68,277 calls received, 55,955 Calls for Service were generated, whereas at least one entity from Fire, EMS and Law Enforcement responded. (In some cases, several entities responded.) The Center also received 1,474 text messages for assistance from citizens.
- NENA's standard is that calls will be answered in 10 seconds or less at least 95% of the time. Our average was 98.5% of the time.

### Child Support Enforcement Program (Prosecutor's Office IV-D)

- In Indiana, Child Support services are provided in each county by elected Prosecutors operating in cooperative agreement with the Child Support Bureau. The Montgomery County Child Support IVD Enforcement Office works under the Elected Prosecutor of Montgomery County.
- The Federal Office of Child Support Enforcement (OCSE) is part of the U.S. Department of Health and Human Services. It helps states develop, manage, and operate their programs effectively and according to Federal law. OCSE pays the major share of state program operating costs, provides location services, policy guidance and technical help to enforcement agencies, conducts audit and educational programs, supports research, and shares ideas for program improvement
- Child support services include locating parents, establishing paternity, establishing and modifying child support and medical orders, and enforcing the payment of child support through a variety of tools exclusively available through the child support enforcement program. The local child support enforcement office also takes referrals from those on various government programs and services receiving state and federal funds such as Foster Care and Temporary Assistance for Needy Families. The Montgomery County IVD Child Support office also prosecutes Non-Support of Dependent cases when the criteria is met by various nonpaying non-custodial parents.

# Child Support Enforcement Program (Prosecutor's Office IV-D)

- ▶ Tools that are available to collect child support include:
  - Income withholding
  - > Revocation of drivers, professional, recreational and occupational licenses of parents who are not current in their child support payments
  - Seizure of assets, including financial accounts
  - Liens on property
  - Denial of passports
  - Federal and state tax refund offset
- The Montgomery County IVD Child Support Enforcement office actively enforces 1,391 cases with new applicants added weekly. Since 2012, our office has received awards in all categories of establishment and enforcement from the State for exceeding state and federal performance averages.
- The local Montgomery County Child Support Enforcement Office finished 2022 with successful collections on 80.30% of cases in current support orders; 98.35% in Support Order Establishment; and 109.20% in Paternity Establishment. The program also scored 100% in their annual 2022 Self-Assessment Audit. A self-assessment audit is where the State selects cases from several periods during the review period and adds the results to provide a picture of performance for the entire period. The State would draw a separate sample for each incremental review period. The incremental approach enables the State to spread its review effort over time and make more efficient use of available resources because the sample size could be smaller, while allowing the State to identify problem areas and take corrective action prior to the end of the review period. For those States who review their case samples incrementally, the cases selected must be reviewed and evaluated for the actions required at the beginning of the incremental review period.
- The staff in Montgomery County's IVD Child Support Enforcement office believes that child support enforcement provides hope as well as support to Montgomery County's children

#### **Clerk's Office**

- City precincts were adjusted to take in new growth through annexations.
- Continued our education with new and updated legislative changes for Clerk's Office and Elections.
- Continued with changes to the case management system.
- 2022 Mid Term election saw over 9,500 voters exercise their right to vote for representation.

#### Courts

- After seeing the success of Judge Barajas's Drug Court and the Veterans Treatment Court started by Judge Lohorn, Judge Petrie started a Family Recovery Court to provide a structured program to help families struggling with substance use. This program has received full accreditation from the Supreme Court and is funded completely by State grants. Also involved in this program are Montgomery County Probation, Montgomery County DCS, Montgomery County Public Defender's Office, Valley Oaks Health, Cummins Behavioral Health, InWell, Montgomery County Youth Service Bureau, and the Crawfordsville Mobile Integrated Health Program.
- The Courts and the Clerks office have begun accepting electronic payments for Court costs and fees. In 2022, this allowed the Clerks office to receive \$44,373.76 in court costs that may otherwise not have been paid and \$166,183.15 in ticket payment.
- Additionally, the Clerks office has contracted with a collection agency to collect outstanding court costs and fines that have gone uncollected. The program began in August of 2022 and has already collected \$7,883.54.

- The 4-H Junior Livestock Board continues to provide additional leadership opportunities for youth in the area of livestock. 4-H members selected to this board gain experience in areas such as interviewing, organizing an event, listening to the needs of peers, and delivering educational programs to meet those needs.


