Approving Motorola Contract

The Motorola contract is for the purchase of the radio consoles for the Central Communications Center (CCC). The CCC Governing Board and the Commissioners have approved the purchase and staff is seeking approval of the contract with Motorola. The Council will consider the approval of the purchase and the loan with Tri-County at their March 14 meeting.

Acknowledge Receipt of RDC 2022 Annual Report

RDC's (Redevelopment Corporation) are required to annually file an annual report with the County Executive (Commissioners) and the County Fiscal Body (Council). After approvals the annual reports are submitted to the DLGF by the County Auditor.

New Business

Request to Name Private Driveway - Ruth/Jason Leaming

Crawfordsville Fire Inspector (Brian Bechtel) has recommended the naming of the private drive located on the Leaming property outside of the City limits on 136E.

Owners Ruth/Jason Leaming have submitted a request to name the private drive Leaming Lane. There are currently three homes located on the drive and a possibility of more in the future.

Authorizing the Serving of Alcohol at Event at the Government Center

On April 22, Athens Arts is hosting an event in which attendees, in groups of 20, will visit four art galleries in Crawfordsville to view the art, listen to music, enjoy finger foods and taste some wine. They have requested that the County Government Center Art Gallery be included as part of the event.

The wine tasting will involve tasting two types of wine in two glasses of 1 to 1.5 ounces. The wine will be served by a licensed bartender. Athens Arts will obtain the necessary state permits and sign an indemnification agreement.

Athens Arts is seeking authorization to utilize the County Government Center as one of the sites for the event and they are also seeking authorization to serve wine during the event at the County Government Center.

The Montgomery County Commissioners met in regular session on Monday, February 27, 2023 at 8:00 am at the Montgomery County Government Center, 1580 Constitution Row – Room E109, Crawfordsville, Indiana.

CALL TO ORDER

On call of the roll, the members of the Board were shown to be present as follows: President, John E. Frey; Vice President James D. Fulwider; and Commissioner Dan Guard.

Affirming Nucor Overpass Local Funding Commitment

The County is applying for a federal RAISE Grant for the Nucor Overpass project which involves the construction of an overpass over US Highway 136. The estimated total construction cost is \$20,193,983. If the grant is awarded to the County, the County will need provide a 20% local match and a contingency.

The local match would be as follows: 20% of the project cost (\$20,193,983), which would be \$4,009,050 and \$990,950 to be used as contingency for a total local commitment of \$5 million.

The application is due by February 28 and Commissioner President Frey has signed the local funding commitment letter, so our consultants can complete the application.

Commissioner Fulwider moved to approve the Consent Agenda. Seconded by Commissioner Guard. Motion carried 3-0 votes in favor.

NEW BUSINESS

Recognize the 200th Anniversary of the 1st Commissioner Meeting

The first Board of Commissioners meeting was held on Saturday evening, March 1, 1823.

County Administrator Tom Klein read the first paragraph of the minutes from that meeting verbatim including punctuation: *"The Commissioners this day elected for the County of Montgomery formed a Board for the first time and each of them towit William Offield, James Blevins and John McCullough having produced the certificates of the Sheriff of said County of their having been duly elected with the proper endorsements on each of them having taken the oaths to support the constitution the oath of office and the oath more effectuate to prevent dueling,"*

At their first meeting, they appointed John Vawter as Clerk Protem to the Board. They agreed to hold every odd numbered lot and proprietors would have every even numbered lot in the Town of Crawfordsville.

They also held a meeting on March 3, 1823. They appointed William Ramey as Agent, set his bond at \$10,000 and ordered him to give notice and sell certain lots owned by the County. They ordered Sheriff Samuel D. Maxwell to give notice of an election for March 22, 1823 for two Justices of the Peace. One justice must be a citizen west of the boundary of the Town and the other must be a citizen east of said boundary. James Stitt was appointed Treasurer. They also appointed Joseph Hahn, John Gowan and William Miller as Fence Viewers for the entire County (there was only one township). Additional appointments included Joseph Hahn and Richard McCafferty as Overseers of the Poor and Samuel McClung as the Supervisor for the Township school. They ordered that the bond for Major Ambrose Whitlock for the sale to the County of 85 "inlots" in the Town of Crawfordsville be filed. A portion of the minutes are missing but it says "3 acres of land for a burying ground" after the mention of 85 inlots.

Commissioner Fulwider moved to take the two bids submitted under advisement. Seconded by Commissioner Guard. Motion carried 3-0 votes in favor.

Approval of EMA Advisory Board EM-HS Director Recommendation

Emergency Management Advisory Council have recommended Jessica Burget as the EM-HS Director. Ms. Burget has been serving as the Interim EMA Director during the time that the EMA Council conducted interviews for the position.

Commissioner Guard moved to appoint Jessica Burget as the EM-HS Director. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.

2023 EMA Director Contract

The EMA Advisory Council is recommending a base salary of \$49,000 for 2023. The proposed contract term is 2/27/23 to 12/31/24. *Commissioner Guard moved to approve the Quotes and Authorizations for the cape seal and double micro projects. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.*

Resolution 2023-4 Resolution Approving Interlocal Agreement for Emergency Communications Department -

The County and the City currently have an agreement that establishes the governing mechanism for the Central Communications Center. The agreement expires on March 1, 2023 and the County and City have worked to develop a new agreement. Here are some of the key highlights of the agreement.

Key highlights of the proposed agreement:

The term of the Agreement shall be for a period of four (4) years commencing as of March 1, 2023 and continuing through April 30, 2027.

The County will continue to maintain a branch of government called the Montgomery County Central Communications Center ("Center").

The five (5) members of the Governing Board shall be as follows:

- a. President of the Board of Commissioners
- b. One (1) County Commissioner appointed by the President of County Commissioners
- c. One (1) member of the County Council appointed by the President of County Council
- d. Mayor of City of Crawfordsville
- e. One (1) member of the City Council appointed by the Mayor

The Governing Board shall have the following responsibilities:

- a. Appoint the Director of the Center
- b. Annually appoint a member of the Board or designee to serve as the Director's supervisor for the day-to-day management responsibilities of the Center.
- c. Review the proposed annual budget prior to it being presented to Montgomery County Council
- d. Approve all contracts before being submitted to county commissioners
- e. Appoint certain members of the Operations Board
- f. Administer this Agreement

The Center and delivery of emergency communications shall be funded as follows:

- a. Funds received from the Indiana Statewide 911 Board shall be deposited into the Montgomery County Statewide 911 Fund #1222 and used for the operation of the Center as permitted by I.C. § 36-8-16.7-38.
- b. The County shall contribute \$232,500 in fiscal year 2023 to county fund #4900. This may require an additional appropriation.
- c. The City shall contribute \$232,500 in fiscal year 2023 to county fund #4900.
- d. The cash balance in fund #4900 until all funds are expended.
- e. For the duration of this Agreement (years 2 thru 4) the Public Safety Answering Point Local Income Tax.
 - f. In the event Center funding from Statewide 911 Fund #1222 or the Local Income Tax is less than anticipated and actual expenses to operate the Center exceed revenue, the County and City shall evenly split the remaining amount (50% county and 50% city).
 - a. This shall not exceed five percent (5%) of either Party's contractual contribution of \$232,500.
 - b. The shortfall amount to be paid shall be set by the Governing Board and shall be based on actual expenses rather than a budgetary deficit.

Commissioner Fulwider moved to approve Resolution 2023-4 Approving Intergovernmental Cooperation Agreement with the City of Crawfordsville for Emergency Communications Department. Seconded by Commissioner Guard. Motion carried 3-0 votes in favor.

Motorola Radio MCC7500E Console Quote

Equipment Discounted per State Contract & System Integration - \$561,838 and Post Warranty Services and Essential Plus Year 1-6 - \$150,012 with a loan through Tri-County Bank.

Commissioner Fulwider moved to approve the Motorola Radio Console quote. Seconded by Commissioner Guard. Motion carried 3-0 votes in favor.

State Matching Grant Program for the Opioid Settlement

The State has created a matching grant program for the prevention and treatment of opioid addiction. The deadline to apply for the grant is February 28, 2023. The County is the responsible entity for the submittal of the grant application. At a previous meeting, the Commissioners assigned Drug Free Montgomery County (DFMC) the responsibility of developing a plan for the use of the funds from the opioid settlement. As part of this responsibility, DFMC established a process to review potential grant applications from local drug treatment organizations for the State matching grant program. The Recovery Coalition requested authority to apply for a grant from the State Revolving Fund in the amount of \$302,500 with a local match of \$30,000. The grant funds would be used to purchase the current building housing the Recovery Coalition located at 1300 Ladoga Road, Crawfordsville.

Commissioner Fulwider moved to approve upon award of the SRF Grant to the Recovery Coalition to use the Opioid Settlement Funds for the required \$30,000 match. Seconded by Commissioner Guard. Motion carried 3-0 votes in favor.

PTABOA Appointment

Assessor Sherri Bentley stated that long-time member Mel Vance has been deemed unable to continue his service on the PTABOA Board due to winning his election bid to the Wayne Township Advisory Board. Assessor Bentley has recommended John Downey to service in place of Mel Vance. *Commissioner Guard moved to approve the appointment of John Downey to the PTABOA. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.*

OTHER BUSINESS

Commissioner Frey stated WHIN have planned to provide Broadband to Ladoga and Waynetown as a beta tests along with five commercial sites.

ADJOURNMENT

There being no further business before the Board, *Commissioner Guard moved to adjourn. Motion passed 3-0 votes in favor.* Meeting adjourned @ 8:12 am.

G. SUMMARY OF ACTIVITIES OF REDEVELOPMENT COMMISSION DURING 2022

The Commission received allocations of tax increment revenue from the Nucor Road Economic Development Allocation Area and made deposits and payments as required by the terms of the Commission's Refunding Bonds of 2017 and 2018 Sewer Lease Bonds in order to extend sewage collection service within the Nucor Road Economic Development Area. Also, the 2021 Economic Development Bonds were issued for incentives to Tempur Sealy, the 2022 Economic Development Bonds were issued for water and rail improvements, and the 2022 RDA Lease Bonds were issued for sewer, drain, and road improvements. Further, the Commission continued analysis of road improvements for the allocation area. The Commission continued work towards the expansion of infrastructure and utilities throughout its area. It incented a new factory to locate in the area, bringing ~300 new jobs, and investing ~\$150 million. This new factory was segregated into a new allocation area (Tempur Sealy Allocation Area) and the revenue will be used to improve roads, extend water, extend sewer, and extend rail. The Commission continued its design and engineering to expand capacity of the waste water treatment plant in order to quickly respond to additional development. The Commission promoted economic development through professionals to market areas throughout Montgomery County. The Commission paid engineering and consulting fees to research and analyze the appropriate projects needed for economic development specific to Montgomery County.
