The partial road closure will be from the Ryker residence at 1089 South Glenway Drive to the Rush residence at 1129 South Glenway Drive.

Quote is from Fishero and Fishero, Inc. in the amount of \$11,472 for work at the County

Government Center to remove and replace the existing 11' by 18' and 4' X '10 concrete entry

pads at the north entrance, replace 4' X 35' of concrete sidewalk adjacent to the north entry

area, replace 4' X 35' of concrete sidewalk along the north side of the building to the employee

parking area and replace 10 feet of concrete curbing at the east end of the north walk to make a

ORDINANCES

Final Reading Ordinance 2023-10: Creating the Local Public Health Services Fund The Indiana Legislature has passed Senate Enrolled Act 4 (2023) and House Enrolled Act 1001 (2023) and signed into law as P.L. 164-2023 to ensure every Hoosier has access to the core public health services that allow them to achieve their optimal health and well-being. The new legislation provides new enhanced funding for local departments of health at the option of local county government. On June 26, 2023, the Montgomery County Board of Commissioners resolved to opt into the funding program. Public Law 164-2023 requires the County to establish a separate fund known as the "local public health services fund" to receive local board of health funding under this program. The proposed ordinance establishes the Local Public Health Services Fund to receive, use, and account for funds received from the State of Indiana by the County for the Montgomery County Health Department as administered by its Board of Health, as a participating member of the legislation.

Final Reading Ordinance 2023-11: Amending Internal Controls to Adopt Suspension and Debarment Policy

The Ordinance amends the County's Internal Controls Policy to adopt and implement a Suspension and Debarment policy. Federal law requires local governments to comply with certain regulations regarding the contracting of business with third party contractors and subcontractors who are subject to federal suspension and debarment from performing work on projects funded by certain federal and/or state funds. The County follows these

regulations but the requirements of the regulations are not contained in the County's internal control policy. The Suspension and Debarment policy will ensure that the County only contracts with contractors and consultants that are not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from entering into a contract with the County by any federal or state agency.

Final Reading Ordinance 2023-12: Adopting a Federal Funds Purchasing Policy In order for the County to accept funding from the Federal Government, the County must adopt a purchasing policy regarding the procurement of goods, materials and services in accordance with Title 2, Part 200 of the Code of Federal Regulations. The Ordinance adds a new section to the County Code to establish a purchasing policy to comply with these Federal Regulations.

Final Reading Ordinance 2023-13: Adopting Internal Control Policy Regarding Federal Grants and Cost Principles

The ordinance adds a Cost Principles Policy to the County's Internal Controls Policy. When the County is a recipient of federal award, the County is responsible for administering the federal funds according to federal, state, and local laws, as well as according to the federal award itself. Federal law requires the County to adhere to certain accounting principles to ensure that the federal government pays for costs associated with the administration of the awards. The accounting principles that the County is required to comply with are contained in the Code of Federal Regulations, 2 C.F.R Part 200, Subpart E "Cost Principles".

Final Reading Ordinance 2023-14: Amending the Clothing Allowance Policy
The proposed Ordinance to amend the clothing allowance policy was introduced at the July 24
meeting of the Board of Commissioners. The introduced ordinance amended the employee
eligibility section to include the Probation Department, Emergency Management/Homeland
Security or any other Department. The proposed Ordinance also removed the requirement that
employees purchase clothing or uniforms prior to receiving a clothing allowance.

The proposed Ordinance has a few amendments upon final reading which are highlighted in yellow. The first amendment clarifies the distinction between a uniform as defined by the IRS and clothing. The next amendment states that an allowance may be for a uniform or clothing. Another amendment states that the uniform allowance will be processed through the accounts payable process instead of through the payroll process. The final amendment states that a Department may choose to purchase clothing or uniforms on behalf of the employees.

CALL TO ORDER

On call of the roll, the members of the Board were shown to be present as follows: President, John E. Frey; Commissioner Jim Fulwider and Commissioner Dan Guard.

Also present: County Attorney Dan Taylor; Auditor Mindy Byers; Sheriff Ryan Needham; Building Administrator Marc Bonwell; Highway Director Jake Lough; CCC Director Sherri Henry; Assessor Sherri Bentley; Health Administrator Adrianne Northcutt; Chief Probation Officer Andria Giegle; Soil & Water Director Kristen Latske and Executive Assistant Lori Dossett.

PLEDGE & PRAYER

Board President Commissioner John Frey led the pledge of allegiance and Jim Fulwider led the prayer.

CONSENT AGENDA

Approval of Claims: Accounts Payable: \$\$3,983,268.92 and Payroll \$422,529.69 Minutes: June 26, 2024 and July 10, 2024

Affirm USI Authorization to Proceed Form - 2023-02 CCMG Application and Contract Document Preparation - Highway Department - \$22,000

CCMG application assistance from USI consultants for the amount of \$22,000. This is will include cost estimates, develop spreadsheet for quantities, individual estimates for each segment, contract documents, and detailed plans.

Affirm Purchase of Trucks - Highway Department

Enterprise- highway is seeking permission to utilize the enterprise program and obtain 3- RAM 3500 trucks for the amount of \$54,490 per year. This includes all aftermarket equipment needed. This is part of the replacement plan and has been budgeted. Attached are the already signed quotes from Enterprise.

Authorization to Join Lafayette Region for READI 2.0

The State Legislature has created the READi grant program to encourage neighboring communities across the state to work collaboratively to develop a bold vision for their future that will attract, develop and retain talent in Indiana. To achieve this vision, the State required regions to develop development plans that outlined strategies focused on improving the quality of place, life and opportunity within their communities. To help regions achieve their goals in their development plans, the State awarded up to \$50 million per region. Montgomery County joined the 180 Alliance regional group for READi. Other members of the group were Boone County, Hendricks County, Morgan County, Johnson County and Putnam County. The County received a READi grant for the construction of the extension of Purple Heart Parkway from 231 to Ladoga Road.

During the 2023 State legislative process, additional funds were approved for a second round of READi grant funding known as READi 2.0. The State has instructed the donut counties around Indianapolis to

belong to the central Indiana regional group for READi 2.0. This means that the 180 Alliance group will no longer exist. The County will need to choose a new regional group. The options include joining the regional groups centered in Lafayette or Terre Haute. Another option is to join the central Indiana regional group. A final option is to create a new regional group with Putnam County and Greencastle. Based on conversations with the City of Crawfordsville, the City of Greencastle and Putnam County, we are recommending that we join the regional group centered in Lafayette. It is the closest region to Montgomery County. In order to join the regional group centered in Lafayette, the County must submit letter of intent by July 31, 2023.

Redaction Services & Support Agreement - Recorder's Office

The Recorder's Office is seeking approval of a contract with CSI-Computer Systems, Inc. to provide redaction services for public documents in the Recorder's Office. The service is an automated process that blocks specific information in a scanned document such as social security numbers from being viewable.

The proposed contract term is from July 1, 2023 to June 30, 2027. The cost of this service for newly recorded scanned documents is \$3,375.

CSI also provides this service for documents previously scanned with a cost based on volume: \$.065/page for a volume of less than 500,000 pages, \$.055/page between 500,000 and 749,999 pages, \$.045/page between 750,000 and 999,999 pages and \$.035/page for 1,000,000 or more pages. The contract will be paid from the Recorder's Office budget.

Commissioner Guard moved to approve Consent Agenda. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.

NEW BUSINESS

2023 Community Crossings Grant Application Financial Commitment

CCMG financial commitment letter state we are responsible for of our 25% plus any that goes over. The engineered estimate has our match at \$351,900. Because of the estimate being high we did cut 2 roads from the application, 200 E between 150 S & 300 S, and 300 S between Ladoga road & 200 E. The roads that we are applying for on the application are

- Concord Road between Crawfordsville City limits and 400 N
- 150 S between Ladoga Road & Nucor Rd
- 700 N between US 231 & 100 W
- 600 S between State Road 47 & New Market City Limits
- 600 S between New Market City limits & US 231

Commissioner Guard moved to approve the 2023 Community Crossings Grant Application Financial Commitment. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.

MOU with IMPA for Guardrail Installation

The Indiana Municipal Power Agency (IMPA) has requested that the County install a guardrail in the right of way on the west side of County Road 250 East across from the end of Comfort Drive to protect their solar farm located on the west side of County Road 250 East. IMPA has stated that they will reimburse the County for the cost to install the guardrail. The Memorandum of Understanding establishes the agreement for the installation of the guardrail and reimbursement for the cost of installation. IMPA agrees to pay any future costs for the repair or replacement of the guardrail.

Commissioner Guard moved to approve the MOU with IMPA for Guardrail Installation. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.

Award Guardrail Quotes for Installation of Guardrail at the site of the IMPA solarfield located on CR250E

Highway Director Jake Lough advised three requests for quotes were issued and only two responses were received: Henderson & C-Tech of Boggerstown. The C-Tech estimate is \$7,000. Commissioner Fulwider moved to approve the C-Tech estimate for the guardrail installation. Seconded by Commissioner Guard. Motion carried 3-0 votes in favor.

Notice to Bidders - Bridge 182

Highway Director Jake Lough requested approval to advertise notice to bidders for construction of bridge 182 over big raccoon creek on county road 750 E. The proposed construction consists of constructing a precast flat top structure with precast footers, headwalls, and wing walls. Also includes guardrail, roadway approach work, site grading, and demolition of existing structure according to plans and specifications. Bids are due to commissioner's office August 25th by 3:00 pm. The bids will be opened September 11th at the commissioners meeting.

The Probation Department has received \$15,740 for multiple grants to support the Juvenile Cognitive Behavioral Program.

Commissioner Guard moved to approve Ordinance 2023-9 2024 Local Coordinating Council Grant Fund. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.

First Reading Ordinance 2023-10: Creating the Local Public Health Services Fund

The Indiana Legislature has passed Senate Enrolled Act 4 (2023) and House Enrolled Act 1001 (2023) and signed into law as P.L. 164-2023 to ensure every Hoosier has access to the core public health services that allow them to achieve their optimal health and well-being. The new legislation provides new enhanced funding for local departments of health at the option of local county government. On June 26, 2023, the Montgomery County Board of Commissioners resolved to opt into the funding program. Public Law 164-2023 requires the County to establish a separate fund known as the "local public health services fund" to receive local board of health funding under this program. The proposed ordinance establishes the Local Public Health Services Fund to receive, use, and account for funds received from the State of Indiana by the County for the Montgomery County Health Department as administered by its Board of Health, as a participating member of the legislation.

First Reading Ordinance 2023-11: Amending Internal Controls to Adopt Suspension and Debarment Policy

The Ordinance amends the County's Internal Controls Policy to adopt and implement a Suspension and Debarment policy. Federal law requires local governments to comply with certain regulations regarding the contracting of business with third party contractors and subcontractors who are subject to federal suspension and debarment from performing work on projects funded by certain federal and/or state funds. The County follows these regulations but the requirements of the regulations are not contained in the County's internal control policy. The Suspension and Debarment policy will ensure that the County only contracts with contractors and consultants that are not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from entering into a contract with the County by any federal or state agency.

First Reading Ordinance 2023-12: Adopting a Federal Funds Purchasing Policy

In order for the County to accept funding from the Federal Government, the County must adopt a purchasing policy regarding the procurement of goods, materials and services in accordance with Title 2, Part 200 of the Code of Federal Regulations. The Ordinance adds a new section to the County Code to establish a purchasing policy to comply with these Federal Regulations.

First Reading Ordinance 2023-13: Adopting Internal Control Policy Regarding Federal Grants and Cost Principles

The ordinance adds a Cost Principles Policy to the County's Internal Controls Policy.

When the County is a recipient of federal award, the County is responsible for administering the federal funds according to federal, state, and local laws, as well as according to the federal award itself. Federal law requires the County to adhere to certain accounting principles to ensure that the federal government pays for costs associated with the administration of the awards. The accounting principles that the County is required to comply with are contained in the Code of Federal Regulations, 2 C.F.R Part 200, Subpart E "Cost Principles".

First Reading Ordinance 2023-14: Amending the Clothing Allowance Policy

The County has adopted a clothing allowance policy that outlines the process to provide a clothing allowance or uniform for employees. The Ordinance amends the employee eligibility section to include the Probation Department, Emergency Management/Homeland Security or any other Department. The Ordinance also removes the requirement that employees purchase clothing or uniforms prior to receiving a clothing allowance.

Montgomery County Board of Commissioners Ordinance 2023 -10

Ordinance Creating the Local Public Health Services Fund

Whereas, the Indiana Legislature has passed Senate Enrolled Act 4 (2023) and House Enrolled Act 1001 (2023) signed into law as P.L. 164-2023 to ensure every Hoosier has access to the core public health services that allow them to achieve their optimal health and well-being; and

Whereas, this new legislation provides new enhanced funding for local departments of health at the option of local county government; and

Whereas, on June 26, 2023, the Montgomery County Board of Commissioners by Resolution 2023- 5 resolved to opt into the funding program; and

Whereas, Public Law 164-2023 requires the County to establish a separate fund known as the "local public health services fund" to receive local board of health funding under this program; and

Therefore, it is ordained that a new section, §35.187, shall be added to Chapter 35 of the Montgomery County Code, and this new section shall read as follows:

§35.187 Local Public Health Services Fund

(A) Establishment of Fund. The Montgomery County Board of Commissioners hereby establishes the Local Public Health Services Fund to receive, use, and account for funds received from the State of Indiana by Montgomery County for the Montgomery County Health Department as administered by its Board of Health, as a participating member of the legislation.

- **(B)** Use of Funds. The Montgomery County Board of Health may authorize the expenditure of funds from the Local Public Health Services Fund to provide any of the following services:
 - (1) Core public health services.
 - (2) Any statutorily required actions for a local health department.
 - (3) Evidence based programs to prevent or reduce the prevalence of health issues or improve the health and behavioral health of Indiana residents as outlined in the plan described in IC 16–30–3–2.

Money in the fund may not be used for any purpose other than for services listed above.

- (1) At least sixty percent (60%) of the funds shall be spent on the following core public health services:
 - (a) Communicable disease prevention and control.
 - (b) Vital statistics.
 - (c) Tobacco prevention and cessation.
 - (d) Supporting student health as set forth in IC 16–18–2–79.5(14).
 - (e) Child fatality review.
 - (f) Suicide and overdose fatality review.
 - (g) Maternal and child health.
 - (h) Testing and counseling for HIV, hepatitis C, and other sexually transmitted infections, in accordance with IC 20–30–5–13.
 - (i) Tuberculosis control and case management.
 - (j) Emergency preparedness.
 - (k) Referrals to clinical care as set forth in IC 16–18–2–79.5(22).
 - (l) The prevention and reduction of chronic illnesses.
 - (m) Screening and case management for childhood lead exposure and poisoning.
 - (n) Health promotion and education for preventing trauma and injury.
 - (o) Access to childhood and adult immunizations.
- (2) Not more than forty percent (40%) of the funds may be spent on the following core public health services:
 - (a) Food protection.
 - (b) Pest and vector control and abatement.
 - (c) Inspection and testing of public and semipublic pools.
 - (d) Residential onsite sewage system permitting and inspections.
 - (e) Orders for the decontamination of property used to illegally manufacture a controlled substance.
 - (f) Sanitary inspections and surveys of public buildings.

- (g) Sanitary operation of tattoo parlors and body piercing facilities.
- (h) Sanitary operations of facilities where eyelash extensions are applied.
- (3) Notwithstanding sections (1) and (2) the funds may be used in different percentages upon the request and receipt of a waiver approved by the Indiana State Department of Health as outlined in Indiana Code 16-20-1-12(d), as amended from time to time.
- (4) No more than ten percent (10%) of the funds in the Local Public Health Services Fund that are received during or for a fiscal year may be used for capital expenditures including:
 - (a) the purchase, construction, or renovation of buildings or other structures;
 - (b) land acquisition; and
 - (c) the purchase of vehicles and other transportation equipment.

Funds used for capital expenditures from the Local Public Health Fund must be included on the annual financial report required by Indiana Code 16-46-10-2.2 or 2.3, as amended from time to time, and posted on the local health department's website.

- **(C)** Non-Reverting Fund. This fund shall be non-reverting and remain in effect until modified or rescinded by the Montgomery County Board of Commissioners.
- **(D) Severability**. If any provision of this ordinance is held to be invalid by a court of competent jurisdiction, all other provisions of this ordinance not otherwise invalidated will remain in full force and effect.

It is further ordained that this ordinance is effective upon adoption.

It is further ordained that any other provisions of the Montgomery County Code which are not specifically amended by this ordinance shall remain in full force and effect.

Whereas, although the County Government follows these regulations, the requirements of the regulations are not contained in the County's internal control policy; and

Whereas, including these rules and regulations in the internal controls policy will encourage compliance and help ensure that all contracts supported by federal or state funding include a Suspension and Debarment clause in order to ensure efficient and effective administration of the funding; and

Whereas, a Suspension and Debarment policy will ensure that the County only contracts with contractors and consultants that are not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from entering into a contract with the County by any federal or state agency; and

Whereas, the Board of Commissioners now finds it is in the best interest of the County, and its citizens, to amend the County Internal Controls Policy to adopt and implement a Suspension and Debarment policy, attached to this ordinance as Exhibit A.

Therefore, it is ordained, that the County Internal Controls Policy be amended to include the attached Suspension and Debarment policy.

It is further ordained that this Ordinance shall become effective upon adoption.

Exhibit A

Policy 5: Contracts Policy

5.01 Contracts Supported by Federal Funds: Under Federal law and regulations, a Department Head who administers a contract or agreement which is supported by federal or state funds is responsible for the efficient and effective administration of grant funds through the application of sound management practices. Such funds shall be administered in a manner consistent with all applicable Federal, State and local laws, the associated agreements/assurances, program objectives and specific terms and conditions of the grant award. In addition, (1) all public works agreements and (2) any other agreement entered into by Montgomery County or one of its agencies, offices, boards or commissions that is supported by federal or state funds or may be supported by federal or state funds in the future must include the following paragraph:

Neither the contractor/consultant nor its principals are presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from entering into this contract by any federal agency or by any department, agency or political subdivision of the State. The contractor/consultant agrees that if after the execution of this agreement, either it or any of its principals are debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from entering into contracts similar to this one that it will immediately notify the County Administrator. For purposes of this agreement, the term "principal" means an officer, director, owner, partner, key employee, or other person with primary management or supervisory responsibilities, or a person who has a critical influence on or substantive control of the operations of the contractor/consultant or who has managerial or supervisory responsibilities for the services to be delivered under this agreement. In addition, the contractor/consultant represents that none of its subcontractors or subconsultants are presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from entering into this contract by any federal agency or by any department, agency or political subdivision of the State. The contractor/consultant is solely responsible for any recoupment, penalties or costs that arise from the use of a suspended or debarred subconsultant. If any subconsultant becomes debarred or suspended, the contractor/consultant will immediately notify the County Administrator and, at the request of Montgomery County, take all steps required by the County to terminate the cntractor/consultant's contractual relationship with said subconsultant for work to be performed under this contract. If the contractor/consultant breaches its obligations under this paragraph, including but not limited to, the condition and obligation of not being debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from entering into this contract, the County shall have the right to terminate this contract and to delay, withhold or deny work under any supplement or amendment, change order or other contractual device issued pursuant to this contract.

Ordinance 2023-12

Adopting a Federal Funds Purchasing Policy

Whereas, the Montgomery County Government from time to time accepts funding from the Federal Government; and

Whereas, in order to accept funding from the Federal Government, the County must adopt a purchasing policy regarding the procurement of goods, materials and services in accordance with Title 2, Part 200 of the Code of Federal Regulations; and

Whereas, the Board of Commissioners desires to adopt a purchasing and procurement policy in accordance with the Code of Federal Regulations to govern the County's procurement of goods, materials and services; and

Whereas, the Board finds that is in the best interest of the County to add a new section to the County Code to establish a purchasing policy to comply with Federal regulations and to promote economic efficiency and continuity in purchasing; and

It is further ordained that a new section of the Montgomery County Code, Section 36.40, is hereby added and this new section shall read as follows:

"§ 36.40 Federal Funds Purchasing Policy

For purchasing involving Federal funds or Federal oversight, the following procedure shall be followed:

- (A) **Records.** The County shall maintain records sufficient to detail the history of procurement. These records shall include, but are not limited to, the following:
 - a. Rationale for method of procurement;
 - b. Selection of contract type;
 - c. Contractor selection or rejection; and
 - d. The basis for the contract price.
- **(B)Informal procurement methods.** When the value of the procurement for property or services under a federal award does not exceed the simplified acquisition threshold (SAT), as defined by 2 CFR 200.1, formal procurement methods are not

required. The County may use informal procurement methods to expediate the completion of its transactions and minimize the associated administrative burden and cost. The informal methods used for procurement of property or services at or below the SAT include:

a. Micro-purchases

- Distribution. When acquiring supplies or services for an aggregate dollar amount of which does not exceed the micro-purchase threshold established by Federal law, if practicable, the County should distribute micro-purchases equitably among qualified suppliers.
- ii. Micro-purchase awards. Micro-purchases may be awarded without soliciting competitive prices or rate quotations if the County considers the price to be reasonable based on research, experience, purchase history or other information and documents it files accordingly.
- iii. **Mirco-purchase thresholds.** The County adopts the Federally-determined threshold for micro purchases, reserving the right to increase the threshold based on an evaluation of risk.
- iv. Higher Local Threshold. If the County decides on a threshold above the Federal standard, the County must include any of the following:
 - A qualification as a low-risk auditee, in accordance with the Federally-set criteria for the most recent audit;
 - An annual internal institutional risk assessment to identify, mitigate, and manage financial risks; or,
 - For public institutions, a higher threshold consistent with state law.
- v. **Indirect Costs**. If the County increases the micro-purchase threshold over \$50,000, it must be approved by the cognizant agency for indirect costs. The County must submit a request as required by 2 CFR 200.320(a)(1)(iv). The increased threshold is valid until there is a change in status in which the justification was approved.

b. Small purchases

- i. Small purchase procedures. Small purchase procedures are to be used when the aggregate dollar of acquiring property or services is higher than the micro-purchase threshold but does not exceed the simplified acquisition threshold. Price or rate quotations must be obtained from an adequate number of qualified sources as determined appropriate by the Board of Commissioners.
- Simplified acquisition thresholds. The County adopts the Federal simplified acquisition threshold.
- c. **Formal procurement methods.** When the value of the procurement for property or services under a federal financial assistance award exceeds the

simplified acquisition threshold, formal procurement methods are required. Formal procurement methods require public advertising unless a non-competitive procurement can be used in accordance with Federal law. The following formal methods of procurement are used for procurement of property or services above the simplified acquisition threshold or a value below the simplified acquisition threshold:

- i. Sealed bids. Bids shall be publicly solicited and a firm fixed-price contract (lump sum or unit price) is awarded to the responsible bidder whose bid, conforming with all the material terms and conditions of the invitation for bids, is the lowest in price.
- ii. Sealed bids applicability. In order for sealed bidding to be feasible, the following conditions should be present:
 - A complete, adequate, and realistic specification or purchase description;
 - 2. Two or more responsible bidders are willing and able to compete effectively for the business; and
 - 3. A firmed fixed price contract and the selection of the successful bidder can be made principally on the basis of price.
- iii. If sealed bids are used, the following requirements apply:
 - Bids must be solicited from an adequate number of qualified sources, providing them sufficient response time prior to the date set for opening the bids, for local, and tribal governments, the invitation for bids must be publicly advertised;
 - The invitation for bids, which will include any specifications and pertinent attachments, must define the items or services in order for the bidder to properly respond;
 - 3. All bids will be opened at the time and place prescribed in the invitation for bids, and the bids must be opened publicly;
 - 4. A firm fixed price contract award will be made in writing to the lowest responsive and responsible bidder. Where specified in the bidding documents, factors such as discounts, transportation cost, and life cycle costs must be considered in determining which bid is lowest. Payment discounts will only be used to determine the low bid when prior experience indicates that such discounts are usually taken advantage of; and
 - Any and all bids may be rejected if there is a sound documented reason.
- iv. Proposals: Proposals are a procurement method in which either a fixed price or cost-reimbursement type is awarded. Proposals are generally used when conditions are not appropriate for the use of

sealed bids. They are awarded in accordance with the following requirements:

- Requests for proposals must be publicized and identify all evaluation factors and their relative importance. Proposals must be solicited from an adequate number of qualified offerors. Any response to publicized requests for proposals must be considered to the maximum extent practical;
- The County will have a written method for conducting technical evaluations of the proposals received and making selections;
- Contracts must be awarded to the responsible offeror whose proposal is most advantageous to the County, with price and other factors considered; and
- 4. The County may use competitive proposal procedures for qualifications-based procurement of architectural/engineering professional services to evaluate offeror's qualifications and select the most qualified offeror, subject to negotiation of fair and reasonable compensation. The method, where price is not used as a selection factor, can only be used in procurement of architectural/engineering professional services. It cannot be used to purchase other types of services through architectural/engineering firms that are a potential source to perform the proposed effort.
- v. Noncompetitive procurement. There are specific circumstances in which noncompetitive procurement can be used. Noncompetitive procurement can only be awarded if one or more of the following circumstances apply:
 - The acquisition of property or services, the aggregate dollar amount of which does not exceed the micro-purchase threshold;
 - 2. The item is available only from a single source;
 - The public exigency or emergency for the requirement will not permit a delay resulting from publicizing a competitive solicitation;
 - The federal awarding agency or pass-through entity expressly authorizes a noncompetitive procurement in response to a written request from the County; or
 - After solicitation of a number of sources, competition is determined inadequate.
- d. The County shall conduct procurements in a manner that prohibits the use of statutorily or administratively imposed state, local, or tribal geographical preferences in the evaluation of bids or proposals, except in those cases where

- applicable Federal statutes expressly mandate or encourage geographic preference.
- e. When contracting for architectural and engineering services, geographic location may be a selection criterion provide its application leaves an appropriate number of qualified firms, given the nature and size of the project, to compete for the project."

It is further ordained that this ordinance shall become effective upon adoption.

It is further ordained that all other provisions of the Code of Ordinances which are not specifically amended by this ordinance shall remain in full force and effect.

Adopting Internal Control Policy Regarding Federal Grants and Cost Principles

Whereas, the Montgomery County government is periodically the recipient of federal awards, such as federal grants, to complete projects or provide services; and

Whereas, when the County is a recipient of federal award, the County is responsible for administering the federal funds according to federal, state, and local laws, as well as according to the federal award itself; and

Whereas, when administering certain federal awards, federal law requires the County to adhere to certain accounting principles to ensure that that the federal government pays for costs associated with the administration of the awards; and

Whereas, the accounting principles that the County is required to comply with are contained in the Code of Federal Regulations, 2 C.F.R Part 200, Subpart E "Cost Principles"; and

Whereas, the County maintains a local Internal Controls Policy and ensures that personnel receive training on Internal Controls; and

Whereas, the Board of Commissioners finds that it is in the best interest of the County to adopt an internal control policy addressing Cost Principles that incorporates 2 C.F.R. Part 200, Subpart E by reference in order to ensure adequate controls over and accounting for federal awards.

Therefore, it is ordained that the County Internal Controls Policy be amended to include a Cost Principles policy, attached as Exhibit A.

It is further ordained that all other provisions of the Montgomery County Code

not specifically amended by this ordinance shall remain in full force and effect.

It is further ordained that this ordinance shall become effective upon adoption.

Exhibit A

Policy 4: Allowable Costs / Cost Principles

4.01 Application: The Office of Management and Budget (the "OMB") prescribes the cost accounting requirements associated with local governments' administration of federal awards (the "Cost Principles"). The requirements are contained in 2 CFR Part 200, Subpart E. The Cost Principles applicable to Montgomery County apply to all federal awards received by the County, unless the County is not required to account to the federal awarding agency or pass-through entity for actual costs incurred.

4.02 Purpose: It is the County's intent to comply with 2 CFR 200, Subpart E, and adopts the regulation as an Internal Control policy by reference. It is the intention of the County to aid the County and its employees in administering federal awards. The guidelines contained in this policy are non-exclusive and not intended to list all the requirements of the Cost Principles that the County shall follow when administering federal awards.

4.03 Cost Principle Guidelines

- (1) Basic Guidelines. Except where otherwise authorized by statute, cost must meet the following general criteria in order to be allowable under federal awards. Unallowable costs are either expenses that are unallowable by nature or unallowable activities.
- (2) **General Cost Allowability Criteria**. All costs expended under an applicable federal award must meeting the follow general criteria:
 - a. Be necessary and reasonable for the proper and efficient performance and administration of the federal program.
 - When determining whether a cost is necessary, consideration shall be given to:
 - Whether the cost is needed for the proper and efficient performance of the federal award;
 - Whether the cost is identified in the approved project budget or application;
 - Whether the cost aligns with identified needs based on results and findings from a needs assessment; and
 - 4. Whether the cost addresses project goals and objectives
 - ii. When determining reasonableness of cost, consideration shall be given to:
 - Whether the cost is the type generally recognized as ordinary and necessary for the proper and efficient performance of the federal award:
 - The restraints or requirements imposed by federal, state, and other laws and regulations and terms and conditions of the award;

- 3. Market prices for comparable goods or services for the geographic area;
- 4. Whether relevant individuals involved in the administration of the award acted with prudence under the circumstances; and
- Whether the County significantly deviates from its established practices and policies when incurring costs in ways that unjustifiably increase the award's cost.
- b. **Be allocable to the award.** A cost is allocable to the federal award if the goods and services involved are chargeable or assignable to the federal award relative to the benefit derived by the federal grant.
- c. Consistent with policies and procedures that apply uniformly to both federally-financed and other activities of the County.
- d. **Consistent treatment.** A cost cannot be assigned to a federal award as a direct cost if any other cost for the same purpose in like circumstances has been assigned as an indirect cost under another award.
- e. Adequately documented.
- f. Be determined in accordance with generally accepted accounting principles, unless provided otherwise by 2 CFR 200, Subpart E.
- (3) Allowable Costs Local Government-Wide Central Service Costs: If the County provides certain services to operating agencies on a centralized basis, a process is required whereby cost associated with the central service can be identified and assigned to the benefitted activities on a reasonable and consistent basis. The County must submit these costs to be allocated under the federal award, and such submissions shall meet the requirements of 2 CFR 200, Appendix V, paragraph D.
- (4) **Selected Items of Cost**. In addition to the basic guidelines, the following selected items of cost are generally allowable or unallowable as follows:

Amending the Clothing Allowance Policy

Whereas, the Montgomery County Employee Handbook details the policies for the employees of the County; and

Whereas, the Montgomery County Code of Ordinances, Chapter 36, details the polices of the County; and

Whereas, the County may require certain employees to wear county uniforms; and

Whereas, the County provides for financial allowances to employees required to wear and maintain county uniforms; and

Whereas, the Montgomery County Board of Commissioners finds that it is in the best interest of the County, its citizens, and employees, to amend the clothing allowance policy to detail the regulations regarding the county's clothing allowance and use policies.

Therefore, it is ordained, that certain sections of the Employee Handbook, Section 4.20, shall be amended to read as follows:

"§ 4.20 Uniform and Clothing Allowance.

A. Employees Eligible for Allowance. Employees of the Montgomery County Central Communications Center, Jail, Sheriff's Department, Probation Department, Emergency Management/Homeland Security, Highway Department or other Departments may be required to wear uniforms as defined by the IRS and/or clothing that meet federal, state, and local standards in both design, uniformity, and safety and thus will be provided a uniform and/or clothing allowance in conformity with the provision of this policy.

E. Internal Controls. The County Auditor shall process the clothing allowance through the County's payroll system and the uniform allowance through the accounts payable process.

A Department may choose to purchase clothing or uniforms on behalf of employees.

All other internal controls provisions adopted by the County shall be adhered to in the administration of this policy."

It is further ordained that certain sections of the Montgomery County Code of Ordinances, Section 36.37, shall be amended to read as follows:

"§ 36.37 Uniform and Clothing Allowance.

- B. Employees Eligible for Allowance. Employees of the Montgomery County Central Communications Center, Jail, Sheriff's Department, Probation Department, Emergency Management/Homeland Security, Highway Department or other Departments may be required to wear uniforms as defined by the IRS and/or clothing that meet federal, state, and local standards in both design, uniformity, and safety and thus will be provided a uniform and/or clothing allowance in conformity with the provision of this policy.
- F. Internal Controls. The County Auditor shall process the clothing allowance through the County's payroll system and the uniform allowance through the accounts payable process.

A Department may choose to purchase clothing or uniforms on behalf of employees.

All other internal controls provisions adopted by the County shall be adhered to in the administration of this policy."

It is further ordained that this ordinance shall become effective upon adoption.

It is further ordained that all other provisions of the Employee Handbook and the Code of Ordinances which are not specifically amended by this ordinance shall remain in full force and effect.
