The July 18, 2023, Montgomery County Council Meeting was held at 9:00 am at the Community Meeting Room of the Montgomery County Government Center. In attendance were Council President David Hunt and Council Members Jake Bohlander, Gary Booth, Brett Cating, Joyce Grimble, Steve Loy and Matt Nelson. Auditor Mindy Byers was present, along with Attorney Dan Taylor, Commissioner John Frey, and County Administrator Tom Klein.

- I. CALL TO ORDER: Council President Hunt called the meeting to order, followed by the Pledge of Allegiance and a prayer.
- II. CONSENT AGENDA: Council Member Nelson moved to approved consent agenda, including the claims from Peters Franklin and Taylor, Minnette, Schneider & Clutter, Q2 Commissary Report and Same-Series Transfer Report. Motion was seconded by Council Member Grimble. Motion carried 7-0.

- A. Council Member Cating moved to accept the transfer requests in the Statewide 911 and MCCCC funds from the Central Communications Center; this was seconded by Council Member Grimble. Motion carried 7-0.
- B. Council Member Loy moved to approve the transfer requests in the County General fund from the Jail. Motion was seconded by Council Member Nelson, and carried 7-0.
- C. Council Member Grimble moved to approve the transfer requests in the MVH Unrestricted fund for the Highway Department. This was seconded by Council Member Nelson; motion carried 7-0.
- D. Council Member Cating moved to accept the transfer requests in the County General fund from the Soil and Water Conservation District. Motion was seconded by Council Member Nelson, and carried 7-0.

V. NEW BUSINESS:

- A. Auditor Byers presented the Crawfordsville District Public Library's Board of Trustees' appointment request. The Board had requested that Owen Bennett be appointed to said board for a 4-year term. Council Member Booth moved to accept the Library Board's request and appoint Owen Bennett. This motion was seconded by Council Member Bohlander. Motion carried 7-0.
- B. Animal Welfare League attorney Kurt Homann had requested that the Council allocate \$4,000 from the spring Dog Tax collections of to the AWL. Auditor Byers reported that the current cash balance of the fund was \$5,368.90, and the office had received an inquiry regarding an animal kill reimbursement. Noting this, Council Member Booth moved to table the request until the next meeting. Motion was seconded by Councilman Bohlander, and carried 7-0.
- C. Sheriff Needham reported that a new dryer was needed at the Jail. He asked the Council's permission to pay for it out of the Commissary fund. A motion to approve the purchase was made by Council Member Booth; seconded by Council Member Bohlander. Motion carried 7-0.
- D. County Administrator Klein brought forward the ERPS Committee's recommendations from their latest meeting. Sheriff Needham had requested increases in the compensation matrix for the Sheriff's Merit deputies. The requested matrix is:

Sheriff Needham explained that retention and recruitment of officers becomes more and more

difficult each year due to increased salaries for them at all levels of government. The State Police had recently raised their base rate to \$70,000, so that just made the competition for interested and able recruits more intense. Administrator Klein reported that the ERPS Committee had made a favorable recommendation for the Sheriff's request. Council Member Loy moved to approve the Sheriff's request, effective the first pay of August. The motion was seconded by Council Member Nelson, and carried 7-0.

- E. A discussion was had regarding Wheel & Surtax rates for 2024. County Administrator Klein presented a report from Jeff Peters showing what various increase options would net. After some discussion, Attorney Taylor was asked to prepare the necessary paperwork to increase the charges for both to 75% of the maximum charge, to be considered at meetings in August.
- F. Auditor Byers requested that the Council determine dates for the 2024 Budget meetings. The Council decided that the internal budget presentation meetings would be held on August 29th and 30th at 6:00 p.m. in the Community meeting room. Also, that the 2024 Budget Hearing would be on Tuesday, September 12th and the Budget Adoption meeting would be on October 10th at the normal Council meeting time and location. Auditor Byers agreed to advertise accordingly.
- VI. OLD BUSINESS: None.

VII. REPORTS:

- A. Central Communications Director Sherri Henry reported that the office had been advertising job openings on the radio. She reported that some prospective employees had said that the County's health insurance costs were too high for them, so they had passed. She asked that it be taken into consideration in upcoming budget discussions.
- B. Chief Probation Officer Andria Geigle reported that there was currently an opening at in her office for a Probation Officer.
- C. Highway Director Jake Lough reported that there were 4 openings in that department.
- D. Sheriff Needham also reported that there were several openings in his department. He also reported that the Department had been participating in the CTE program for full and part time candidates, and encouraged other department heads to do the same, if possible.
- E. Auditor Byers reported that the SBOA had finished their audits and the exit conference would be on the 20th. She also reported personnel changes in the office and that during the hiring process had offered open positions to 3 qualified candidates who had turned them down due to pay.
- F. Council Member Booth shared the challenges facing the Redevelopment Commission. There have been 1,000 jobs added to our region, and he would like to see the County benefit from that via income tax. In order to do that there need to be available homes in our community, and that is a challenge that is being addressed.
- G. Council Member Grimble agreed with Booth and added that the growth in Boone County will also lead people to reside here, if it there is housing available.
- H. Commissioner Frey agreed with that, and noted that the County is realizing progress in housing developments, as there are several currently being planned and permitted.

VIII. PUBLIC COMMENT:

- A. Deantha Wright-Thornburg reiterated that the Council does have tough job in determining compensation for County employees. She asked that consideration be taken to increase starting wages, citing an example of a new employee making \$30,000 per year. She noted that often in County jobs the pay is well below the level of responsibility, and asked that the Council consider the level of responsibility in making fair determinations. Council President Hunt thanked her for her comments and reiterated that the plan is to budget a 4.9% increase across the board, in hopes that it helps with retention and recruitment.
