# MEETING MINUTES MONTGOMERY COUNTY COUNCIL MONTGOMERY COUNTY COMMISSIONERS January 9, 2024

The January 9, 2024, Montgomery County Council Meeting was held at 9:00 am at the Community Meeting Room of the Montgomery County Government Center. In attendance were Council Members David Hunt, Jake Bohlander, Gary Booth, Brett Cating, Joyce Grimble, Steve Loy and Matt Nelson. Auditor Mindy Byers, Commissioner John Frey, County Administrator Tom Klein and Attorney Dan Taylor were also present.

I. CALL TO ORDER: Council President Hunt called the meeting to order, followed by the Pledge of Allegiance and a prayer.

## II. CONSENT AGENDA:

- A. Council Member Bohlander moved to approve the consent agenda items, which included receipt and acceptance of the 4<sup>th</sup> Quarter Commissary Report from the Sheriff and the prior month's Same-Series Transfer report from the Auditor. The motion was seconded by Council Member Nelson, and carried 7-0.
- III. PUBLIC COMMENT ON AGENDA ITEMS: None.

## IV. ELECTION OF 2024 COUNCIL OFFICERS:

- A. Council Member Bohlander nominated David Hunt as Council President. This was seconded by Council Member Grimble. There were no other nominations; motion carried 7-0.
- B. Council Member Loy nominated Jake Bohlander as Council Vice President. This was seconded by Council Member Cating. There were no other nominations; motion carried 7-0.

A. Council Member Cating moved to approve all encumbrance requests. The motion was seconded by Council Member Nelson and carried 7-0.

## IX. NEW BUSINESS:

- A. Attorney Taylor presented Resolution 2024-1 Sheriff's Compensation Agreement. An annual agreement, formalizing the Sheriff's salary. A motion to approve Resolution 2024-1 was made by Council Member Booth, seconded by Council Member Loy. Motion carried 7-0.
- B. Attorney Taylor then presented Resolution 2024-2 Approving Attorney Engagement Letter. Another annual agreement, formalizing the new rate and terms of engagement. A motion to approve Resolution 2024-2 was made by Council Member Nelson, seconded by Council Member Loy. Motion carried 7-0.
- C. Attorney Taylor and Sheriff Ryan Needham presented Resolution 2024-3 Commissary Fund. This lists the Council-approved uses of the Sheriff's Commissary fund each calendar year. A motion to approve Resolution 2024-3 was made by Council Member Booth, seconded by Council Member Cating. Motion carried 7-0.
- D. Sheriff Needham informed the Council that South Montgomery Community School Corporation had requested a second School Resource Officer (SRO). As with other SRO arrangements, the Corporation would agree to reimburse the County for half of the SRO's salary and vehicle costs. The Sheriff asked the Council for a commitment of support, so that the School Corporation and Sheriff's department may move forward with arrangements for the officer. The Sheriff will present budget appropriation requests at the next meeting, since they had not yet been budgeted for 2024. A motion to support the School Corporation and Sheriff's request was made by Council Member Loy, seconded by Council Member Cating. Motion carried 7-0.
- E. Angela Swazay, Office Administrator for the Child Support Department informed the Council that their office had realized that one of the Deputy Prosecutor's salaries was not in line with all other Deputy Prosecutors. She wanted to explain that in order to fix the issue, an additional appropriation request would be presented at the next meeting. Mrs. Swazay wanted to clarify ahead of time that the upcoming request did not represent an actual change of salary for the employee.
- X. OLD BUSINESS: None.

## XI. REPORTS:

A. Funded Organization: None.

# B. Department Heads:

- 1. Highway Director Jake Lough reported that the department had received very competitive bids for the Community Crossing Grant. They came in at \$1.1million, which is below the estimated cost of the planned projects.
- 2. Chief Probation Officer Andria Geigle reported that the department had ordered a new vehicle in July of 2023, and they are still waiting for it. She will be requesting an additional appropriation at the next meeting since the new vehicle costs had not been budgeted for 2024.
- 3. County Administrator Tom Klein reported that the bid process had begun for the Purple Heart Parkway project and that the expansion project should be substantially completed by August.

## C. Elected Officials:

- 1. Commissioner John Frey reported that the latest Comprehensive Plan shows that lack of housing is a concern. Commissioner Frey reported that the READI 2 program could bring \$3million or more towards local residential upgrades. He also mentioned planned meetings between City leaders, Commissioners and Council in order to figure out how to work together to make the necessary things happen to comply with the READI program, among other items. Commissioner Frey also asked the Council for a motion of support to match funds for the Community Crossings Grant, which will be increasing next year. A motion to support the pursuit of these grants and make matching funds available was made by Council Member Booth, seconded by Council Member Grimble. Motion carried 7-0.
- 2. Auditor Mindy Byers reported that the department had completed Fall Settlement, which helped bring the cash balance in County General to the healthiest level it has been for years. She also reported that she had received and accepted the 1782 Notice from the Department of Local Government Finance; therefore, the 2024 Budget Order should be arriving soon.

# D. Councilors:

- 1. Several Council Members expressed their condolences to Council Member Loy due to the recent passing of his wife.
- 2. Council Member Grimble also congratulated Council Member Cating on his new radio
- Council Member Loy thanked the Council. He also reported that he plans to continue gathering data on the funding of the County's criminal justice team in order to help the Council move forward with more educated decisions.
