Environmental Safety

Environmental safety measures undertaken by the health department include septic inspections, mosquito control, animal bite testing, and bacteria testing for both drinking and swimming water.

Food Safety

The health department inspects all county food establishments, including schools, restaurants, convenience stores, festival booths, and farmer's market booths as needed or required by law.

Immunizations

Partnering with Christian Nursing Service (Well Baby Clinic), the health department provides childhood immunizations free of charge through the Indiana Vaccines for Children program. Adult vaccines are also available for a charge. We also provide tuberculosis tests, case management for latent and active tuberculosis cases, and flu clinics.

Vital Records

Birth and death records of all those who were born in or died in Montgomery County are kept at the health department. Copies of these records can be obtained with proper identification. We also provide corrections for records, paternity affidavits, and genealogy searches.

Public Health

Our mission as the Montgomery County Health Department is to better serve the community by providing public health services which promote and protect the health of the citizens of Montgomery County.

Services that are provided by the Health Department are as follows:

Community Preparedness

The health department works in conjunction with other first responder agencies to better protect the citizens of Montgomery County. The focus of the health department is particularly in the area of public health emergencies.

Disease Control

One of the goals of the health department is to detect, contain, and prevent disease in Montgomery County through health safety measures, education, and coordination with other agencies.

Testing services are provided for Private Wells, Public Water, Pools and Spas, Surface Ditch Water, Lakes/Bathing Beaches. We do a variety of quality control tests including Present/Absent Tests, Heterotrophic Plate Tests, and Quantitative Tests.



2013 Septic Report



Montgomery County saw a slight increase in new and repair permits for septic systems for 2013. Complaints related to septic systems were minimal. Waivers issued up slightly to 13. Waivers are issued to applicants who are adding on to their home and do not need to add on to a septic or are rebuilding on a lot where an approved septic already exists. This waiver is needed in order to obtain their building permit through the building department. It is important to note that 13 of the new systems were put in replacing old tank and tile systems.

In 2013 the following were issued by the Health Department * 42 New Permits * 28 Repair Permits * 9 Waivers

There were also *58 Installation Inspections and *89 Soil and Site evaluations performed.

There are approximately 50 to 55 species of mosquitoes found in the State of Indiana. Ten of these species transmit the above 5 diseases listed above. And several of these 10 species have been found in Montgomery County. We are fighting this battle through surveillance, larvaciding and adultaciding our communities. This year there were no instances of West Nile Virus reported.

Total Machine Hours Spraying Mosquito Adultacide.


