The October 8, 2019 Montgomery County Council Meeting was held at 9:00 am at the Montgomery County Courthouse. In attendance were Council President Terry Hockersmith, Councilmen Don Mills, Mark Davidson, Tom Mellish, and Mark Smith. Auditor Jennifer Andel and Attorney Rob Reimondo were present, as well as County Administrator Mark Casteel and Commissioner Attorney Dan Taylor.

- I. CALL TO ORDER: Council President Hockersmith called the meeting to order. This was followed by the Pledge of Allegiance, then a Prayer given by Councilman Mills.
- II. APPROVAL OF MINUTES: A motion to approve the September 10th, 25th and 26th minutes, as made by Councilman Mills, seconded by Councilman Mellish. Motion carried 5-0.
- III. PUBLIC COMMENT ON ANY AGENDA ITEMS: None

IV. 2020 WCSW BUDGET ADOPTION

- A. Council President Hockersmith opened the 2020 WCSW Budget Adoption at 9:08 a.m.
- B. A motion to adopt the 2020 WCSW Budget was made by Councilman Mills, seconded by Councilman Davidson. Motion carried 5-0.

V. 2020 CRAWFORDSVILLE LIBRARY BUDGET ADOPTION

- A. Council President Hockersmith opened the 2020 Crawfordsville Library Budget Adoption at 9:10 a.m.
- B. A motion to adopt the 2020 Crawfordsville Library Budget was made by Councilman Mellish, seconded by Councilman Smith. Motion carried 5-0.

- A. Council President Hockersmith opened the 2020 Montgomery County Budget Adoption at 9:13 a.m.

 - D. Treasurer Heather Laffoon reminded everyone the fall taxes are due by November 12, 2019. In addition to her office, you may pay at the local HHSB, Tri-County and First Financial banks.

 - A. Amber Reed, with the Health Department, announced they will be starting flu shot clinics this

- week and urged everyone to get their shot.
- B. Bryan Donaldson, with the Public Defender's Office, shared they have officially moved to the 3rd floor.

- A. Councilman Davidson asked when the clinic was expected to open in its new location. Auditor Andel replied that she heard it was slated for January or February 2020.
