[Resolution 2021-15](#): Resolution Approving Lease for Courthouse Annex - ***After conducting the 2nd public hearing the resolution provides that the proposed Lease with the building corporation, provides for fair and reasonable rent for the Courthouse Annex Lease***

[Courthouse Annex Lease](#) - ***The leased real estate is approximately 40,000 square foot renovated building to be used as a new courthouse annex with approximately 40 offices, meeting rooms and associated amenities include required surface parking lot. Lease terms of 20 years, beginning on the date that the building is acquired and ready for use and occupancy, and ending on the day prior to such date 20 years later.***

Final Reading: [Ordinance 2021-28](#): Electronic Participation Policy - ***Title III, Chapter 31 -***

Section 31.04 provides if Board members cannot physically be present at a meeting, the members may participate by telephone or other electronic means under the following conditions and limitations until a Declaration of Emergency. If there is no emergency then members may participate electronically so long as at least a quorum of the elected members may participate.

Final Reading: [Ordinance 2021-29](#): Establishing the 2021 Courthouse Annex Lease Fund - **Ordinance creates a new fund into which the LIT (Local Income Tax) revenues will be deposited and from which the rent payments will be made. The lease is for a maximum of 20 years and will have a maximum annual rent of \$440,000 with payments of rent beginning in July, 2022.**

Introduction: [Ordinance 2021-30](#): Adopting a Supplemental Workplace Injury Leave - **Ordinance would create section 36.37, Chapter 4 of the County Employee Handbook. Whether employees who are either injured during the course of their employment or become ill because of a work condition with a supplemental benefit which will allow such employees to receive their full compensation.**

Introduction: [Ordinance 2021-31](#): Amending the County's Right-of-Way Policies - Adds **Section 90.01 to the County Code for permits and establishes fees for permits. Work commenced without a permit to the section's emergency provisions, will result in the imposition of fines.**

Resolutions

[Resolution 2021-16](#): Approving American Rescue Plan - **United States Department of Treasury has allocated the sum of \$7,446,707 to Montgomery County from the Coronavirus State and Local Fiscal Recovery Funds established by the American Rescue Plan Act of 2021. Montgomery County has received a portion of these funds to be used to eligible costs. Montgomery County is required to develop, adopt and implement a plan for the use of these funds which complies with the guidance from the Dept of Treasury. Water Infrastructure: \$5,000,000 for the extension of water infrastructure to rural areas which are underserved in order to provide clean drinking water and other water services. This extension will be from existing water service infrastructure along Nucor Road, extending south on Nucor Road and west from Nucor Road along Comfort Drive; Replacement of Lost Public Sector Revenue: An amount up to \$2,246,707 to replace lost public sector revenues which will be used to provide government services. Address Negative Economic Impacts: Amount of up to \$200,000 to address negative economic impacts caused by public health emergency. Funds will be granted to small businesses, impacted industries, and not for profit organizations which suffered negative economic impacts caused by the COVID-19 crisis.**

Board President Commissioner Frey led the pledge of allegiance and Commissioner Dan Guard led the prayer.

Christopher B. Burke Engineering – Professional Services Proposal for MHMP Grant

Commissioner Guard moved to approve the consent agenda. Seconded by Commissioner Frey.

Motion passed 2-0 votes in favor.

NEW BUSINESS

Authorization to Purchase Paver & Secure Financing

Highway Director Jake Lough stated the total cost of the 2021 BF300 Paver is \$210,824. The new paver will replace the current paver which was purchased in 1991. Commissioner Guard moved to authorize the purchase and financing for the 2021 BF300 Paver. Seconded by Commissioner Frey. Motion passed 2-0 votes in favor.

Memorandum of Understanding – BOC + Wiley-Connell, LLC + Tempur Production USA, LLC

The memorandum memorializes the agreement between Tempur Production, Montgomery County Commissioners and Wiley-Connell, LLC in regards to the 196.827 acres of real estate along the north side of CR200 S (newly named Comfort Drive. *Commissioner Guard moved to approve the Memorandum of Understanding as presented. Seconded by Commissioner Guard. Motion passed 2-0 votes in favor.*

Building Corporation Appointments for Courthouse Annex Project

Commissioner Guard moved to appoint Jim Johnson, Aaron Morgan and Greg Morrison to the Courthouse Annex Project Building Corporation. Seconded by Commissioner Frey. Motion passed 2-0 votes in favor.

Amendment to Indiana American Water Company Agreement

Attorney Taylor advised that the amendment provides for the financing to extend the water line down Nucor Road to Comfort Drive and to install a water tower. *Commissioner Guard moved to approve the Amendment to Indiana American Water Company Agreement. Seconded by Commissioner Frey. Motion passed 2-0 votes in favor.*

Intergovernmental Agreement between Putnam County & Montgomery County

Montgomery County's Engineer will perform 8 hours of engineering duties for Putnam County. *Commissioner Guard moved to approve the Intergovernmental Agreement between Putnam County and Montgomery County. Seconded by Commissioner Frey. Motion passed 2-0 votes in favor.*

ORDINANCES

Final Reading: Ordinance 2021-27: Ordinance Amending County Code Regarding Health Department
Senate Enrolled Act 5 (2021) modified the emergency powers, appointment powers, removal powers and other powers of the local Health Department. The Board of County Commissioners are required to develop an appeal procedure which relates to the appeal of orders made by the Local Health Officer related to any public health emergency or disaster emergency. *Commissioner Guard moved to approve on final reading Ordinance 2021-27. Seconded by Commissioner Frey.* Health Administrator Amber Reed commented, "the proposed Ordinance 2021-27 is not a new concept to modify the duties and responsibilities of the Health Department. The timing has stirred up emotions given the recent statement by the Commissioners and their position on mask mandates." Carolyn Snider, Health Board member reiterated Ms. Reed's comment that the duty of the Health Department is to keep the community safe and informed. Nancy Sennett, Health Board member stated, "the Health Department has the support of the Health Board and the Health Officers. Ms. Sennett applauded the dedication of the employees of the Health Department. Elizabeth Justice stated, "I was appalled to say the decision to mask is an individual one." Janet Rucker stated she is a retired Dentist and she sees the need for everyone to be wearing masks given that Montgomery County is now #1 in the state as far as numbers. Marilou Daywalter stated that she is "only reading what she sees in the paper. Perception is that Dr. Douglas is not doing his job?" Leslie Hedge stated her concern over children and the more cases that the County is having and everyone should be wearing masks. Hearing no further comment - *Motion passed 2-0 votes in favor.*

Introduction: Ordinance 2021-28 – Electronic Participation Policy

Ordinance amends Title III, Chapter 31 by adding Section 31.04 regarding Electronic Participation. If a Commissioner cannot be physically present at a meeting, the member may participate by telephone or other electronic means under two limitations: Declaration of Emergency or No emergency as long as at least a quorum of the elected members is present in person at the meeting.

Introduction: Ordinance 2021-28 – Establishing Courthouse Annex Lease Fund

Ordinance establishes a fund for the annex office building lease rental payments that will be paid from Local Income Tax revenues by Montgomery County. The revenues are committed for the rest obligations of the Board under its lease with the Building Corporation.

RESOLUTIONS

Resolution 2021-12: Approving Lease for Courthouse Annex

Resolution approves financing of the acquisition of the project by the Building Corporation and the leasing of the same to Montgomery County. *Commissioner Guard moved to approve the Resolution 2021-12. Seconded by Commissioner Frey. Motion passed 2-0 votes in favor.*

Resolution 2021-13: Authorizing Lease of County Farm, Authorizing Solicitation of Bids, Appointing Appraisers & Approving Form of Lease

Resolution stated that the County Farm should be leased and that the Auditor should publish notice for the solicitation of bids for leasing the County Farm. Resolution also appoints Building Administrator Marc Bonwell and Assessor Sherri Bentley as appraisers to determine the fair rental value of the County Farm and approve the form lease which is attached to the Resolution. The lease would be awarded in November. The current lease is 3 years, the bidders can propose a different term. *Commissioner Guard moved to approve the Resolution 2021-13. Seconded by Commissioner Frey. Motion passed 2-0 votes in favor.*

OTHER BUSINESS

Commissioner Frey stated, "I appreciate you guys coming in and sorry about the perception. They have always had the commissioners' support. Commissioner Guard stated, "the purpose was for clarity more than anything."

ADJOURNMENT

There being no further business before the Board, *Commissioner Guard moved to adjourn. Commissioner Frey seconded. Motion passed 2-0 votes in favor.*

(“St. Vincent”), and County of Montgomery HSA Plan (“Montgomery HSA”) (hereinafter individually a *Party* or collectively, the *Parties*).

RECITALS

1. Whereas, Mr. Powell was involved in a traffic accident on or about April 14, 2019 and, as a result of the accident, received services or otherwise incurred debts owed to St. Vincent and Montgomery HSA;
2. Whereas, Mr. Powell received \$25,000 in settlement funds as a result of that accident to which St. Vincent and Montgomery HSA secured appropriate liens;
3. Whereas, after paying attorneys’ fees, Mr. Powell’s remaining settlement funds total \$14,595.44. Mr. Powell filed a *Complaint in Interpleader Action* in the Montgomery County Circuit Court under Cause No. 54C01-2007-MI-000542 requesting the court to distribute those remaining funds to the secured Parties (the *Settled Dispute*);
4. Whereas, Mr. Powell received services or otherwise incurred debts owed to other providers; however, those providers did not pursue debts owed through the above referenced legal action;
5. Whereas the Parties to this *Settlement Agreement* have agreed to distribute those remaining settlement funds amongst themselves as further detailed in this *Settlement Agreement*;
6. No Party to this *Settlement Agreement* has assigned, transferred, or granted, or purported to assign, transfer or grant, any of the claims, demands, or cause or causes of action disposed of by this *Settlement Agreement*, including any claims, demands, or cause or causes of action that could have been asserted;
7. The Parties wish to release one another from any and all claims, causes of action, damages, costs, expenses, and compensation whatsoever, past, present and future, they may have against one another, however arising and of whatsoever kind or character, whether asserted or could have been asserted at any time up to and including the Effective Date of this *Settlement Agreement*;

NOW, THEREFORE, in consideration of the mutual understandings and covenants and the releases contained herein and intending to be legally bound hereby, the Parties hereby voluntarily agree as follows:

AGREEMENT

1. **Incorporation of Recitals.** The recitals set forth above are incorporated into this *Settlement Agreement*.
2. **Denial of Liability.** This *Settlement Agreement* constitutes the full settlement of disputed claims. Nothing contained in this *Settlement Agreement* shall constitute any admission of liability between the Parties or any admission or renunciation as to the truth of any allegations and each Party expressly denies the allegations or claims of the other.
3. **Settlement Payment.** Within 30 days of the Effective Date of this *Settlement Agreement*, Mr. Powell shall pay St. Vincent \$7,000.00 and Montgomery HSA \$2,595.00 (the *Settlement Amounts*).
4. **Release of Liability.** In exchange for the *Settlement Amounts* the Parties promise:
 - 4.1. **Mr. Powell**, fully releases St. Vincent and Montgomery HSA and all their known or unknown, past, present, and former members, officers, employees, successors, and agents from liability for any injuries, damages, or costs allegedly incurred by Mr. Powell as a result of, related to, or arising from the claims regarding the *Settled Dispute*.
 - 4.2. **St. Vincent**, fully releases Mr. Powell, and all its known or unknown, present and former members, officers, employees, successors, and agents from liability for any injuries, damages, or costs alleged incurred by St. Vincent as a result of, related to, or arising from the claims regarding the *Settled Dispute*.
 - 4.3. **Montgomery HSA**, fully releases Mr. Powell, and all its known or unknown, present and former members, officers, employees, successors, and agents from liability for any injuries, damages, or costs alleged incurred by Montgomery HSA as a result of, related to, or arising from the claims regarding the *Settled Dispute*.
5. **Consideration.** The Parties agree that the consideration set forth in this *Settlement Agreement* is sufficient, valuable, good, and material consideration.
6. **Agreement Effectuation.** The Parties agree that they will execute any and all documents necessary to effectuate the terms and conditions of this *Settlement Agreement*.
7. **General Representations and Warranties of the Parties.** The Parties represent, warrant, covenant, and acknowledge to each other, in order to induce the other Parties to enter into this *Settlement Agreement*, and the Parties each acknowledge that the other Parties are reasonably relying upon such representations, warranties, covenants, and acknowledgements as a material inducement to execution of this *Settlement Agreement*:
 - 7.1. Mr. Powell, Montgomery HSA, and St. Vincent, and all other persons or entities that could make claims by or through them have not, in whole or in part sold, assigned, transferred, conveyed, or made any other disposition of any cause of action, claim, counterclaim, demand, right, obligation, interest, shares, or damages

released or covered herein;

7.2. Mr. Powell, Montgomery HSA, and St. Vincent represent that, regarding the actions required of them by this *Settlement Agreement*, they collectively have the sole right and exclusive authority to execute this *Settlement Agreement*; and

7.3. Mr. Powell, Montgomery HSA, and St. Vincent each have had a full and fair opportunity to review the terms and conditions of this *Settlement Agreement* and to consult with legal counsel of its choice concerning the legal effect and consequences of entering into this *Settlement Agreement*. This *Settlement Agreement* is entered into by the Parties freely and voluntarily, with and upon advice of counsel.

8. **Cost and Fees.** The Parties shall bear their own costs and fees, including attorney's fees.

9. **Entire Agreement and Assignability.** This *Settlement Agreement* contains the entire agreement between the Parties with regard to the matters set forth herein and shall not be assigned by any Party without written consent from all other Parties. This *Settlement Agreement* replaces and supersedes all prior agreements, understandings, and undertakings with respect to their subject matters, by and among the Parties. This *Settlement Agreement* further supersedes all prior written and oral statements by and among the Parties, and no representation, statement, or condition or warranty not contained in this *Settlement Agreement* will be binding on the Parties or have any force or effect whatsoever.

10. **Knowledge and Understanding.** Each Party acknowledges that such Party has consulted with such Party's own attorney to the extent that the Parties are represented and has had adequate reasonable time to evaluate this *Settlement Agreement*. Each Party further acknowledges that such Party is fully aware of such Party's rights, or has been afforded the opportunity to seek qualified legal counsel relating to each Party's rights, has knowingly and voluntarily waived those rights, and has carefully read and fully understands all the provisions of this *Settlement Agreement*.

11. **Non-Waiver.** The waiver by either Party of a breach or violation of any provision of this *Settlement Agreement* shall not operate as or be construed to be a waiver of any subsequent breach or violation hereof.

12. **Applicable Law and Jurisdiction.** The Parties agree that this *Settlement Agreement* is deemed made and entered into in the State of Indiana and in all respects shall be interpreted, enforced and governed under the laws of the State of Indiana, unless otherwise preempted by federal law and without regard to choice of law or conflicts of law principles.

13. **Venue.** Any action taken by the Parties to enforce, interpret, or determine or declare the rights of the Parties relating to the terms of this *Settlement Agreement* shall be brought and determined in the state or federal courts located in Montgomery County, State of Indiana, and each Party hereby consents to the personal jurisdiction of such courts and waives any objection relating to the lack of personal jurisdiction, improper venue, and/or based on the defense of *forum non-*

conveniens.

14. **Enforcement Fees.** If any lawsuit or action is initiated to interpret or enforce the provisions of this *Settlement Agreement*, to rescind this *Settlement Agreement*, to seek relief as a result of a breach of this *Settlement Agreement*, or otherwise legally or equitably with respect to the subject matter of this *Settlement Agreement*, the Prevailing Party shall be entitled to recover, in addition to costs, reasonable attorneys' fees incurred in the preparation, prosecution, or defense of such lawsuit or action as determined by the court, and if any appeal is taken from such decision, reasonable attorneys' fees as determined on appeal. The term *Prevailing Party* shall include, but not limited to, the circumstance where a Party obtains legal counsel or brings an action against the other Party by reason of that Party's breach or default and obtains substantially the relief sought whether compromise, settlement, or judgment.

15. **Severability.** The sections of this *Settlement Agreement* are severable, and the unenforceability of any section shall not affect the validity or enforceability of such other sections.

16. **Counterparts.** This *Settlement Agreement* may be executed in separate counterparts, each of which when so executed shall be an original, but all of such counterparts shall together constitute but one and the same instrument.

17. **Rules of Construction.** Each of the Parties hereto has revised, or requested revisions to, this *Settlement Agreement*. Any ambiguities are not to be resolved against any Party hereto as a drafter of this *Settlement Agreement*. The titles and subheadings of this *Settlement Agreement* are for ease of reference only and are not intended to create or alter the substantive terms of this *Settlement Agreement*.

PLEASE READ CAREFULLY. THE FOREGOING *SETTLEMENT AGREEMENT* AND GENERAL RELEASE INCLUDES A RELEASE OF ALL KNOWN AND UNKNOWN CLAIMS, EXCEPT AS OTHERWISE SPECIFICALLY PROVIDED HEREIN.

1.2 Statements of work will be written documents setting forth at a minimum:

- a. A complete, sufficiently detailed description of the types of services to be rendered.
- b. The applicable billing rates for the services to be rendered (service fees).
- c. Any additional terms and conditions to which the parties may agree.

1.3 The parties contemplate that it may be desirable to make changes to the statement(s) of work. Before performing any work associated with any such change, a written change order shall set forth the necessary revisions to the statement(s) of work, and the parties, shall agree in writing that such work constitutes a change from the original statement of work, as amended, and that they further agree to the change provisions set forth in the change order. Each change order shall be numbered serially and executed by Blu4 and MEMA.

1.4 Executive staff of Blu4 and MEMA will review the status of the services, statement(s) of work, change orders, invoices and estimates as may be required. A written status report will be produced regarding the review. Blu4 and MEMA agree to execute and maintain copies of these status reports.

Obligations

2.1 Blu4 will provide other support services as both the company and MEMA subsequently agree.

Services and Fees and Expenses

3.1 MEMA shall be responsible for all service fees as identified in the applicable statement(s) of work (and change orders, as applicable) as those services are provided.

3.2 Blu4 will invoice MEMA for the service fees once per calendar month (on or about the 15th of each month). MEMA agrees to remit full payment to accounts payable promptly upon its receipt of the invoice.

Term and Termination

4.1 This agreement shall commence as of the agreement date above and shall remain in force through 12/01/2022 or completion of the Active Shooter Exercise Series.

Proprietary Rights: Confidential information

5.1 Blu4 agrees that the work products from the services provided to MEMA shall be owned by MEMA. Nothing contained in this section 5.1 shall be construed as prohibiting Blu4 from utilizing in any manner, knowledge and experience of a general nature acquired in the performance of services for MEMA.

5.2 Confidential information includes all information identified by a disclosing party as proprietary and confidential, which confidential information shall remain the sole property of the disclosing party unless the ownership of such confidential information is otherwise expressly set forth in the agreement. Items will not be considered confidential information if: (a) available to public other than by a breach of an agreement by the recipient; (b) rightfully received from a third party not in breach of any obligation of any confidentiality; (c) independently developed by one party without access to the confidential information of the other; or (d) rightly known to the recipient at the time of disclosure as verified by its written records.

5.3 Each party agrees that it shall not use for any purpose or disclose to any third party any confidential information of the other party without the express written consent of the other party. Each party agrees to safeguard the confidential information of the other party against use or disclosure other than as authorized by or pursuant to this agreement through measures, and exercising a degree of care, which are at least as protective as those, Blu4 or MEMA, as the case may be, exercises in safeguarding the confidentiality of its own proprietary information, but no less than a reasonable degree of care under the circumstances. Each party shall permit access to the confidential information of the other party only to those individuals (a) who have entered into a written nondisclosure agreement with the other party on terms equally as restrictive as those set forth herein, and (b) who require access in performance of their duties to the other party in connection with the other party's rights under this agreement.

5.4 Each party acknowledges that the wrongful use or disclosure of confidential information of the other party may result in irreparable harm for which there will be no adequate remedy at law. In the event of a breach by the other party or any of its officers, employees or agents of its or their obligations under this Section 5, the non-breaching party may immediately terminate this agreement without liability to the other party, and may bring an appropriate legal action to enjoin such breach, and shall be entitled to recover from the breaching party reasonable legal fees and cost in addition to other appropriate relief.

Warranties

6.1 Blu4 warrants that the services to be provided under this agreement shall be performed in a professional manner conforming to generally accepted industry standards and practices. MEMA agrees that Blu4's sole and exclusive obligation with respect to the services covered by this limited warranty shall be, at Blu4's sole discretion, to correct the nonconformity or to refund the service fees paid for the affected executive consulting services.

General Provisions

7.1 The relationship of MEMA and Blu4 is that of independent contractors. Personnel of both parties are neither agents nor employees of the other party for federal tax purposes or any other purpose whatsoever, and are not entitled to any employee benefits of the other party.

7.2 No delay, failure or default in performance of any obligation by either party, excepting all obligations to make payments hereunder, shall constitute a breach of this agreement to the extent caused by force majeure.

7.3 Any assignment in violation of these terms is void.

7.4 Any controversy or claim arising out of or relating to this agreement, or the breach thereof, shall be conclusively resolved through binding arbitration under the Commercial Arbitration Rules of the American Arbitration Association. Judgment on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof. Each party shall bear its own costs and attorney fees, unless the arbitration award specifically provides otherwise.

7.5 All communications between the parties with respect to any of the provisions of this agreement shall be in writing, and shall be sent by personal delivery, airmail or e-mail to MEMA or to Blu4 as set forth in the preamble of this agreement, until such time as either party provided the other not less than ten (10) days prior written notice of a change of address in accordance with these provisions.

7.6 The validity of this agreement and the rights, obligations and relations of the parties hereunder shall be construed and determined under and in accordance with the laws of the state of IN; provided, however, that if any provision of the agreement is determined by a court of competent jurisdiction to be in violation of any applicable law or otherwise invalid or unenforceable, such provision shall to such extent as it shall be determined to be illegal, invalid or unenforceable under such law be deemed null and void, but this agreement shall otherwise remain in full force. After arbitration, as specified in Section 7.4, any suit to enforce any provision of this agreement, or any right, remedy or other matter arising from the arbitration, will be brought exclusively in the state or federal courts located in IN. Blu4 and MEMA agree and consent to the venue in and to the in-person jurisdiction of the aforementioned courts.

7.7 Any modification or amendment of any provision of this agreement must be in writing and bear the signature of the duly authorized representatives of both parties. The failure of any party to enforce any right it is granted herein or to require the performance by the other party hereto of any provision of this agreement, or the waiver by any party of any breach of this agreement, shall not prevent a subsequent exercise or enforcement of such provisions or be deemed a waiver of any subsequent breach of this agreement. All provisions of this agreement which by their own terms take effect upon the termination of this agreement or by their nature survive termination (including without limitation the provisions of Sections 3, 5, 6, 7) shall survive such termination.

7.8 This agreement, all attached schedules and all other agreements referred to herein or to be delivered by the parties pursuant hereto, represents the entire understanding and agreement between the parties with respect to the subject matter hereof, and merges all prior discussions between them and supersedes and replaces any and every other agreement or understanding which may have existed between the parties to the extent that any such agreement or understanding relates to providing services to MEMA. MEMA hereby acknowledges that it has not reasonably relied on any other representation or statement that is not contained in this agreement or made by a person or entity other than Blu4. To the extent, if any, that the terms and conditions of MEMA's orders or other correspondence are inconsistent with this agreement, this agreement shall control.

LEASE AGREEMENT

THIS LEASE AGREEMENT ("Lease") entered into this _____ day of _____, 2021, between the MONTGOMERY COUNTY BUILDING CORPORATION, an Indiana corporation ("Lessor"), and MONTGOMERY COUNTY, INDIANA, a political subdivision existing under the laws of the State of Indiana ("Lessee" or "County"),

WITNESSETH THAT:

WHEREAS, the Lessor has been organized under the Indiana Non-Profit Corporation Act of 1991 and in pursuance of the provisions of Indiana Code 5-1-14 and Indiana Code 36-1-10 for the purpose of acquiring a site or sites, constructing, renovating, expanding and equipping governmental buildings, including acquisition of an approximately 40,000 square foot renovated building to be used as a new courthouse annex with approximately 40 offices, meeting rooms and associated amenities, including required surface parking, together with all necessary appurtenances, related improvements and equipment, including acquiring land, existing building or buildings and demolition thereof, constructing, renovating, improving, or expanding the same, leasing governmental facilities, including a building or buildings to be used as a new courthouse annex facility for the County any other reasonably related costs; and

WHEREAS, the annual rentals to be paid under the Lease by the Lessee will be derived from an ad valorem property tax levied on all property taxpayers in the County;

1. Premises, Term and Warranty. The Lessor does hereby lease, demise and let to Lessee the real estate in the County more particularly described in Exhibit A attached hereto and made a part hereof, and an approximately 40,000 square foot renovated building to be to be used

as a new courthouse annex with approximately 40 offices, meeting rooms and associated amenities, including required surface parking, together with all necessary appurtenances, related improvements and equipment to be acquired by Lessor constructed according to plans and specifications prepared by engineers employed by the Lessee ("Leased Premises").

TO HAVE AND TO HOLD the Leased Premises with all rights privileges, easements and appurtenances thereunto belonging, unto Lessee, for a term of twenty (20) years, beginning on the date on which the building is acquired and ready for use and occupancy, and ending on the day prior to such date twenty (20) years thereafter. However, the term of this Lease will terminate at the earlier of: (a) the exercise by the Lessee of the option to purchase the Leased Premises and the payment of the option price; or (b) the payment or defeasance of all bonds issued: (i) to finance the cost of the Leased Premises; (ii) to refund such bonds; (iii) to refund such refunding bonds; or (iv) to improve the Leased Premises. The date the Leased Premises are acquired and ready for use and occupancy shall be endorsed on this Lease at the end hereof by the parties hereto as soon as the same can be done after such completion, and such endorsement shall be recorded as an addendum to the Lease. The Lessor hereby represents that it is possessed of, or will acquire, a good and indefeasible estate in fee simple to the above-described real estate, and Lessor warrants and will defend the same against all claims whatsoever not suffered or caused by the acts or omissions of Lessee or its assigns.

1. Rental Payments. The Lessee agrees to pay rental for the Leased Premises at the rate of \$440,000 per year during the term of the Lease. The first rental installment shall be due on the day that the Leased Premises are acquired and ready for use and occupancy or July 1, 2022, whichever is later. If the Leased Premises is available later than July 1, 2022, the first

rental payment shall be in an amount calculated at the annual rate from the date of payment to the next January 1 or July 1. Thereafter, rental shall be payable in advance in semiannual installments of \$220,000 on January 1 and July 1 of each year. The last semiannual rental payment due before the expiration of this Lease shall be adjusted to provide for rental at the annual rate specified above from the date such installment is due to the date of the expiration of this Lease.

All rentals payable under the terms of this Lease shall be paid by the Lessee to the bank selected as Trustee ("Trustee") under the Trust Indenture between it and the Lessor ("Indenture") or to such other bank or trust company as may from time to time succeed such bank as Trustee under the Indenture securing the bonds to be issued by the Lessor to finance the acquisition of the Leased Premises. All payments so made by the Lessee shall be considered as payment to the Lessor of the rentals payable hereunder. The bank selected as Trustee shall be endorsed on this Lease at the end hereof by the parties hereto as soon as the same can be done after selection, and such endorsement shall be recorded as an addendum to this Lease. The date the Leased Premises is acquired and ready for use and occupancy shall be endorsed on this Lease at the end hereof by the parties hereto as soon as the same can be done after such acquisition, and such endorsement shall be recorded as an addendum to this Lease.

After the sale of the bonds issued to finance the acquisition of the Leased Premises, the annual rental amount provided for in the first paragraph of this Section 2 shall be reduced to an amount equal to the multiple of \$1,000 next higher than the sum of principal and interest due on such bonds in each twelve-month period ending on any bond payment date (bond year) plus a maximum of Five Thousand Dollars (\$5,000), payable in semiannual installments. Such amount

of reduced annual rental shall be endorsed on this Lease at the end hereof by the parties hereto as soon as the same can be done after the sale of said bonds and such endorsement shall be recorded as an addendum to this Lease.

2. Additional Rental Payments. The Lessee shall pay as further rental for the Leased Premises all taxes and assessments levied against or on account of the Leased Premises and/or the receipt of lease rental payments. Any and all such payments shall be made and satisfactory evidence of such payments in the form of receipts shall be furnished to the Lessor by the Lessee, at least three (3) days before the last day upon which the same must be paid to avoid delinquency. In case the Lessee shall in good faith desire to contest the validity of any such tax or assessment, and shall so notify the Lessor, and shall furnish bond with surety to the approval of the Lessor conditioned for the payment of the charges so desired to be contested and all damages or loss resulting to the Lessor from the nonpayment thereof when due, the Lessee shall not be obligated to pay the same until such contests shall have been determined. The Lessee shall pay as further rental the amount calculated by or for Lessor as the amount required to be rebated or paid as a penalty in lieu of rebate to the United States Treasury, after taking into account other available moneys, to prevent the first mortgage bonds issued to finance the acquisition and construction of the Leased Premises from becoming arbitrage obligations under Section 148 of the Internal Revenue Code of 1986, as amended.

3. Abatement of Rent. In the event the Leased Premises shall be partially or totally destroyed, whether by fire or any other casualty, or are taken under the exercise of the power of eminent domain, so as render them unfit, in whole or part, for use or occupancy by the Lessee, it shall then be the obligation of the Lessor to restore and rebuild the Leased Premises as promptly

as may be done, unavoidable strikes and other causes beyond the control of the Lessor excepted; provided, however, that the Lessor shall not be obligated to expend on such restoration or rebuilding more than the amount of the proceeds received by the Lessor from the insurance provided for in Section 6 hereof or the condemnation proceeds received by the Lessor, whichever is applicable.

If there is in force on the date of partial or total destruction or taking insurance on the Leased Premises and the rental value thereof, in accordance with the provisions of Section 6 hereof, the rent shall be abated for the period during which the Leased Premises or any part thereof are unfit or unavailable for occupancy and shall be in proportion to the percentage of floor area which is unfit or unavailable for occupancy.

4. Maintenance, Alterations and Repairs. The Lessee assumes all responsibility for maintenance, repairs and alterations to the Leased Premises. At the end of the term, Lessee shall deliver the Leased Premises to Lessor in as good condition as at the beginning of the term, reasonable wear and tear only excepted. Equipment or other personal property which becomes worn out or obsolete may be discarded or sold by Lessee. The proceeds of the sale of any personal property shall be paid to the Trustee. Lessee may trade in any obsolete or worn out personal property on replacement property which replacement property will belong to Lessee upon payment to the Trustee of an amount equal to the trade-in value of such property. Lessee need not replace worn out or obsolete personal property, but may replace such property at its own expense, and the replacement property shall belong to Lessee.

5. Insurance. Lessee, at its own expense, will, during the full term of the Lease, keep the Leased Premises insured against physical loss or damage, however caused, with such

exceptions as are ordinarily required by insurers of buildings or facilities of a similar type, with good and responsible insurance companies acceptable to Lessor. Such insurance shall be in an amount equal to one hundred percent (100%) of the full replacement cost of the Leased Premises as certified by a registered architect, registered engineer or professional appraisal engineers, selected by the Lessor, on the effective date of this Lease and on or before the first day of April of each year thereafter. Such appraisal may be based upon a recognized index of conversion factors. During the full term of this Lease, Lessee will also, at its own expense, maintain rent or rental value insurance in amount equal to the full rental value of the Leased Premises for a period of two (2) years against physical loss or damage of the type insured against pursuant to the preceding requirements of this clause. During the full term of this Lease, Lessee will also, at its own expense, carry combined bodily injury insurance, including accidental death, and property damage with reference to the Leased Premises in an amount not less than Three Million Dollars (\$3,000,000) on account of each occurrence with one or more good and responsible insurance companies. The public liability insurance required herein may be by blanket insurance policy or policies.

The proceeds of the public liability insurance required herein (after payment of expenses incurred in the collection of such proceeds) shall be applied toward extinguishment or satisfaction of the liability with respect to which such insurance proceeds are paid. Such policies shall be for the benefit of persons having an insurable interest in the Leased Premises and shall be made payable to the Lessor or to such other person or persons as the Lessor may designate. Such policies shall be countersigned by an agent of the insurer who is a resident of the State of Indiana, and such policies (or certificates of insurance for each policy) and the certificate of the

architect or engineer hereinbefore referred to shall be deposited with the Lessor. If, at any time, the Lessee fails to maintain insurance in accordance with this Section, such insurance may be obtained by the Lessor and the amount paid therefor shall be added to the amount of rental payable by the Lessee under this Lease; provided, however, that the Lessor shall be under no obligation to obtain such insurance and any action or non-action of the Lessor in this regard shall not relieve the Lessee of any consequence of its default in failing to obtain such insurance, including its obligation to continue the rental payments in case of total or partial destruction of the building as provided in Section 4 hereof.

6. Eminent Domain. If title to or the temporary use of the Leased Premises, or any part thereof, shall be taken under the exercise of the power of eminent domain by any governmental body or by any person, firm or corporation acting under governmental authority, any net proceeds received from any award made in such eminent domain proceedings (after payment of expenses incurred in such collection) shall be paid to and held by Lessor.

Such proceeds shall be applied in one or more of the following ways:

(a) The restoration of the Leased Premises to substantially the same condition as it existed prior to the exercise of said power of eminent domain, or

(b) The acquisition, by construction or otherwise, of other improvements suitable for the Lessee's operations on the Leased Premises and which are in furtherance of the purposes of Indiana Code, Title 36, Article 1, Chapter 10 (which improvements shall be deemed a part of the Leased Premises and available for use and occupancy by the Lessee without the payment of any rent other than as herein provided, to the same extent as if such other improvements were specifically described herein and demised hereby).

Within ninety (90) days from the date of entry of a final order in any eminent domain proceedings granting condemnation, the Lessee shall direct Lessor in writing as to which of the ways specified in this Section the Lessee elects to have the net proceeds of the condemnation award applied. Any balance of the net proceeds of the award in such eminent domain proceedings not required to be applied for the purposes specified in subsections (a) or (b) above shall be deposited by Lessor in the Sinking Fund held by the Trustee under the Indenture.

Lessor shall cooperate fully with the Lessee in the handling and conduct of any prospective or pending condemnation proceedings with respect to the Leased Premises or any part thereof and will to the extent it may lawfully do so permit the Lessee to litigate in any such proceedings in its own name or in the name and on behalf of the Lessor. In no event will Lessor voluntarily settle or consent to the settlement of any prospective or pending condemnation proceedings with respect to the Leased Premises or any part thereof without the written consent of the Lessee, which consent shall not be unreasonably withheld.

7. General Covenants. The Lessee shall not assign this Lease or sublet the Leased Premises herein described without the written consent of Lessor. Lessee shall use and maintain the Leased Premises in accordance with the laws and ordinances of the United States of America, the State of Indiana, and all other proper governmental authorities. The Lessee covenants that in any contracts entered into by the Lessee providing for the use of the Leased Premises, which involve the conduct of a separate trade or business, (a) the Leased Premises would be used only (i) by a Governmental Unit within the meaning of Section 141 of the Internal Revenue Code of 1986 or (ii) by non-Governmental Units on the same basis as other members of the general

public or (b) would not in the aggregate result in payments to the Lessee in an amount in excess of 5% of the principal of and interest on the first mortgage bonds issued under the Indenture.

8. Option to Renew. Lessor hereby grants to Lessee the right and option to renew this Lease for a further like or lesser term upon the same or like conditions as herein contained, and applicable to the portion of the premises for which the renewal applies, and Lessee shall exercise this option by written notice to Lessor given upon any rental payment date prior to the expiration of this Lease.

9. Option to Purchase. Lessor hereby grants to Lessee the right and option, on any rental payment date, upon sixty (60) days' written notice to Lessor, to purchase the Leased Premises at a price equal to the amount required to enable Lessor to liquidate by paying all indebtedness, including all premiums payable on the redemption thereof and accrued and unpaid interest and by paying the expenses and charges of liquidation. In no event, however, shall such purchase price exceed the capital actually invested in such property by Lessor represented by outstanding securities or existing indebtedness plus the cost of transferring the property and liquidating the Lessor. The phrase "capital actually invested" as used herein shall be construed to include, but not by way of limitation, the following amounts expended by the Lessor: organization and incorporation expenses, financing costs, carry charges, legal fees, architects' fees and reasonable costs and expenses incidental thereto.

Upon request of the Lessee made not less than sixty (60) days prior thereto, the Lessor agrees to furnish an itemized statement setting forth the amount required to be paid by the Lessee on the next rental payment date in order to purchase the Leased Premises in accordance with the preceding paragraph. Upon the exercise of the option to purchase granted herein, Lessor will

upon payment of the option price deliver, or cause to be delivered, to the Lessee documents conveying to the Lessee all of the Lessor's title to the property being purchased, as such property then exists, subject to the following: (i) those liens and encumbrances (if any) to which title to said property was subject when conveyed to Lessor; (ii) those liens and encumbrances created by the Lessee or to the creation or suffering of which the Lessee consented, and liens for taxes or special assessments not then delinquent; and (iii) those liens and encumbrances on its part contained in this Lease.

In the event of purchase of the Leased Premises by the Lessee or conveyance of the same to the Lessee, the Lessee shall procure and pay for all surveys, title searches, abstracts, title policies and legal services that may be required, and shall furnish at the Lessee's expense all documentary stamps or tax payments required for the transfer of title.

Nothing contained herein shall be construed to provide that Lessee shall be under any obligation to purchase the Leased Premises, or under any obligation in respect to the creditors, members, or security holders of the Lessor.

10. Transfer to Lessee. In the event the Lessee has not exercised its option to renew in accordance with the provisions of Section 9 hereof, and has not exercised its option to purchase the Leased Premises in accordance with the provisions of Section 10 hereof, and upon the full discharge and performance by the Lessee of its obligations under this Lease, the Leased Premises shall thereupon become the absolute property of the Lessee and upon the Lessee's request, Lessor shall execute proper instruments conveying to the Lessee all of Lessor's title thereto.

11. Defaults. If the Lessee shall default (a) in the payment of any rentals or other sums payable to the Lessor hereunder, or in the payment of any other sum herein required to be paid for the Lessor; or (b) in the observance of any other covenant, agreement or condition hereof, and such default shall continue for sixty (60) days after written notice to correct the same; then, in any or either of such events, the Lessor may proceed to protect and enforce its rights by suit or suits in equity or at law in any court of competent jurisdiction, whether for specific performance of any covenant or agreement contained herein, or for the enforcement of any other appropriate legal or equitable remedy; or the Lessor, at its option, without further notice, may terminate the estate and interest of the Lessee hereunder, and it shall be lawful for the Lessor forthwith to resume possession of the Leased Premises and the Lessee covenants to surrender the same forthwith upon demand.

The exercise by the Lessor of the above right to terminate this Lease shall not release the Lessee from the performance of any obligation hereof maturing prior to the Lessor's actual entry into possession. No waiver by the Lessor of any right to terminate this Lease upon any default shall operate to waive such right upon the same or other default subsequently occurring.

12. Notices. Whenever either party shall be required to give notice to the other under this Lease, it shall be sufficient service of such notice to deposit the same in the United States mail, in an envelope duly stamped, registered and addressed to the other party or parties at the following addresses: (a) to Lessor: Montgomery County Building Corporation, Attention: President, 100 East Main Street, Crawfordsville, Indiana 47933; (b) to Lessee: Montgomery County, Indiana, Attention: Auditor, 100 East Main Street, Crawfordsville, Indiana 47933; (c) to

Trustee: at the address shown on the Addendum referred to in the first paragraph of Section 2 hereof.

Lessor and Lessee may by notice given hereunder, designate any further or different addresses to which subsequent notices, certificates, requests or other communications shall be sent.

13. Successors or Assigns. All covenants of this Lease, whether by Lessor or Lessee, shall be binding upon the successors and assigns of the respective parties hereto.

14. Construction of Covenants. Lessor was organized for the purpose of constructing, renovating and erecting governmental buildings and leasing the same to Lessee under the provisions of Indiana Code, Title 36, Article 1, Chapter 10. All provisions herein contained shall be construed in accordance with the provisions of said statutes, and to the extent of inconsistencies, if any, between the covenants and agreements in this Lease and the provisions of said statutes, said statutes shall be deemed to be controlling and binding upon Lessor and Lessee.

Montgomery County Board of Commissioners

Ordinance 2021 – 30

Adopting a Supplemental Workplace Injury Leave

Whereas, Chapter 36 of the Montgomery County Code Book details the policies of the County; and

Whereas, Chapter 4 of the Montgomery County Employee Handbook details the employment policies of the County; and

Whereas, employees who are either injured during the course of their employment or become ill because of a workplace condition may receive workers compensation benefits which are less than their full compensation from the County government; and

Whereas, the Montgomery County Board of Commissioners desires to provide for employees who are injured or who become ill because of a work condition with a supplemental benefit which will allow such employees to receive their full compensation; and

Whereas, Montgomery County Board of Commissioners finds that it is in the best interest of the County, and its employees, to adopt a supplemental injury leave policy.

Therefore, it is ordained that a new section, § 36.37, shall be added to the Montgomery County Code Book this new section will read as follows:

“§ 36.37 Supplemental Workplace Injury or Occupational Disease Leave

(A) **Leave:** If an employee is unable to work because either (1) the employee was injured by accident arising out of and in the course of the employee’s employment or (2) the employee suffers from a disease or illness that arises out of and in the course of employment, the employee is eligible for supplemental workplace injury or occupational disease leave, unless one or more exceptions apply.

(B) **Compensation While on Leave:** This leave is paid leave for up to fifty-two (52) weeks and is equal to the difference between the employee’s maximum average weekly wage and the amount of benefits, if any, received by the employee under the Indiana Worker’s Compensation Act or the Indiana Occupational Disease Act. For purposes of this section, the term “maximum average weekly wage” means the earnings of the employee for the period of time 52 weeks immediately prior to the injury divided by 52. If the employee has not been employed 52 weeks, the maximum average weekly wage is the earnings of the employee for the period of time which the employee has been employed divided by the number of weeks of employment with the County.

(C) **Ineligibility.** An employee is not eligible for this leave if the injury or disease is the result of a self-inflicted injury or disease, intoxication, commission of an offense, knowing failure to use a safety device, knowing failure to obey a reasonable written rule of the employer that has been disseminated or posted in the place of work, or knowing failure to perform any statutory duty.

(D) **Applying for Leave.** In order to apply for this leave, the employee must:

1. promptly report to the employer the injury or disease and apply for the leave in writing, using the form prescribed; and
2. submit to employer-provided treatment and/or examination.

(E) **Determination of Leave Benefit.** When an employee applies for this leave, the Department Head will make a determination of eligibility and notify the employee of this determination in writing within seven (7) days. If the employee is eligible, the Department Head will also notify the employee of the amount of the benefit, complete the timesheet for the

employee indicating the award of supplemental leave, and process all information and deliver the same to the Auditor for payroll purposes.

(F) Right to Appeal. If an employee disagrees with a determination by the Department Head, the employee may appeal that determination to the Board of County Commissioners. All appeals must be in writing and delivered to the County Administrator within ten (10) days of the employee's receipt of notice of the determination. Upon receipt of the appeal, the County Administrator will notify the Board of County Commissioners and schedule a hearing on the appeal. The County Administrator will provide to the employee notice of the hearing at least 10 days prior to the hearing.

(G) Appeal Hearing. At any appeal hearing, both the employee and the Department Head will be allowed to present evidence to the Board. The employee has the right to call witnesses to testify in support of the appeal, the right to confront and cross examine witnesses, and the right to be represented by an attorney.

(H) Appeal Determination. After hearing the evidence, the Board will make a written determination either that (1) the appeal is granted and the leave awarded or (2) the appeal is denied. This determination must be made within ten (10) days of the hearing. The decision of the Board is final.

(I) Obligations of Employee While on Leave. While on this leave, the employee has an obligation to

1. provide to the Department Head information regarding the employee's condition, progress, diagnosis, treatment and return to work;
2. consent to and execute forms necessary to allow the employer to obtain medical information from the employee's medical care provider;
3. accept suitable employment requested by the employer;
4. return to work when released to do so by the employee's medical provider;
5. comply with reasonable requests by employer for meetings, conferences and other dialogue regarding a return-to-work plan.

(J) Termination of Leave. The leave terminates when:

1. the employee has received paid supplemental leave under this section for a period of 52 weeks;

2. the employee has refused to consent to the release of medical information to the employer;

3. the employee has refused to cooperate with the employer to develop a return-to-work plan;

4. the employee has failed to meet his or her obligations under this policy;

5. the employee is able to return to work but refuses to do so;

6. the employee is unable to return to work for reasons unrelated to the employee's workplace injury or illness; or

7. the employee has died.

(K) Not Concurrent Leave. When an employee is awarded this leave, the leave does not count as sick leave, paid-time-off, or any other leave. This leave does not count for purposes of determining an entitlement for overtime or compensatory time off."

It is further ordained that a new section, § 6.12, of the Montgomery County Employee Handbook shall be added and this new section shall read in accordance with § 36.37 of the Montgomery County Code Book and as detailed herein.

It is further ordained that this ordinance is effective upon adoption.

It is further ordained that any other provisions of the Montgomery County Code Book and Employee Handbook which are not specifically amended by this ordinance shall remain in full force and effect.

Ordinance 2021- 31

An Ordinance Amending the County's Right-of-Way Policies

WHEREAS, the Board of Commissioners periodically reviews County policies in order to manage risk related to providing government services, provide for ease of administration in policies, and make technical corrections; and

WHEREAS, the County Highway Director and County Engineer have recommended that the Board provide for a permit procedure and relocation procedure which govern the County's rights-of-way; and

WHEREAS, based upon these recommendations, the Board now finds that Section 90.01 of the County Code should be amended in order to provide for these regulations; and

WHEREAS, the Board finds that the proposed amendment to Section 90.01 furthers the County's interests, is in the best interests of the citizens of Montgomery County, and should be approved.

NOW, THEREFORE, IT IS ORDAINED by the Montgomery County Board of Commissioners that section 90.01 in the County Code should be amended to read as follows:

“§90.01 COUNTY ROADS AND RIGHTS-OF-WAY

~~(A) The purpose of this section is to establish procedures for obtaining permission to use any part of the right-of-way of the roads of the County for laying pipe or cable or to cross any of the roads with pipe or cable. (1982 Code §5-84-1).~~

~~(B) (1) Any person or corporation wishing to use any part of the right-of-way or cross any roads to lay pipe or cable shall obtain permission in writing from the County Highway Department using the form as set out by the County. (1982 Code §5-81-2)~~

(A) DEFINITIONS.

For the purposes of this article, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

(1) **EXCAVATION AND CONSTRUCTION.** Installation, repair, and replacement of driveways, curbs, and sidewalks; the installation, repair, and replacement of all public utilities and other utilities, and other projects involving construction activities over, upon, or beneath county roads, alleys and public ways in the unincorporated area of Montgomery County.

(2) **MINOR REPAIRS.** Work personally performed by property owners to existing sidewalks or driveways located on public streets abutting their property. Minor repairs may include crack repair, removal and replacement of existing driveways to the same line and grade, or resurfacing. Minor repairs exclude any street curb cut work.

(3) **PUBLIC ROADS.** All public roads, streets, alleys, public ways and public rights-of-way in the unincorporated area of Montgomery County, Indiana.

(4) **ROUTINE MAINTENANCE.** Periodic repair or replacement of utilities or physical components within or adjacent to the public road, Routine maintenance excludes any street curb cut work.

(5) **ROAD CURB CUT WORK.** Work done to or through the actual street surface or curb and gutter section.

(B) PERMITS.

(1) *Permit required.* All excavation, construction, and road curb cut work on public roads in the unincorporated areas of the County shall require a permit issued by the County Highway Department upon application of the property owner, licensed contractor or utility performing the work.

(2) *Procedure.* Any person required to obtain a permit must apply for such a permit at the County Highway Department and pay the applicable permit fee.

(3) *Emergencies.* In an emergency involving a risk to public health or safety, construction or excavation may be commenced without a permit provided the person or entity performing the work has made a reasonable effort to inform the County Highway Department and any utility whose facilities might be involved, and shall make written application for a permit at the beginning of the next business day.

(4) *Work commenced without a permit.* Work commenced without a permit, or adherence to this section's emergency provisions, ~~will may~~ result in the imposition of fines for each day the work is undertaken or a public road is left in disrepair as a result of work done without a permit.

(5) *Fees.* All **applicants for permits**, except those for minor repairs, routine maintenance, entities exempted by a written municipal agreement, **for residential driveways**, and initial installation of public improvements within new subdivisions, shall pay a permit fee. **The fees are:**

(a) **for a non-residential driveway cut on a paved road is \$100, and the permit holder must provide a performance bond, in a form acceptable to Montgomery County in the amount of \$2,500;**

(b) **for the placement, relocation or removal of utility poles and overhead lines is \$100 per 1,000 lineal feet, and the permit holder must provide a performance bond, in a form acceptable to Montgomery County, in the amount of \$5,000;**

(c) **for subdivision entrance permits:**

(i) **for 20 or fewer lots, the fee is \$100;**

(ii) **for 21 to 40 lots, the fee is \$200;**

(iii) **for 41 or more lots, the fee is \$300.**

Fees must be submitted with the application for the permit.

~~. as authorized by the Board of Commissioners by ordinance. A base permit fee shall be required for any excavation or construction necessary for a single connection, a single driveway and adjoining sidewalk, or a cut for installing facilities, not exceeding 100 linear feet on public streets. The permit fees for excavation and construction of projects exceeding 100 linear feet will consist of the base permit fee plus an additional fee for each linear foot of excavation and construction in excess of 100 linear feet.~~

(6) *Duration of the permits.* All permits shall expire within 1 year of the date of issuance. Once work is commenced, it must be completed within 30 days. If a longer period of time is needed, the permit holder may request that the Highway Director extend the work period for up to an additional 30 days. ~~30 days of the commencement of the work authorized by the permit, unless a longer period of time, not exceeding 60 days, has been requested at the time of the~~

permit issuance. The County highway Director may extend a permit beyond its original term for up to 60 days, if applicant can demonstrate the need for additional time to complete the work.

(C) OTHER REQUIREMENTS.

(1) *Bond requirement.* A bond will be provided to the County to assure the proper repair of the public road before commencement of the work or immediately thereafter in the case of an emergency. The amount of the bond will be determined by the County Highway Director based upon the work to be performed and the cost of remediation if the applicant fails to perform.

(2) *Public safety precautions.* “Road Closed” and/or “Work Ahead” signs must properly mark the work site. Barricades and flaggers (if necessary) must separate exposed work from vehicle and pedestrian traffic. No trenches are to be left open overnight. **All traffic control measures must comply with the *Manual on Uniform Traffic Control Devices for Streets and Highways*, published by the U.S. Department of Transportation.**

(3) *Responsibility for maintenance.* It shall be the responsibility of the person or entity issued a permit to make sure that the public roads in or on which they perform work are properly repaired at the completion of the work and that particular places where the work was done are kept in good condition for a period of three years after the completion of the work. If the permit holder fails to perform proper repairs or maintenance for the three-year period, the County may perform any repair or maintenance work and bill the permit holder.

(4) *Additional rules and regulations.* The County Highway Department may adopt excavation specifications standards and rules for the making of cuts, for related matters involving excavations and restoration of pavements or surfacing.

(5) *Flowable Fill.* Flowable fill is required for excavation at depths of six feet or more.

(D) Relocation of public utilities.

1. *Purpose.* The County is authorized by Indiana law to manage and regulate the rights-of-way of its public roads. The purpose of this section is to establish a procedure for road improvement projects that involve the relocation of utility facilities by providing for the exchange of information and the implementation of their respective responsibilities among the County, utilities, and the contractors.

2. *Applicability.*

- a. This section applies to improvement projects by Montgomery County for which is paid solely from local funds.
- b. This section does apply to public highways improvements projects conducted by the Indiana Department of Transportation (“INDOT”) or its designee or for improvement projects for which Montgomery County received federal funding. In these events, the INDOT regulations in 105 IAC 13 shall be used

between the parties.

3. *Definitions.*

- a. "Compensable work" means facility relocation for which Montgomery County will reimburse the utility under Indiana law.
- b. "Contractor" means the person or entity that enters into a contract with Montgomery County for an improvement project.
- c. "Day" means any calendar day of the year. If more than one (1) day, the term includes any consecutive day or days of any year or years.
- d. "Facility" shall include all privately, municipally, publicly, or cooperatively owned systems for supplying communications, power, light, heat, electricity, gas, water, pipeline, sewer, sewage disposal, drain or the like service, directly or indirectly, to the public. The term includes, but is not limited to, cable television systems.
- e. "Facility relocation" means any activity involving a facility that is needed for an improvement project including, but not limited to, abandoning, altering, deactivating, installing, maintaining, modifying, moving, removing and/or supporting.
- f. "Highway" means any roadway under the jurisdiction of Montgomery County or where an improvement project is planned.
- g. "Improvement project" means the construction, reconstruction, rehabilitation, and process incidental to building, fabricating, or bettering any of the following:
 - (i) Projects within the unincorporated areas of Montgomery County that the County is required by statute to build and maintain.
 - (ii) A local project administered by Montgomery County including but not limited to road projects and road-related projects.The term does not include routine maintenance.
- h. "Major project" means an improvement project that due to scope or complexity, involves a long-term design process of more than twelve (12) months or is otherwise designated by Montgomery County as a major project.
- i. "Minor project" means an improvement project that due to scope or complexity, involves a short-term design process of less than twelve (12) months or is otherwise designated by Montgomery County as a minor project.
- j. "Project plan" means the plans for the improvement project suitable for the design of facility relocation that Montgomery County sends to the utility.

k. "Utility" means the owner of a facility.

l. "Work plan" means a plan of the utility to carry out facility relocation to accommodate an improvement project.

4. Identification and Notification.

a. Montgomery County shall send by U.S. certified mail to the identified utility an initial notice of the proposed improvement project. A notice shall include the following:

- i.* The name or route number, or both, of the highway.
- ii.* The geographical limits of the improvement project.
- iii.* A general description of the work to be done.
- iv.* The anticipated date an approved work plan will be needed.
- v.* The anticipated ready for contract date of the improvement project.
- vi.* The name of the designer and other contact information, if available.
- vii.* Montgomery County's determination of whether the project is major or minor.

Montgomery County shall inform the utility of the latest anticipated dates with each notice.

b. Within thirty (30) days after receiving the initial notice, the utility shall respond in writing to Montgomery County with a:

- i.* description of the type and location of its facilities within the geographical limits of the proposed improvement project; or
- ii.* statement that the utility has no facilities within the geographical limits of the improvement project.
- iii.* Montgomery County will list the utilities and identify the locations of all facilities identified on one (1) or more plan sheets

5. Verification of Existing Facilities.

a. Montgomery County shall send by certified mail to each utility a copy of the plan sheets that shows all existing facilities known to Montgomery County that are within the right-of-way of the improvement project or the geographical limits of the improvement project.

b. Each utility shall do the following within thirty (30) days of receiving the plan sheets:

- i.* Review the accuracy of the plan as to the location of its existing facilities.
- ii.* Declare in writing to Montgomery County whether the information is accurate or inaccurate.
- iii.* Detail in writing to Montgomery County any inaccuracies in the information.

Failure to reply within the allotted time shall be deemed verification that the information is accurate.

6. Work Plan Development.

a. In conjunction with the mailing the plans sheet(s), Montgomery County will send by mail preliminary project plans to the involved utilities. After receiving the preliminary project plans, each utility shall do the following:

- i. Review the preliminary project plans.
- ii. Declare in writing to Montgomery County whether there are or are not conflicts between its facilities and the improvement project.
- iii. Detail in writing to Montgomery County any conflicts between its facilities and the proposed improvement project within:
 - (A) thirty (30) days for minor projects; or
 - (B) sixty (60) days for major projects.

b. Failure to reply within the allotted time shall be deemed an indication of no conflicts. In the event of conflicts, the utility may recommend design changes for the improvement project to minimize utility costs or delays. Montgomery County will review the recommended changes and implement the changes where appropriate.

c. After completion of the preliminary project plan development, Montgomery County will proceed with the development of final project plans for the improvement project. The County shall send by mail to the utility a copy of the preliminary final project plans for the improvement project, generally before those plans are complete, but which shall have sufficient detail to allow the preparation of the utility work plan. The utility shall use the preliminary final project plans to develop and provide to the County its work plan. A work plan shall be submitted:

- i. whether or not any facility relocations are required; and
- ii. within:
 - (A) sixty (60) days after receiving the preliminary final project plans for a minor project; and
 - (B) one hundred twenty (120) days after receiving the preliminary final project plans for a major project.

If a utility or the County determines there is a potential for conflict between work plans, the County will schedule a meeting. The County and the affected utilities will attend to coordinate the work. An additional thirty (30) days will be allowed to furnish the work plan if coordination is required with another utility or utilities. Additional time may be allowed by the department for unusually complex or extensive facility relocations, but not more than one hundred eighty (180) days.

d. The work plan shall include the following:

- i. A narrative description of the facility relocation that will be required.
- ii. A statement whether the facility relocation is or is not dependent on work:
 - (A) to be done by:
 - (1) another utility; or
 - (2) the County or contractor; or

- (B) on the acquisition of additional right-of-way; with a description of that work.
- iii. A statement whether the utility is or is not willing to allow the contractor to do the required work as part of the highway contract.
- iv. The:
 1. earliest date when the utility could begin to implement the work plan; and
 2. number of days to complete the required work.
- v. The expected lead time in days to:
 1. obtain any required permits;
 2. obtain materials;
 3. schedule work crews; and
 4. obtain the necessary additional right-of-way.
- vi. A drawing of sufficient detail and scale to show the proposed location of the facility relocation.
- e. For work that the utility believes it is entitled to be compensated by the County, the work plan shall also include a cost estimate for the facility relocation including appropriate credits for betterments and documentation of easements and compensable land rights.
- f. Montgomery County shall review the work plan to ensure that it:
 - i. is compatible with:
 1. County permit requirements;
 2. the project plans;
 3. the construction schedule; and
 4. other utility relocation work plans; and
 - ii. has a reasonable:
 1. relocation scheme; and
 2. cost for compensable work.
- g. If the work plan submitted by the utility is not compatible or reasonable, the County shall notify the utility by mail as soon as practicable. The utility shall submit a revised work plan within thirty (30) days of receipt of the notification by the County. The County shall review the revised work plan, and, if the work plan is still not compatible or reasonable, the County will prepare an alternative work plan for submission to the utility. Within thirty (30) days of receipt by the utility of the alternative work plan, the utility may accept the alternative work plan or request, in writing, specific changes. The County shall review any requested changes to the alternative work plan. The County shall adopt a final work plan that considers the interests of the utility, contractor, and public, to ensure safety and reliability of the utility facilities and the highway and avoid the imposition of unnecessary and unreasonable costs. The final work plan adopted by the County will be the approved work plan; and
- h. A highway utility agreement, if required, shall be executed at this time.
- i. The County shall notify the utility by mail as soon as practicable when the final work plan is approved.

(2) Construction.

- a. Montgomery County shall notify the utility by mail not less than thirty (30) days before the utility is required to begin the implementation of the approved work plan. The utility shall acknowledge the notification by mail within fifteen (15) days.
- b. Montgomery County will include or reference a copy of each approved work plan in the highway contract.
- c. If an approved work plan is dependent on work by the contractor, the contractor shall do the following:
 - i. Provide Montgomery County and the utility a good faith notice not less than fifteen (15) days before the contractor's work is expected to be complete and ready for the utility to implement its work plan.
 - ii. Follow up with a confirmation notice to the County and the utility not less than five (5) days before the contractor's work will be complete so that the utility may implement the work plan.
- d. The utility shall notify Montgomery County and contractor, if identified, as follows:
 - i. At least five (5) days before beginning fieldwork within the right-of-way.
 - ii. When the work is complete.

(3) Work Revision Plans.

- a. If, before the letting date of the improvement project, the project plan is revised so that additional facility relocation work is found necessary,
 - i. Montgomery County shall:
 1. furnish to the utility the revised project plan; and
 2. identify to the utility the revisions within the project plan; and
 - ii. The utility shall provide to Montgomery County a revised work plan, except that the time allowed for the utility to submit the revised work plan after receiving the revised project plan shall not exceed sixty (60) days.
- b. If, after the letting date of the improvement project, additional facility relocation is found necessary, Montgomery County shall notify the utility to prepare an expedited work plan as soon as practicable for submission to the County.

(4) Responsibilities.

- a. The utility, contractor, and Montgomery County shall perform the duties imposed by the approved work plan and contract within the time frames specified.
- b. Factors that shall excuse a utility from meeting the schedule in its approved work plan include the following:
 - i. The facility relocation was impacted by any of the following:
 1. Significantly differing site conditions.
 2. Unexpected impacts of other utilities.

- 3. Other unforeseen circumstances that could not have been reasonably anticipated through due diligence.
- 4. A force majeure event.
- ii. Occurrence of severe weather or other factors beyond the control of the utility directly affecting the approved work plan.
- iii. The final project plans differ substantially from the plans provided to the utility.
- iv. If a facility is discovered during the process required by IC 8-1-26, has not been previously identified as being within the improvement project limits, and the utility can show the following:
 - 1. The facility was installed after the date the County identified the affected facilities as described above.
 - 2. A proper permit was obtained for the installation of the facility from Montgomery County.
- c. If an approved work plan requires adjustment due to the occurrence of one (1) or more factors enumerated in subsection (b), the County and the utility shall proceed as directed in section 8(b) of this rule.

E. SPECIAL REGULATIONS RELATING TO TELECOMMUNICATIONS PROVIDERS

- 1. providers may collocate small cell facilities on existing utility poles and wireless support structures;
- 2. providers may perform routine maintenance on wireless facilities and replace wireless facilities with wireless facilities that are substantially similar to or the same size or smaller than the wireless facilities being replaced; and
- 3. providers with authority to use public rights-of-way may install, place, maintain or replace micro wireless facilities that are suspended on cables strung between existing utility poles in compliance with applicable codes.

F. PENALTY.

Any person or entity violating this article is subject to a fine in the amount of \$500 per day, plus the cost of the required permit.
(Ord. 2021- 14, passed 4-12-21).”

IT IS FURTHER ORDAINED that this amendment will take effect upon adoption.

IT IS FURTHER ORDAINED that all other provisions of the County Code which are not expressly amended by this ordinance will remain in full force and effect.
