Confirming Letter of Intent for Pyatt Homes - This letter will confirm that it is the intent of the Board of Commissioners of Montgomery County to construct an extension of Purple Heart Parkway from its current terminus at U.S. Highway 231 east to Ladoga Road. In order to facilitate the construction of the East Extension, the City of Crawfordsville and Montgomery County have worked collaboratively regarding design, construction, maintenance and cost-sharing for the extension project.

Based on the recently approved Study for the Montgomery County Courthouse Exterior Improvements, DLZ is submitting our professional design services letter agreement for your consideration and approval. The following identifies the basic scope of work, project schedule, and professional fee for the Montgomery County Courthouse Exterior Improvements.

BASIC SCOPE OF WORK

We will also compile a project manual that includes the Conditions of the Contract for Construction and Specifications and may include bidding requirements and sample forms.

The probable cost of work for the scope of work will be updated. Final add alternates will be determined for bidding purposes.

If applicable, Montgomery County will provide DLZ a site survey and the geotechnical investigation report. We will provide recommendations for the survey and geotechnical report.

Montgomery County will also provide to DLZ any required man lifts to visually observe the courthouse facades. Roof observations will be completed using drone video technology. The cost of the drone video will be a direct reimbursement in addition to the lump sum. If Montgomery County has drones available, DLZ will coordinate applicable information needed.

Due to the scope of work, submittal of the project to the Indiana Department of Homeland Security for a Construction Design Release is not likely not required. All applicable local permits will be the responsibility of the Contractor to obtain.

Although not on the National Register of Historic Places listing, the Montgomery County Courthouse is part of the Crawfordsville Commercial Historic District. As applicable, DLZ will meet with the Indiana Landmarks Western Regional Office, and local historic preservation groups, to discuss the scope of work for the exterior improvements of the courthouse.

DLZ will present the Construction Documents to the Commissioners for review and approval. Upon approval, we will commence with the Bidding phase.

Bidding

During the Bidding Phase, DLZ will assist the Owner in bidding the Project by:

- Facilitating the distribution of Bidding Documents to prospective bidders.
 - Organizing and conducting a pre-bid conference for prospective bidders.
 - We suggest the pre bid conference be recommended, but not mandatory for any contractor submitting a prime bid.
 - Preparing responses to questions from prospective bidders and providing clarifications and interpretations of the Bidding Documents to the prospective bidders in the form of addenda; and,
 - Organizing and conducting the opening of the bids, and subsequently documenting and distributing the bidding results, as directed by the Owner.

Upon acceptance and award of the project by Montgomery County, DLZ will prepare the Standard Form of Agreement Between Owner and Contractor. The Agreement will be reviewed and approved by the County Attorney and the Contractor prior to execution.

Construction Administration

DLZ will administer the Contract between the Owner and the Contractor as set forth in AIA Document A201™–2017, General Conditions of the Contract for Construction (part of the contract documents developed by DLZ). If the Owner and Contractor modify AIA Document A201–2017, those modifications shall not affect DLZ's services under this Agreement unless the Owner and the Architect amend this Agreement.

DLZ will advise and consult with the Owner during the Construction Phase Services. We will have authority to act on behalf of the Owner only to the extent provided in this Agreement. DLZ will not have control over, charge of, or responsibility for the construction means, methods, techniques, sequences, or procedures, or for safety precautions and programs in connection with the Work, nor will DLZ be responsible for the Contractor's failure to perform the Work in accordance with the requirements of the Contract Documents.

Our responsibility to provide Construction Phase Services commences with the award of the Contract for Construction and terminates on the date the Architect issues the final Certificate for Payment.

DLZ will visit the site at intervals appropriate to the stage of construction to become generally familiar with the progress and quality of the portion of the Work completed, and to determine, in general, if the Work observed is being performed in a manner indicating that the Work, when fully completed, will be in accordance with the Contract Documents. We will make monthly visits during the construction phase, and we will keep the Owner reasonably informed about the progress and quality of the portion of the Work completed, and promptly report to the Owner (1) known deviations from the Contract Documents, (2) known deviations from the most recent construction schedule submitted by the Contractor, and (3) defects and deficiencies observed in the Work.

DLZ has the authority to reject Work that does not conform to the Contract Documents. Whenever we consider it necessary or advisable, DLZ will have the authority to require inspection or testing of the Work in accordance with the provisions of the Contract Documents, whether the Work is fabricated, installed, or completed.

information and belief, the Work has progressed to the point indicated, the quality of the Work is in accordance with the Contract Documents, and that the Contractor is entitled to payment in the amount certified.

The foregoing representations are subject to (1) an evaluation of the Work for conformance with the Contract Documents upon Substantial Completion, (2) results of subsequent tests and inspections, (3) correction of minor deviations from the Contract Documents prior to completion, and (4) specific qualifications expressed by the Architect.

DLZ will review and approve, or take other appropriate action upon, the Contractor's submittals such as Shop Drawings, Product Data and Samples, but only for the limited purpose of checking for conformance with information given and the design concept expressed in the Contract Documents.

Review of such submittals is not for the purpose of determining the accuracy and completeness of other information such as dimensions, quantities, and installation or performance of equipment or systems, which are the Contractor's responsibility. Our review shall not constitute approval of safety precautions or construction means, methods, techniques, sequences, or procedures.

We will review and respond to requests for information about the Contract Documents. DLZ will set forth, in the Contract Documents, the requirements for requests for information. Requests for information by the Contractor shall include, at a minimum, a detailed written statement that indicates the specific Drawings or Specifications in need of clarification and the nature of the clarification requested.

Our response to such requests will be made in writing within any time limits agreed upon, or otherwise with reasonable promptness. If appropriate, DLZ will prepare and issue supplemental Drawings and Specifications in response to the requests for information.

We may order minor changes in the Work that are consistent with the intent of the Contract Documents and do not involve an adjustment in the Contract Sum or an extension of the Contract Time. DLZ will prepare Change Orders and Construction Change Directives for the Owner's approval and execution in accordance with the Contract Documents.

DLZ will conduct a punch of the site and building for the purpose of substantial completion of the work. At the end of the project, we will issue a final Certificate for Payment based upon a final observation indicating that, to the best of our knowledge, information, and belief, the Work complies with the requirements of the Contract Documents. When substantial completion has been achieved, we will inform the Owner about the balance of the Contract Sum remaining to be paid the Contractor, including the amount to be retained from the Contract Sum, if any, for final completion or correction of the Work.

**MEMORANDUM OF UNDERSTANDING
BETWEEN CITY OF CRAWFORDSVILLE AND MONTGOMERY COUNTY
REGARDING MAINTENANCE OF LANDFILL**

This Memorandum of Understanding seeks to memorialize the intention of the City of Crawfordsville (the City) and Montgomery County (the County) to provide for the maintenance of the closed Montgomery County and City landfill which is located on Memorial Drive.

Background

- The City and the County have closed their respective landfills north of Memorial Drive, but they each have ongoing responsibility for the maintenance of the facility under the closing order issued by the Indiana Department of Environmental Management and under Indiana and federal law;
- From time-to-time, it is necessary for the City and County to perform maintenance on the cap and other features of the closed facility in order to prevent adverse environmental impacts, and the City and County believe that certain economic efficiencies and systemic efficiencies will occur if they collaborate and cooperate with each other;
- The City and the County have collaborated in the past on these matters, and they monitor and inspect the landfill in order to be informed of the condition of and necessary maintenance needed at the facility;
- The County has engaged Butler Fairman & Seifert (BF&S) to identify necessary maintenance, and BF&S has identified cap stabilization and certain drainage work to be performed in order to maintain the integrity of the environmental protection systems. This work is referred to as The Cap Stabilization Project (hereinafter referred to as The Project);
- The City and The County agree that these maintenance measures are necessary, and each agrees to pay for Fifty Percent (50%) of the cost of the design of the work
- The City and The County agree to have the County seek bids for the work and both parties will review the bids and either party may choose to reject the bids.
- The City and County intend to use this memorandum to identify areas of agreement and matters which are in need of further discussion regarding the project.

Recitation of Preliminary Understandings

1. **Design of Project.** BF&S has designed the Project, and the County and City will each pay for Fifty Percent (50%) of the design work;
2. **Letting of Project:** The County will solicit bids for the project, both parties will review the bids and either party may determine that the bids are not acceptable. If

the bids are accepted by both parties, the County may award the project consistent with Indiana law.

3. **Construction of Project.** The County and City agree to coordinate the entire construction of the project. The City and County agree that, subject to the availability of public funds, the construction costs of this project will be divided with the City paying for fifty percent (50%) construction, project management, and other costs and with the County paying fifty percent (50%) of such costs. The agreement with the contractor that is awarded the bid for the work will be between the City, County and Contractor. The costs will be billed directly to each party by the service providers, and each party will pay their respective share directly to the provider.
4. **Nonbinding Memorandum:** The purpose of this memorandum is to assist the parties in the identification of issues, areas of agreement and disagreement, and, if the parties desire, to assist them as they work toward a possible agreement regarding the project. This Memorandum is not an agreement between the parties, is not binding upon them, and it neither creates enforceable rights for the benefit of the parties nor imposes obligations upon them. This memorandum merely recites the parties' intentions to explore the possibility of an agreement.

Ordinance Amending the Road Stop Schedule

Whereas, Schedule III of Chapter 70 of the Montgomery County Code of Ordinances (the “Code Book”) contains a list of the stop intersections in the County; and

Whereas, the Montgomery County Board of Commissioners possesses a compelling governmental interest to ensure the safety of motor vehicles in the County; and

Whereas, in the northwest section of the County, Old Oak Hill Road intersects with Oak Hill Road; and

Whereas, northbound travelers on Old Oak Hill Road must yield to traffic on Oak Hill Road; and

Whereas, to maximize the safety of vehicular traffic at this intersection, the Board of Commissioners now finds that the current yield sign on Old Oak Hill Road should be changed to a stop sign.

Therefore, it is ordained, that Schedule III, Section (C)(5), of Chapter 70 of the Code Book shall be amended to include a stop sign on Old Oak Hill Road at the intersection of Oak Hill Road, and this amended section shall read as follows:

AN ORDINANCE CREATING THE 2022-2023 DRUG FREE MONTGOMERY COUNTY COALITION GRANT FUND

Whereas, the Montgomery County Probation Department has been awarded \$15,330 in mini-grants by the Drug Free Montgomery County Coalition/Local Coordinating Council; and

Whereas, these mini-grants consist of \$3,000 for Drug Court incentives, \$1,000 for Veteran Court incentives, \$1,680 for juvenile and young adult drug screening, \$4,050 for substance abuse assessments, \$3,000 for emergency/transitional housing assistance and \$2,600 for juvenile cognitive behavioral programs; and

Whereas, the use of funds from these mini-grants may be used by the Probation Department consistent with the terms and conditions of the grant award and grant agreement; and

Whereas, the Montgomery County Board of Commissioners finds that a new fund, the 2022-2023 Drug Free Montgomery County Coalition Grant Fund, should be created in order to receive the funds and to provide a mechanism for appropriation and accounting for the funds used.

Therefore, it is ordained that a new section, Section 35.____ of the Montgomery County Code, is hereby added to the County Code and that this new section shall read as follows:

“§ 35.____ 2021-2022 DRUG FREE MONTGOMERY COUNTY COALITION GRANT FUND

(A) *Source of Funds.* The Montgomery County Board of Commissioners hereby establishes the 2022-2023 Drug Free Montgomery County Coalition Grant Fund. The fund shall consist of monies received by the Montgomery County Probation Department in mini-grants from the Drug Free Montgomery County Coalition/Local Coordinating Council.

(B) *Use of Funds.* All money in the Fund will be used by the Probation Department in a manner consistent with the terms and conditions of the mini-grant awards and grant agreements.

(C) *Non-Reverting Fund.* This is a Non-Reverting Fund.”

It is further ordained that this ordinance shall be effective upon adoption.

It is further ordained that all other provisions of the Montgomery County Code of Ordinances which are not specifically amended by this ordinance shall remain in full force and effect.
