PUBLIC HEARING RE: RZ2024-1 4850 W block of Fall Creek Road Ag to R-2 Residential Subdivision

A 6-acre parcel owned by Dwight Alex Miller for the purpose of residential development. Specifically, the petitioner requests an amendment to the zoning classification from Agriculture to R-2 for the purpose of a residential subdivision. The proposed development on the property is a subdivision for Single Family Dwellings. The existing characteristics are row crop with natural grade from North to South. The property is accessed from Fall Creek Road which is a chip seal county-maintained road in fair condition. No thoroughfare plan notes to Fall Creek road. The proposed parcel of RZ 2024-1 is five miles west of Crawfordsville using SR32 to access Fall Creek Road approximately 1.3 mile on fall Creek Road to the South. Development in the area includes parcellation for Single Family Dwellings and agricultural row crop. Adjacent property to the north is an agricultural area owned by the petitioner. West and East areas are Single Family Dwelling homesteads. South of the 6 acres is an MFG Mobile Home park.

Ordinance 24-24 Approving Rezone of 4850 W block of Fall Creek Road

Ordinance would memorialize the change of 4850 W block of Fall Creek Road to rezone it from agricultural to residential.

LOCAL DISASTER EMERGENCY DECLARATION - Effective date: October 21, 2024

As of October 21, 2024 Montgomery County is immediately threatened by a natural disasterspecifically countywide drought conditions and at risk of widespread fire hazards. A countywide burn ban affecting certain activities is an appropriate safety response to the fire hazards presented by the current drought conditions. The following activities are prohibited in Montgomery County:

- 1. Campfires and other recreational fires, unless enclosed in a fire ring with dimensions of 23 inches in diameter X 10 inches high or larger;
- 2. Open burning of any kind using conventional fuel such as wood, or other combustible matter, with the exception of grills fueled by charcoal briquettes or propane;
- 3. The burning of debris, such as timber for vegetation, including such debris that results from building construction activities and any other open-air fires, including the use of fireworks; Burning will be allowed in burn barrels with a 1/4" mesh top from dawn to dusk only. All burning must be monitored.

Declaration is in effect until October 28, 2024 unless it is continued or renewed by the Board of Commissioners.

ORDINANCES

2nd Reading Ordinance 2024-21 Amending Tax Rate for Cumulative Bridge Fund

Commissioners agree to Amend the Tax Rate for Cumulative Bridge Fund for 2024 payable 2025 budgets from \$0.075 per \$100 of assessed valuation to \$0.055 per \$100 of assessed valuation in order to relieve the County's General Fund and to provide greater flexibility to the County Council for 2025 budgets. The reduction is in accordance to the County's Financial Plan referred to as the "Peters Plan".

2nd Reading Ordinance 2024-22 Amending Speed Limit on County Road 400 North Between State Road 231 and County Road 400 West

Due to recent road improvements the County Highway Department recommends that the speed limit on County Road 400 North between State Road 231 and County Road 400 West changed to 40 miles per hour, effective immediately.

2nd Reading Ordinance 2024-23 Amending Speed Limit on County Road 150 South Between State Road 47 and County Road 200 West

The Board received a report from the County Highway Department on August 26, 2024 which recommended that the speed limit on County Road 150 South between State Road 47 and County Road 200 West be changed to 45 miles per hour, effective immediately.

Introduction Ordinance 2024-25 Amending Speed Limit on County Road 500N between the Eastern Town Limits of Darlington and State Road 47

The Board received a report from the County Highway Department on October 8, 2024 which recommended that the speed limit on County Road 500 North between the eastern town limits of Darlington and State Road 47 be changed to 30 miles per hour.

Due to recent road improvements the County Highway Department recommends that the speed limit on County Road 400 North between State Road 231 and County Road 400 West changed to 40 miles per hour, effective immediately.

1st Reading Ordinance 2024-23 Amending Speed Limit on County Road 150 South Between State Road 47 and County Road 200 West

The Board received a report from the County Highway Department on August 26, 2024 which recommended that the speed limit on County Road 150 South between State Road 47 and County Road 200 West be changed to 45 miles per hour, effective immediately.

Resolution 2024-25 Approving the Issuance of Redevelopment Commission District Revenue Bonds

The Board of Commissioners hereby approves the issuance of the Bonds for the design and construction of watermain extensions for Nucor Road. 



Introduction

At the September 25, 2024 meeting you will conduct a public hearing to consider Re- zoning a 6-acre parcel owned by Miller for the purpose of residential development. Specifically, the petitioner requests an amendment to the zoning classification from Agriculture to R-2 for the purpose of a residential subdivision. The proposed development on the property is a subdivision for Single Family Dwellings.

The existing characteristics are row crop with natural grade from North to South. The property is accessed from Fall Creek Road which is a chip seal county-maintained road in fair condition. No thoroughfare plan notes to Fall Creek road. The proposed parcel of RZ 2024-1 is five miles west of Crawfordsville using State Road 32 to access Fall Creek Road approximately 1.3 mile on fall Creek Road to the South. Development in the area includes parcellation for Single Family Dwellings and agricultural row crop. Adjacent property to the north is an agricultural area owned by the petitioner. West and East areas are Single Family Dwelling homesteads. South of the 6 acres is an MFG Mobile Home park

The proposed 6-acre development would be served by on-site septic and well.

R-2 residential subdivision is categorized in the zoning code a district designated for residential subdivisions which will not be served by municipal or regional sanitary services.

Parcel number - 54-11-16-500-007.000-018

The Comprehensive Plan of Montgomery County does not specifically address this area for development. The general characteristics of the area coincide with the proposed use of the property in the re-zone request.

Fall Creek Road (Minor Collector) in the area of entry is a straight section of County Road 19 feet in width. No traffic counts taken or delineated for this section of Fall Creek Road.

Procedural Status of Case

Notice of the public hearing was published on September 15, 2024. Notice to adjoining landowners and landowners within 660 feet of property were sent prior to September 15, 2024.

Factors to be considered

- 1. The Comprehensive Plan.
- 2. Current conditions and the character of current structures and uses in area.
- 3. The most desirable use for which the land in each area is adapted.
- 4. The conservation of property values throughout the jurisdiction.
- 5. Is the proposed development responsible development?

Staff Recommendation

Staff recommends approval of Re zone requested.

If the re-zone is approved by the county Commissioners the petitioner will begin the Subdivision process with the Plan commission.

Making a Motion and Discussion

After hearing the statement of the case provided by the petitioner, the statement of the case by staff, any statements of the public and discussing the case, the Commission can send the proposed amendment to the zoning classification to the County Commissioners with a favorable, unfavorable or no recommendation. A member of the Commission should make a motion to send to the Commissioners a recommendation and can be accompanied with conditions. Each motion requires a second. After a motion is made and seconded, the Commission may discuss the motion. Form motions are below. A minimum of 5 voting members are required to vote in favor of motion in order to take official action. After the vote, members will certify its action with signatures.

LOCAL DISASTER EMERGENCY DECLARATION

MONTGOMERY COUNTY, INDIANA

October 21, 2024

WHEREAS, Montgomery County, Indiana is immediately threatened by a natural disaster-specifically countywide drought conditions, and;

WHEREAS, as of October 21, 2024, we find Montgomery County to be at risk of widespread fire hazards because of the ongoing drought conditions and;

WHEREAS, a countywide burn ban affecting certain activities is an appropriate public safety response to the fire hazards presented by the current drought conditions;

NOW THEREFORE, the acting principal executive officer of the Montgomery County Board of Commissioners, declares, pursuant to the provisions of IC 10-14-3-29, that a state of emergency exists in the County and that it is hereby invoked and declared those portions of the Indiana Code which are applicable to the conditions and have caused the issuance of this declaration, to be in full force and effect in the County for the exercise of all necessary emergency authority for protection of the lives and property of the people of Montgomery County.

It is also declared that, effective immediately, the following activities are prohibited in Montgomery County.

- 1. Campfires and other recreational fires, unless enclosed in a fire ring with dimensions of 23 inches in diameter X 10 inches high or larger;
- 2. Open burning of any kind using conventional fuel such as wood, or other combustible matter, with the exception of grills fueled by charcoal briquettes or propane;
- 3. The burning of debris, such as timber for vegetation, including such debris that results from building construction activities and any other open-air fires, including the use of fireworks;

Burning will be allowed in burn barrels with a 1/4" mesh top from dawn to dusk only. All burning must be monitored

Reference is hereby made to all appropriate laws, statutes, ordinances, and resolutions and particularly to Section 10-14-3-29 of the Indiana Code.

All public office and employees of Montgomery County are hereby directed to exercise the utmost diligence in the discharge of duties, required of them for the duration of the emergency and in execution of emergency laws, regulations, and directives whether state or local.

All residents are called upon and directed to comply with necessary emergency measures to cooperate with public officials and Emergency Management forces in executing emergency plans and to obey and comply with the lawful directions of properly identified officers. A person who knowingly, intentionally, or recklessly violates this Order commits a Class B infraction.

This Declaration will remain in effect until October 28, 2024 unless it is continued or renewed by a majority of the Board of the Montgomery County Commissioners.

Crawfordsville Police Department

Amount Requested: \$11,500

2025 DARE and SRO training

The Crawfordsville Police Department is requesting these funds to assist with continuing the DARE and School Resource Officers education and training. They would like to add to their current DARE staff by having four officers teaching DARE in the schools. The requested funds would pay for the certification, hotel stay, and meals of two officers to go through the 2025 DARE certification training. Additionally, the funds being requested would also be used to allow one SRO to attend the Advanced SRO course to expand the officer's skillset and knowledge. These funds would also allow SROs to attend the Indiana SRO conference and the National SRO conference to continue the SROs education. These funds would pay for the registration, hotel, and meals. In addition, funds being requested would be used to purchase DARE supplies such as handouts, t-shirts, name cards, or pencils.

United Way in Montgomery County

Amount Requested: \$45,000

Amount Approved: \$43,237.47

First Door

First Door is a coordinated effort to assist and connect individuals and families to resources in the community. This initiative uses the nine areas of the Wellness Wheel to bring organizations, leaders, and volunteers from each area to one place at one time. This ensures that those who are looking for resources have immediate, face-to-face interaction with a knowledgeable individual who can assist in the navigation and access to resources. The intention of this initiative is connection, not just a phone number or recommendation. The funds being requested would be used to fund a Community Impact Associate (Navigator) to oversee the development/expansion of the program, ongoing operations, and follow-up strategies with those served. This position would also oversee a community resource website and resource guide to replace the current MontCares website.

Harm Reduction

Montgomery County Probation Department

Amount Requested: \$1,550

Amount Approved: \$1,550

Hygiene Bags

The Montgomery County Probation Department puts together hygiene bags for both men and women who are recently released from incarceration, homeless, or have financial need of hygiene products. They create separate bags for both men and women that include necessary hygiene products such as shampoo/conditioner, soap, razors, shaving cream, deodorant, toothbrush/toothpaste, hairbrush/comb, toilet paper, feminine pads and a pair of socks. They also add a heath education piece by including a waterproof hanging tag that explains how to give a breast and testicular cancer self-exam. These funds will help support that project.

Intervention/Treatment/Recovery

Through the Gate

Amount Requested: \$20,000

Amount Approved: \$15,000

Post-Graduate Job Development Manager

These funds will help pay for the post-graduate job development manager at the restaurant that Through the Gate has opened in Montgomery County and it will employ graduates from Through the Gate. Helping Through the Gate graduates succeed is the goal. By expanding the post-graduation capacity of care, they believe they can increase TTG's 78% success rate and produce better equipped employees that will eventually get other jobs in the community. The Job Development Manager will not only oversee the day-to day operations for the restaurant, but they will also continue to teach job development skills, which is part of the clients program as a resident at TTG.

Valley Oaks Health, Inc.

Amount Requested: \$22,290

Amount Approved: \$20,000

Expanding peer recovery for uninsured/underinsured VOH patients

Valley Oaks Health is applying to receive funding to continue their current Opioid-Grant Project to provide peer recovery services under one roof to those who cannot otherwise afford such services. Additionally, they would like to expand on this project to include limited case management services, on an as-needed basis (i.e., not to exceed 5 hours per month per patient). The population would be those

lacking insurance which covers peer services/case management, having insurance with a high deductible or having no insurance. This will help have peer services, and therapy services all under one roof so that the client is getting the best care they can. This will ensure the treatment team is all under one roof and can communicate more efficiently and effectively.

Integrative Wellness, LLC

Amount Requested: \$889.00

Amount Approved: \$889.00

Enhancing Medication-Assisted Treatment Access

Currently, Integrative Wellness (InWell) is only able to offer buprenorphine injections through the Lebanon Location due to restrictions of the provider's DEA license. They started their clinic by offering Buprenorphine (Subutex), buprenorphine/naloxone (Suboxone, and Naltrexone tablets and injections (Revia & Vivitrol). In recent years, buprenorphine long-acting injections have become available. InWell has found that these long-acting injections are successful for individuals who struggle to take medications as prescribed, have risks of diverting medications, or are looking to taper of medications completely. InWell is requesting funds to cover the cost of adding the Crawfordsville Location to the current provider's DEA license to be able to offer further Medically Assisted Treatment. Adding the Crawfordsville Location to the license would ensure that Crawfordsville patients would not need to drive to Lebanon.

Integrative Wellness, LLC

Amount Requested: \$18,000

Amount Approved: \$18,000

Free Support Services - Regional Hub Supplement

Integrative Wellness (InWell) became a Regional Recovery Hub several years ago which allows them to offer free peer support. Specifically, this means individuals needing services with InWell do not have any barriers or delays in starting their peer recovery support services. Individuals can check in with their peer as often or as little as they would like without restriction. Unfortunately, the State has changed the structure of the Recovery Hub and will require, after December 2024, that agencies must be a Certified Recovery Community Organization. This change would restrict InWell from offering Hub services. InWell is requesting funds to be able to provide one session a week for a year for up to 15 clients so that the program is not disrupted. The requested funding would cover a peer's salary at \$25 an hour for up to 15 clients up to four times a month for one year.

Cummins Behavioral Health Systems, Inc.

Amount Requested: \$25,000

Amount Approved: \$20,000

Opioid/Substance Use Disorder Treatment Support

Cummins Behavioral Health Systems is applying for funds to help pay for services to those who have difficulty paying for treatment. It may be that they have no funding source to pay for treatment, or they may have private insurance that will not cover treatment or if they do then it has a very high deductible. This funding will allow them to give out vouchers and scholarships for treatment and they will value this up to \$1,000 per consumer. The review team has agreed to fund this project at \$20,000.

Recovery Coalition, Inc.

Amount Requested: \$21,216

Amount Approved: \$21,216

2025 Peer Recovery Coaches

The Recovery Coalition is requesting these funds for the Recovery Rec Center to continue to employ peer recovery coaches for 2025. This will allow peers to guide, mentor, and support anyone who would like to enter into or sustain long-term recovery. The recovery coaches will meet weekly with clients. They will continue this position after the twelve months and use funds from their Recovery Community Organization to pay for it. This is an ongoing project.

Whereas, on the 26th day of February, 2024, the Montgomery County Board of Commissioners adopted Ordinance 2024-5 which re-established the Cumulative Bridge Fund ("Cum Bridge Fund"), as provided for in Indiana Code \$8-16-3, and imposed a tax levy on all real and personal property in Montgomery County, under Indiana Code \$6-1.1-41, to provide money for the construction, repair, maintenance, and inspection of bridges in Montgomery County; and

Whereas, the Ordinance also established a tax rate for 2025 for the Cumulative Bridge Fund at \$0.075 per \$100 of assessed valuation, and the maximum property tax rate for the Fund per Indiana Code \$8-16-3 is \$0.075 per \$100 of assessed valuation; and

Whereas, in order to relieve the General Fund and to provide greater flexibility to the County Council for 2025 budgets, the Commissioners agree to lower the tax rate for the Cumulative Bridge Fund for 2024 payable 2025, from \$0.075 per \$100 of assessed valuation to \$0.055 per \$100 of assessed valuation;

It is therefore ordained that the Montgomery County Board of Commissioners that Section 2 of Ordinance 2024-5 is hereby amended to read as follows:

<u>"Section 2</u>. <u>Tax Rate</u>. The County Board of Commissioners now levies a tax on all real and personal property in Montgomery County to provide funds to the Cumulative Bridge Fund. The property tax will not exceed \$0.055 on each \$100 of assessed valuation. This tax rate will be levied beginning with taxes for 2024, due and payable in 2025."

WHEREAS, the <u>County Commissioners</u> of Montgomery County (hereinafter referred to as the "Participating Employer") has determined that in the interest of attracting and retaining qualified employees, it wishes to offer a defined contribution plan, funded by employer contributions:

WHEREAS, the Participating Employer has reviewed the State of Indiana Deferred Compensation Matching Plan ("Plan");

WHEREAS, the Participating Employer wishes to participate in the Plan to provide certain benefits to its employees, reduce overall administrative costs, and afford attractive investment opportunities;

WHEREAS, the Participating Employer is an Employer as defined in the Plan;

WHEREAS, the <u>County Commissioners</u> ("Governing Body") are authorized by law, IC 5-10-1.1-7.3, to adopt this resolution approving the Adoption Agreement on behalf of the Participating Employer;

Therefore, the Governing Body of the Participating Employer hereby resolves:

<u>Section 1.</u> The Participating Employer adopts the Plan and the Trust Agreement ("Trust") for the Plan for its Employees.

<u>Section 2.</u> The Participating Employer acknowledges that the Deferred Compensation Committee ("Trustees") are only responsible for the Plan and have no responsibility for other employee benefit plans maintained by the Participating Employer.

Section 3. The Participating Employer hereby adopts the terms of the Adoption Agreement, which is attached hereto and made a part of this resolution. The Adoption Agreement sets forth the Employees to be covered by the Plan, the benefits to be provided by the Participating Employer under the Plan, and any conditions imposed by the Participating Employer with respect to, but not inconsistent with, the Plan. The Participating Employer reserves the right to amend its elections under the Adoption Agreement, so long as the amendment is not inconsistent with the Plan or the Internal Revenue Code or other applicable law and is approved by the Trustees of the Plan.

Section 4. The Participating Employer hereby authorizes the State Comptroller of Indiana ("Administrator"), in conjunction with the Deferred Compensation Committee ("Trustees"), to amend the Plan on its behalf as provided under Section 18.01 of the Plan.

The Trustees and the Administrator will maintain or have maintained on their behalf a record of the Participating Employers, and the Trustees and the Administrator will make reasonable and diligent efforts to ensure that Participating Employers have actually received and are aware of all Plan amendments.

Section 5.

- (a) The Participating Employer shall abide by the terms of the Plan and the Trust, including amendments to the Plan and the Trust made by the Trustees of the Plan, all investment, administrative, and other service agreements of the Plan and the Trust, and all applicable provisions of the Internal Revenue Code and other applicable law.
- (b) The Participating Employer accepts the administrative services to be provided by the Administrator of the Plan and any services provided by a Service Manager (as defined in the Plan) as delegated by the Administrator or Trustees. The Participating Employer acknowledges that fees will be imposed with respect to the services provided and that such fees will be charged to the Participants' Accounts, and not to the Participating Employer.

Section 6.

- (a) The Participating Employer may terminate its participation in the Plan, including but not limited to, its contribution requirements, if it takes the following actions:
 - (i) A resolution must be adopted terminating its participation in the Plan.
 - (ii) The resolution must specify when the participation will end.

The Trustees shall determine whether the resolution complies with the Plan, and all applicable federal and state laws, shall determine an appropriate effective date, and shall provide appropriate forms to terminate ongoing participation. However, distributions under the Plan of existing accounts to Participants will be made in accordance with the Plan.

- (b) The Participating Employer acknowledges that the Plan contains provisions for involuntary Plan termination.
- Section 7. The Participating Employer acknowledges that all assets held in connection with the Plan, including all contributions to the Plan, all property and rights acquired or purchased with such amounts and all income attributable to such amounts, property or rights shall be held in trust for the exclusive benefit of Participants and their Beneficiaries under the Plan. No part of the assets and income of the Plan shall be used for, or diverted to, purposes other than for the exclusive benefit of Participants and their Beneficiaries and for defraying reasonable expenses of the Plan. All amounts of compensation deferred pursuant to the Plan, all property and rights acquired or purchased with such amounts and all income attributable to such amounts, property or rights held as part of the Plan, shall be transferred to the Trustees to be held, managed, invested and distributed as part of the Trust Fund in accordance with the provisions of the Plan. All contributions to the Plan must be transferred by the Participating Employer to the Trust Fund. All benefits under the Plan shall be distributed solely from the Trust Fund pursuant to the Plan. Only the assets attributable to a particular Participating Employer and its Employees are available to pay benefits to those Employees and their Beneficiaries.
- Section 8. This resolution and the Adoption Agreement shall be submitted to the Trustees for their approval. The Trustees shall determine whether the resolution complies with the Plan, and, if it does, shall provide appropriate forms to the Participating Employer to

implement participation in the Plan. The Trustees may refuse to approve an Adoption Agreement by an Employer that does not have state statutory authority to participate in the Plan. The Trustees may also refuse to approve an Adoption Agreement that is ambiguous or that does not comply with the requirements of the Plan.
