#### Assessor's Office

- The Assessor's Office continues to assess all properties in the County in a fair and equitable manner. We obtain all education necessary to keep up with relevant legislation and technological changes, while providing exceptional customer service to our taxpayers.
- In 2024, the Montgomery County Assessor's Office assessed and valued 23,452 real estate parcels for a gross assessed value of \$3,902,229,300.00. This was a 17% increase in gross assessed value from the previous year.
- New legislation beginning in 2024, resulted in a 47% reduction in the number of Business Personal Property returns filed. With this reduction in filings, we would have expected to see a similar reduction in assessed value. The reduction we actually saw; however, was only 8%, with a gross assessed value of \$509,627,900.00.
- Each year the County Assessor is required to send a Notice of Assessment of Land and Structures/Improvements to each property owner. This Notice lists the prior year's assessed value and the proposed assessed value for the upcoming tax year. From this Notice, taxpayers are allowed to appeal the proposed assessed value. In 2023, the real estate market didn't see the steep increases of sales prices such as in 2021 and 2022. Corresponding with that, and through a concerted effort to educate our taxpayers, we saw a 40% reduction in the number of appeals filed.
- The County Assessor is required to reassess ¼ of all parcels annually as a part of our cyclical reassessment. Our staff visited and reassessed 3,656 residential parcels, 1,389 agricultural parcels and 742 commercial/industrial parcels.
- In addition to the above-listed tasks, our office measured and assessed all new construction in the County; processed sales disclosures, destroyed property permits, parcel splits, parcel combinations, property tax exemption applications and valued annually assessed mobile homes.

## Building, Zoning and Maintenance Department: Zoning Ordinance

- Ordinance Updates:
- Chapter 159 Zoning Code -
- Article 20 Commercial Battery Energy Systems;
- The purpose of this Section is to plan for and regulate the use, improvement, and maintenance of real property and the location, condition, and maintenance of structures and other improvements. These regulations allow commercial battery energy storage systems in certain areas, and, therefore, do not have the effect of unreasonably restricting the use of such facilities other than for preservation and protection of public health and safety. These regulations are not intended to and do not have the effect of significantly increasing the cost of system systems, decreasing the efficiency of such systems, or impeding alternative systems of comparable cost and efficiency.
- Article 21 Carbon Sequestration;
- The purpose of this section is to manage, regulate, and administer carbon sequestration based on the enabling legislation of I.C. 14-39 as amended from time to time. These regulations allow carbon sequestration projects and facilities in certain areas, and, therefore, do not have the effect of unreasonably restricting the use of such facilities other than for preservation and protection of public health and safety, and the County's natural and constructed resources. These regulations are not intended to and do not have the effect of significantly increasing the cost of the carbon sequestration projects, decreasing the efficiency of carbon sequestration, or impeding alternative projects of comparable cost and efficiency.
- The department still needs updates to the Drainage ordinance and will begin those in early 2025

## Building, Zoning and Maintenance Department: Plan Commission

#### Plan Commission:

- ▶ The Plan Commission ruled on three re-zone cases in 2024 two were moved to the Commissioners with favorable recommendations. One was sent with an unfavorable.
- One case issued a waiver of the drainage ordinance requirements. The plan commission deliberated and approved the waiver.
- ▶ Three Subdivisions of parcels requests were approved in 2024. All were one lot splits two Commercial and one residential.
- ► Three drainage plans were approved in 2024. Dehaai Holdings (Bobcat dealership) Plevna Implement, Nucors Towers and Structures.

### Building, Zoning and Maintenance Department: Board of Zoning Appeals

### Building, Zoning and Maintenance Department: Maintenance

#### Maintenance:

- In 2024 maintenance was involved in several maintenance upgrades and yearly tasks. A part time cleaner was added to the Binford St Bldg. in November replacing the contract cleaner that left employment.
- Fire suppression system panel and fixtures were maintained including fire extinguishers and drain downs at GC.
- A total of eight snowfalls were cleared off the County building parking lots and sidewalks in 2024.
- The elevators at the Binford Bldg. and Courthouse were inspected monthly for fire test and phone operation.
- Day to day operations on plumbing fixtures, HVAC filters, belts and other hardware continued in 2024.
- General cleaning materials list purchases for 2024;
- > 35 cases of toilet paper
- > 35 cases of hand towels
- ▶ 10 cases of hand soap
- 20 cases of trash bags
- ▶ 12 -- cases of air mist
- 9 cases of disinfectant spray.
- ▶ The remainder of disinfectant wipes and other cleaners were acquired through overstock
- Maintenance added 2 small snow blowers to inventory.

### Building, Zoning and Maintenance Department: Other Items

- ▶ The Carillion was programmed a total of four times in 2024 for additional music or bell rings in 2024.
- ▶ The flags at the Courthouse and GC were adjusted down several times in 2024
- Courthouse upgrade project began in early December.
- New online permit system was purchased and we are in the process of cleanup and implementation in early 2025. The system will serve all departments that wish to have the software issue their permitting requests.

#### **Central Communications Center**

The Montgomery County Central Communications Center is a Centralized PSAP (Public Safety Answering Point). The Center dispatches for 12 Law Enforcement Agencies (including the Town Marshalls), 10 Fire Agencies (including the Volunteer Agencies) 10 Fire Agencies (including the Volunteer Agencies) and approximately 16 other various agencies in the City/County.

The Center employees 16 full-time telecommunicators and 2 Administrative positions, whom are all IDACS/NCIC Certified, Emergency Medical Dispatch Certified, Fire Emergency Dispatch Certified, Law Enforcement Dispatch Certified, Telephone CPR Certified and CPR Certified through the American Red Cross. The Center currently has 3 full-time openings.

As required by Indiana State Law, all employees completed their 24 hours of Continuing Education requirements for 2024. Most of the Staff were also able to participate in the Indiana State NENA Conference in September as well. One employee went to Supervisor School in Northern Indiana to obtain her certification and 2 others went to Certified Training School near Indianapolis to obtain their certifications.

#### Central Communications Center

► The Center participated in the CTE (Career and Technical Education) Program again this past year with the local High Schools through West Central Indiana CTE. We currently have 2 students shadowing the Center two times a week. The Center also attended the annual Job Fair held at Crawfordsville High School in April for all area high schools and Western Boone.

▶ The Center took over 67,183 phone calls with approximately 14,445 of those calls being 911 calls. The Center generated over 53,000 Calls for Service in which responders/agencies were dispatched to calls. The Center handled over 2,369 text to 911 as well.

## Child Support Enforcement Program (Prosecutor's Office IV-D)

- □ In Indiana, Child Support services are provided in each county by elected Prosecutors operating in cooperative agreement with the Child Support Bureau. The Montgomery County Child Support IVD Enforcement Office works under the Elected Prosecutor of Montgomery County.
- The Federal Office of Child Support Enforcement (OCSE) is part of the U.S. Department of Health and Human Services. It helps states develop, manage, and operate their programs effectively and according to Federal law. OCSE pays the major share of state program operating costs, provides location services, policy guidance and technical help to enforcement agencies, conducts audit and educational programs, and supports research, training and shares ideas for program improvement.
- Child support services include locating parents, establishing paternity, establishing and modifying child support and medical orders, and enforcing the payment of child support through a variety of tools exclusively available through the child support enforcement program. The local child support enforcement office also takes referrals from those on various government programs and services receiving state and federal funds such as Foster Care and Temporary Assistance for Needy Families.

## Child Support Enforcement Program (Prosecutor's Office IV-D)

- The Montgomery County IVD Child Support office also prosecutes Non-Support of Dependent cases when various nonpaying non-custodial parents meet the criteria. The Montgomery County Child Support Program Prosecutor and staff have actively reviewed cases and have found more nonpaying non-custodial parties that meet Felony Non-Support criteria for 2024.
- Tools that are available to collect child support include:
- Income withholding
- Revocation of drivers, professional, recreational and occupational licenses of parents who are not current in their child support payments
- ▶ □ Seizure of assets, including financial accounts
- Liens on property
- Denial of passports
- □ Federal and state tax refund offset

### Child Support Enforcement Program (Prosecutor's Office IV-D)

- The Montgomery County IVD Child Support Enforcement office actively enforces 1,962 cases with new applicants added weekly.
- Since 2012, our office has received awards in all categories of establishment and enforcement from the State for exceeding state and federal performance averages.
- ▶ □ The local Montgomery County Child Support Enforcement Office finished 2024 with successful collections on 81.30% of cases in current support orders; 98.72% in Support Order Establishment; 124.27% in Paternity Establishment, and 83.18% of the caseload paying on arrears.
- The program also scored 100% in their annual 2024 Self-Assessment Audit. A self-assessment audit is where the State selects cases from several periods during the review period and adds the results to provide a picture of performance for the entire period. The State would draw a separate sample for each incremental review period. The incremental approach enables the State to spread its review effort over time and make use that is more efficient of available resources because the sample size could be smaller, while allowing the State to identify problem areas and take corrective action prior to the end of the review period. For those States who review their case samples incrementally, the cases selected must be Reviewed and evaluated for the actions required at the beginning of the incremental review period.
- The Montgomery County Child Support Program Prosecutor and staff have actively reviewed cases and have found more nonpaying non-custodial parties that meet Felony Non-Support criteria for 2024.
- The program has enforced, collected, and disbursed approximately \$3,003,211.00 in arrears and current support for 2023. We have not received the final numbers for 2024 to date but we imagine it will be close to the same. A majority of said money was paid to residents in Montgomery County.
- The staff in Montgomery County's IVD Child Support Enforcement office believes that child support enforcement provides hope as well as support to Montgomery County's children.

#### EMS Service: Contract with City

- EMS Calls for Service Dispatched
- In 2024, the PSAP dispatched approximately 1,239 medical calls, with the Crawfordsville Fire Department responding to 991 of them, or 80% of all calls in the County. This represents an increase of 59 emergency medical calls compared to 2023.
- Medic 54 responded to 715 (72%) emergency calls for service. Additional CFD resources responded to 276 (28%) emergency calls for service in the County. Table 2 identifies calls for service by month assigned to Medic 54 and "other" CFD resources.
